Agreed Conditions

- 1) A Personal Licence Holder on site at all times alcohol is being sold.
- 2) CCTV to meet the satisfaction of WYP. The cameras will be positioned inside & outside the premises, with a monitor on the till area. Recordings will be kept for a minimum of 30 days & made available to the authorities upon request.
- 3) From 11pm until 6am the store will be closed to the public & all sales will take place via a serving hatch.
- 4) A challenges & refusals register will be maintained at the premises.

- 5) A challenge 21 policy will be in place with corresponding posters in prominent locations around the premises.
- 6) Posters will be on display in the shop advising customers of the penalties for obtaining alcohol for children, & for children attempting to buy alcohol.
- 7) All staff will be trained within their responsibilities under the licensing act, prior to making sales of alcohol. All training will be documented & made available to the authorities upon request.

- 8) A bin will be located outside the premises.
