

I am a Police Constable currently employed by West Yorkshire Police as part of the Neighbourhood Policing Team based at Rothwell. On Friday 31st August 2012 I was working an evening shift in full uniform in company with Police Constable 2407 SMITH and Police Constable Support Officers 392 SMITH and 428 MURPHY.

At 2104hrs we were dispatched to a call at Middleton Park Circus, Middleton, Leeds where a number of youths were drinking behind the KASA Store, Middleton Park Road, Leeds. The caller reported they were drunk, rowdy, swearing and urinating in the street.

On attending there was a group of approximately 15 youths of both males and females, who were largely 14-15 years old and from the local area. The group had in their possession a box of REEF and a large bottle of Sambuca and several bottles of beer. The alcohol was removed by officers and destroyed at locus. The youths were clearly intoxicated and were asked to move away from the shops. A few of the youths were identified by officers to be:



There were a number of females present with the group. When I asked the group where the alcohol had come from I heard one of the females state "KASA, AT THE FRONT". When I asked who had made the statement, none of the females identified themselves to me.

When asked to move on from the area, the youths kept returning. was later involved in criminal damage to a motor vehicle which he stated was due to him being drunk, and a further call was received to police a few hours later regarding a flight between the same youths. Upon our return to the location the fight had finished and no-one wanted to make a complaint. A direction to leave was verbalised to all the youths on St Peters Avenue, Middleton at approx 2330hrs. Two of the females then returned to the location on the circus, and were removed to their home addresses. Both females were heavily intoxicated and 14 years of age.

Continuation Statement of Laura Dennant

After dealing with these incidents officers attended at KASA stores in order to compare the alcohol that the youths had in their possession with that sold at the premises, however the store had closed. I can state that the anti-social behaviour that was observed in Middleton on this evening was definitely influenced by all parties being in drink, with many of them under-age and therefore at risk from harm, as was demonstrated by the physical fight that later occurred. This was also the reason why the two females were removed form the location and taken to a place of safety, namely their home addresses.
