

Conclusion addendum

Having considered the position of the applicant, who has not opted to accept recommended conditions, we recommend that the Sub-Committee; if it is minded to allow the application apply the conditions we have suggested.

We have also considered the planning conditions as we understand them. It appears that the conditions we have referred to relate to only one side of the business at 20 Harrogate Road.

We therefore also suggest that the sub-committee consider applying the following licensing conditions to the premises as a whole to avoid any potential for loopholes to be exploited or for confusion.

• Patrons will not use the external seating area as a place to consume food or drink before 08:00 or after 18:00 hours each day.
