Summary of main issues

This report advises Members that a Temporary Event Notice (TEN), has been received for Back Ash Grove, 61 Victoria Road, Leeds, LS6 1AS, and the Environmental Protection Team have served an objection notice on the grounds of noise disturbance.

Members of the Licensing Sub Committee are asked to consider the Temporary Event Notice and the objection.

1.0 Purpose of this Report

- 1.1 To advise Members of a temporary event notice served under section 100 of the Licensing Act 2003 ("the Act") in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of an objection notice from Environmental Protection Team.

2.0 History of Premises

- 2.1 The Temporary Event Notice applied for, is for a street party. A Temporary Event was held on the 6th June 2014, in the same place. This was also for a street party, in aid of Make A Dream, which is a Leeds based charity that aims to make dreams come true for Yorkshire's sick and terminally ill children. The activity requested for the TEN, was the provision of regulated entertainment.
- 2.2 The TEN did not attract representations from West Yorkshire Police or Environmental Protection Team, albeit concerns were raised by local residents and ward councillors. In the absence of objections from the statutory responsible authorities, the TEN was held, but agencies did engage with the organiser in order to minimize disturbance. It is understood that the event did however result in nuisance complaints. Fuller details are provided in the objection notice received from the Environmental Protection Team at Appendix C to this report.

3.0 The Application

- 3.1 The proposed premises user is Theodore Grainzevelles.
- 3.2 The location of the premises can be seen on the map at Appendix A.
- 3.3 A copy of the Temporary Event Notice is attached at Appendix B.
- 3.4 In summary the TEN is for:

The sale of alcohol Regulated entertainment

The dates and times the event will be in force:

Saturday 6th June 2015 – 11:00 am until 21:00

The maximum capacity of the event is 499.

4.0 Other matters relevant to the application

4.1 It is brought to Members attention that the regulated entertainment and the sale of alcohol is to take place outdoors. The applicant proposes that the event will be restricted to only Back Ash Grove. No entrance into any of the adjacent houses. The event will be controlled through the use of temporary fencing which will prevent any of the attendees from being able to enter these houses. Access is only possible from the top of the street.

- 4.2 Live music is to take place from 13:00 21:00 and food and beverages served from 12:30 20:00.
- 4.3 At the time of writing this report there were no implications for equality and diversity. Any decision taken by the Licensing Sub-Committee will be in accordance with the four licensing objectives as prescribed by the Licensing Act 2003.
- 4.4 Members of the Licensing Sub Committee must make decision with a view to the prevention of crime and disorder.

5.0 Representations

- 5.1 Environmental Protection Team have received a copy of the notice. They consider that allowing the premises to be used in the manner set out in the temporary event notice will undermine the prevention of public nuisance and have issued an objection notice.
- 5.2 Copies of the objection notice will be available at the hearing for Members consideration.

6.0 Options Available to Members


- 6.1 The Licensing sub-committee must take such of the following steps as it considers necessary:
 - Issue a counter notice against the event in order to prevent the event from taking place.
 - Allow the event to take place
- 6.2 Members of the licensing sub-committee are asked to note that they may not restrict or attach conditions to the temporary event notice.





Temporary Event Notice: Charity Street party June 2015
Name of Premises: Back of Ash Grove, Headingley, LS6 1AY

We refer to your application for a Temporary Event Notice for the above-mentioned Charity Street party June 2015.

We believe that your application does not give enough information about how you intend to meet an important aim of the licence, which is to prevent public nuisance. We therefore confirm that we are submitting a formal objection to your application.

We base our objection on the following matters:

- The potential for noise disturbance associated with licensable activities from this event to cause noise disturbance to nearby residential premises.
- The potential for the alleged sources of nuisance described in items 1 above to continue beyond licensing hours into hours where such disturbance may adversely affect the use and enjoyment or further loss of home life.

We base our objection on the present Statement of Licensing Policy 2014-2018 issued by Leeds City Council as the Licensing Authority, experience of the Environmental Protection Team including that specifically associated with the area, including data relating to complaints received from members of the public.

Description of the surrounding area:

The application site / location is the lane located to the rear of No's 2 to 16 Ash Grove, Headingley, LS6 1AY with the applicants address being 61 Victoria Road, Headingley, LS6 1AS which is the gable end property at the start of the rear lane.

The area predominantly consists of residential housing, with little or no licensed premises within the immediate vicinity.

INVESTOR IN PEOPLE

Complaint and other history specific to the applicant premises:

A similar event to the one proposed took place around the same time in 2014 which did not result in any noise nuisance complaints being made direct to the Environmental Protection Team.

However, an abatement notice was served under the provisions of section 80 Environmental Protection Act 1990 upon the applicant Theodore Grainzevelles and Thomas Mitchell on 8th May 2014 as it was envisaged that a Statutory Nuisance is "likely to occur" from the playing of amplified music from this event.

In addition an officer from the Environmental Protection Team was on site towards the end of the event and had to insist that the event was ended to prevent breach of licence or the abatement notice.

The Environmental Protection Team also works in conjunction with Leeds Anti-Social Behavior Team (LASBT), who run and facilitates the council's out of hour's noise service (OOH). On the date the event took place the OOH service received and responded to noise nuisance complaints from the applicant's property, therefore indicating an after party.

Conclusions reached:

With regard to this application, the Environmental Protection Team has consulted with partner organisations (i.e. West Yorkshire Police, Leeds Anti-Social Behavior Team and Entertainment Licensing) as well as local ward councilor and local residents and it is our opinion that the event has the potential to create noise disturbance from amplified music and patrons attending the event.

In addition allowing the TEN to proceed may result in a number of revelers remaining in the area after the event. Furthermore there is the possibility of breakaway / after party's at nearby residential premises which are out of the control of the applicant and which also have the potential to create further or addition noise nuisance complaints which extend into noise sensitive hours and in which Leeds City Council may have to attend and take appropriate enforcement action.

Therefore Leeds City Council's Environmental Protection Team will be objecting to your Temporary Event Notice application.
