**NOTICE OF OBJECTION BY A RELEVANT PERSON  
TO A 'STANDARD' TEMPORARY EVENT NOTICE  
SECTION 104(2) as amended – LICENSING ACT 2003**

**PREMISES: CHURCH (formley Halo and the Joint)**

Your 'standard' temporary event notice was received by the West Yorkshire Police (WYP) at the above address on 26<sup>th</sup> September 2016. The notice relates to licensable activities at the premises on: Sunday 9<sup>th</sup> October 2016.

I Cat Sanderson, Licensing Officer for West Yorkshire Police, hereby give you notice that I intend to object to your 'standard' temporary event notice.

West Yorkshire Police are satisfied that allowing the premises to be used in accordance with the notice would undermine a licensing objective, for the following reasons:

- The premises have been running in a restaurant capacity since the closure of the nightclub in December 2014.
- The Premises Licence Holder (PLH) took over the venue in October 2013, and the premises were subject to an action plan meeting in January 2014 and monthly action plan meetings from October 2014 onwards, due to the nature and frequency of calls for service at the venue.
- During the last action plan meeting on 15<sup>th</sup> December 2014, the PLH was informed that serious consideration was being given to a premises licence review after a serious incident occurred on 9<sup>th</sup> December 2014, where a customer was pushed into the road and into the path of an

oncoming vehicle. The premises closed after the night concerned and has not reopened in a nightclub capacity since. A review was also being considered because of the number of incidents which were being reported at the premises.

It is felt that due to the above, WYP believe that in allowing an extension of hours would undermine the prevention of crime and disorder licensing objective.

West Yorkshire Police therefore ask a presiding sub-committee at a subsequent hearing, to give the premises user a counter notice in promotion of the licensing objectives, under Section 105 Licensing Act 2003.
