The Area Committee has some functions which are delegated from full Council and some Functions which are delegated from the Executive Board. Both functions are kept separately in order to make it clear where the authority has come from so that if there are decisions that the Area Committee decides not to make they know which body the decision should be referred back to.

### **Project Delivery - How the project will be delivered (inc how any partners are involved in the project, what each will contribute, project timescale etc):**

It is proposed that this project runs every weekend from December-March 2008, using two police motorcyclists backed up by two Parks and Countryside motorcyclists

### **Project Summary (including a brief description of the main activities and why this project is needed and its links to key priorities/actions particularly within the Area Committee's Area Delivery Plan):**

The main activities would be:

1. Off-road patrolling of identified hotspots across the inner areas
2. Seizure of stolen/uninsured motorbikes
3. Use of Section 59 Power Police Reform Act to seize vehicles being used in an anti-social manner provided certain conditions are met.
4. Responding to calls about nuisance motor-bikes live-time

The problem of motorbikes being driven in an anti-social way is widespread across the inner area. This is backed up by police intelligence and recent reassurance mapping exercises undertaken by the South Leeds Community Safety Partnership.

It addresses the Area Delivery Plan action SN3: Deliver Actions to tackle anti-social behaviour in priority areas.

Reduction in off-road motorbike related calls

**Project Cost (an indication of how much the project will cost, how much funding or in kind contributions is sought from what sources with an idea of when you will know the funding is confirmed. What funding is already secured. Breakdown between capital and revenue):**

Option 1:

2 x PCs for an 8 hour day: £364.48

To cover all weekends December-March 2008

$36 \times £364.48 = £13121.00$

Option 2:

2 x PCs for a 6 hour day: £273.36

To cover all weekends December-March 2008

$36 \times £273.36 = £9840.96$

**Which geographic areas will benefit (ie particular neighbourhoods, wards etc):**

All inner area wards will benefit.
