TRANSFORMING COMMUNITY SERVICES - UPDATE

SUMMARY

Transforming Community Services is a three year programme aimed at developing community provision in line with both primary and secondary care transformation. The first key milestone within the programme is for all NHS commissioning organisations to separate from their provider arms by 31st March 2011.

On 29th September 2010 NHS Leeds Board reviewed options for the future provision of those services currently provided by Leeds Community Healthcare and agreed that a Community Foundation Trust was the preferred option. This was supported by NHS Yorkshire and the Humber (Strategic Health Authority)

This paper provides a summary of progress to date in developing the preferred model for the organisation, including rationale for a change in preferred model to Community Foundation Trust, and makes recommendations as to next steps in delivering the new organisational form.

BACKGROUND

1. In January 2009 Transforming Community Services: enabling new patterns of provision set out the range of options for organisational form. During the summer of 2009 NHS Leeds consulted with Leeds Community Health staff on their preferred option¹. The outcome of staff consultation supported the developments of a Community Foundation Trust and a case for the model was presented to the Board in October 2009. NHS Leeds Board subsequently approved Community Foundation Trust as the preferred model for future provision.

In January 2010 new *Transforming Community Services*: enabling new patterns of provision guidance was issued by the Department of Health. The new guidance indicated that whilst a range of options were still available it was highly unlikely that NHS Leeds would be supported in taking forward its preferred Community Foundation Trust model. As a result Leeds Community Healthcare, still wishing to pursue a stand alone organisational model, decided to explore the establishment of a Social Enterprise under the staff "right to request" scheme. NHS Leeds Board supported the development of the Social Enterprise Business Case in July 2010. Detailed negotiations with

¹ There are approximately 3000 staff in Leeds Community Healthcare and the survey delivered a 47% response rate (1400 staff (approx.)). Of those that responded, 97% (1360 staff (approx.)) were in favour of the Community Foundation Trust option.

the NHS Yorkshire and the Humber and the Department of Health in late summer opened the opportunity for the reconsideration of the Community Foundation Trust option.

As this was the preferred model, both for the organisation and for staff, an application was submitted to the Department of Health for Leeds to be considered in the second wave of applicants for Community Foundation Trust status

On 1st November 2010 NHS Leeds/NHS Leeds Community Healthcare presented the proposal to the Department of Health Community Foundation Trust panel. The panel considered that the proposal made good strategic sense, was pro-competitive, should be sustainable, and had the potential to transform local community services and approved the forwarding of Leeds Community Foundation Trust application to the Department of Health Transactions Board. The case will be reviewed on 13th December 2010. The Department of Health Community Foundation Trust panel recommended the following actions take place prior to the Transactions Board meeting:

- a) Yorkshire & Humber Strategic Health Authority should further assure itself on organisational readiness and ensure a Director of Finance and Board are in place.
- b) Yorkshire & Humber Strategic Health Authority should assure itself on the financial aspects of the proposal.
- c) Leeds Community Healthcare to review the following documents and forward to Department of Health:
 - Short business case.
 - Opening balance sheet.
 - Financial projections for the next 3 years.
- d) A covering letter be provided from the Yorkshire & Humber Strategic Health Authority confirming the following
 - Yorkshire & Humber Strategic Health Authority and PCT Board have signed off for the Community Foundation Trust route.
 - Yorkshire & Humber Strategic Health Authority assurance of readiness for Trust status by December 2010.

NHS Leeds is currently working with the Yorkshire & Humber Strategic Health Authority and the Leeds Community Healthcare management team to ensure that the actions required by the Department of Health have been undertaken in readiness for the Transaction Board on 13th December 2010.
