9. White Paper Motion - Leeds Climate Change Strategy and Action Plan

Council welcomes the Leeds Climate Change Strategy and Action Plan, but recognises that it does not go far enough in reducing CO₂ emissions and does not, as yet, commit the city to the actions that are needed.

Council therefore calls on the Executive Board:

- 1) To introduce a target of reducing CO₂ emissions by an annual rate of 10% per year for the city as a whole, i.e. an overall reduction of around 65% between 2010 and 2020 against a 2005 baseline.
- 2) To provide quarterly updates on performance against the target.

10. White Paper Motion - Ofsted Inspection of Children's Services

This Council expresses its deep concern at the findings of Ofsted's recent announced inspection of Leeds City Council's Children's Services department.

Council is alarmed about Ofsted's disturbing conclusions, which follow similarly damning comments arising from an unannounced inspection of the department last year, which found that out of a sample of 23 children case files, seven children were found to be at potential risk of serious harm. Further reports have highlighted that a third of the indicators we are judged against have been deemed to be inadequate. This underlines the concern of everyone in the city over the safeguarding and well-being of our most vulnerable children.

Council affirms that the safeguarding of children should receive the highest priority, and that this Council has once again failed to fulfil this most vital of responsibilities.

Furthermore, Council condemns Executive Board member for Children's Services Cllr Stewart Golton, and previous incumbents in the role Councillors Richard Brett and Brian Jennings for their continued failure to tackle key weaknesses within the department.

Council therefore resolves that:

1. An urgent report on Ofsted's inspection be brought to an extraordinary meeting of the Executive Board as soon as possible.
2. In order to ensure full and transparent accountability, Children's Services Scrutiny Board should be chaired by a member of the opposition.

11. White Paper Motion - Leeds Kirkgate Market

This Council underlines its commitment to Leeds Kirkgate Market and all markets across the city. Council notes that some progress has been made at Kirkgate Market recently, but recognises a lot of hard work still needs to be done to address a wide-range of challenging and critical issues.

Council also acknowledges the important role that traders play in Kirkgate Market, and resolves therefore to do everything in its power to save and preserve this vital retail asset in our city.

12. White Paper Motion - Public Spending and Democratic Accountability

This Council notes that over £7 billion of public spending takes place in the Leeds District on an annual basis.

Council further notes that less than 10% of this public spending is raised locally and that this causes major problems in terms of public accountability as well as creating a democratic deficit.

Council therefore supports moves to improve democratic accountability at a local level through:-

- return of business rates to local authority control
- less interference by central government in regional funding decisions
- more powers of scrutiny over regional bodies and the health service
- continuing development of Leeds City Region

Council recognises the negative impact this government has had on democratic accountability and further recognises the impact that proposed government cuts will have on frontline services in Leeds. As a result of the poor deal given to Leeds in the current CSR and the economic forecast for the coming years this council concludes that a new approach is needed to local government both in Leeds and nationally.

Council asks the Chief Executive to write to Gordon Brown and Leeds MPs and all MEPs serving the Leeds area asking them in the light of the "total place initiative" to support measures that would improve democratic accountability in Leeds.

This Council underlines its commitment to providing recreational open space and playing pitches for residents right across the city. Council notes the particularly acute shortage of such recreational space within 3 miles of the city centre, and recognises the massive blow to the local community if the playing fields located on the former Leeds Girls High site were to be lost.

Council therefore pledges to do all it can to increase the total area of public recreational land in the city, and vigorously protect all playing pitches designated under UDP policy N6 from non-recreational built development.

1. INTRODUCTION

Under the Local Government Finance Act 1992 and accompanying regulations, detailed procedures are laid down for calculating the tax base which will be used for calculating the Council Tax. The tax base for the Leeds area is expressed as the number of Band D equivalent properties and will be used both for calculating Leeds City Council's own element of Council Tax and for notifying to the West Yorkshire Police and Fire Authorities for them to calculate their own elements of Council Tax. The West Yorkshire Police and Fire Authorities have to be notified of the tax base by 31 January 2010.

In addition to calculating the tax base for the Leeds area as a whole, a separate tax base has to be calculated for each part of the Council's areas to which a "special item" of expenditure relates. In Leeds, it is considered that only parish precepts should be treated as special items for these purposes and a tax base is therefore also calculated for each parish.

2. CALCULATIONS

Details of the calculations for Leeds as a whole and for each individual parish are given in the Appendix. In summary, the Council Tax Base for Leeds is calculated at 236,630 Band D equivalent properties. This is calculated by estimating changes from the District Valuer's Valuation List that will take place during 2010/2011 by reference to the following:

- a) provision for successful appeals,
- b) provision for exempt properties,
- c) changes in number of properties (demolitions and new additions),
- d) estimated single person and other discounts and
- e) estimated collection rate.

The net Council Budget for 2010/2011, which will be decided by Council in February 2010, will be divided by the calculated Council Tax Base to arrive at the Council Tax for a Band D property, from which the Council Tax for other valuation bands will be calculated.

3. **RECOMMENDATION**

Members are requested to adopt the following resolution:

that in accordance with the Local Authorities (Calculation of Tax Base) Regulations 1992 (as amended), the amount calculated by the Council as its Council Tax Base for the year 2010/2011 shall be 236,630 and for each parish as listed below:

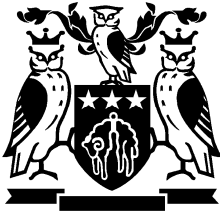

LATE ITEM

The Chair has admitted this report to the agenda as a late item in order that the Board be apprised of actions taken under the Special Urgency provisions of the Constitution at the earliest opportunity.

1.0 PURPOSE OF REPORT

1.1 To inform the Executive Board of a Key Decision taken under 'Special Urgency' provisions contained in the Constitution and to recommend the Board to forward this report to Council as the quarterly report on such decisions in accordance with paragraph 16.3 of the Access to Information Procedure Rules

2.0 BACKGROUND

2.1 The general requirement of the Council Constitution is that notice of Key Decisions will be given in the Forward Plan of Key Decisions. There is also provision for the five day notification of the intention to take a decision where it has been entered on the Forward Plan.

2.2 Paragraph 16 of the Access to Information Procedure Rules allows for 'Special Urgency' and states: "If by virtue of the date by which a decision must be taken Rule 15 (general exception) cannot be followed, then the decision can only be taken if the decision taker (if an individual) or the chair of the body making the decision, obtains

the agreement of the chair of a relevant Scrutiny Board that the taking of the decision cannot be reasonably deferred and the decision is urgent. If there is no chair of a relevant Scrutiny Board, or if the chair of the relevant Scrutiny Board is unable to act, then the agreement of the Lord Mayor of the Council, or in his/her absence the Deputy Lord Mayor will suffice”

- 2.3 Paragraph 16.3 of the Access to Information Procedure Rules requires that reports on special urgency decisions should be made in the following terms: “In any event, the leader will submit quarterly reports to the Council on the executive decisions taken in the circumstances set out in Rule 15 (special urgency) in the preceding three months. The report will include the number of decisions so taken and a summary of the matters in respect of which those decisions were taken”
- 2.4 The last decision taken under the special urgency provisions was in 2008 and in view of this the view was taken that the quarterly report requirement was superfluous until such time as such a decision might be taken. This report is in relation to a decision taken under the Special Urgency provisions on 2nd December 2009.

3.0 THE DECISION TAKEN

- 3.1 On 2nd December 2009 the Chief Planning Officer approved the designation of Buslingthorpe Conservation Area, as identified on the map attached to the report, with immediate effect. The designation became effective at 00.01 hours on 3rd December 2009.
- 3.2 On 1st December 2009 the Chief Officer advised Councillor A Carter as Leader of Council and relevant portfolio holder as to the need for the decision to be taken as a matter of urgency. On 2nd December 2009 the Chair of Scrutiny Board (City Development) was advised of the circumstances and agreed that the decision could be taken forthwith.
- 3.3 The context for the urgency of the decision as contained in the associated report is as follows;

“Buslingthorpe is an area of important industrial heritage which is currently unprotected and little understood or valued by the local population. There has recently been incremental loss of significant historic buildings in the area. Balmforth’s Tannery building was demolished in April 2008 following a successful appeal against refusal of planning permission and now stands as an empty site which further blights the already bleak built environment of Sheepscar. Perseverance Mill, which was of very high quality, was also demolished following a successful appeal and replaced with new-build flats which do not make a positive contribution to the character of the area.

While a number of important buildings have been lost, the unique character of Buslingthorpe and the lower Meanwood valley does survive. However, unless further loss is arrested this special character will soon disappear.

As set out above, the three large tannery complexes in Buslingthorpe constitute a major part of the surviving standing building evidence for the tanning industry in Leeds, and probably in England. While one complex is still in operation as a tannery, none of the three sites is fully occupied and all are likely to come under intense pressure for site clearance and re-development in the near future.

The historic manorial mill site of Scott Hall Mill also is also vulnerable to loss to re-development.

While archaeological significance may be accounted for through preservation by record as set out in PPG 16, the standing historic buildings in Buslingthorpe not only function as historic artefacts but also make a considerable contribution to the area's character and sense of place. Control over their retention may only be given by conservation area status. It is clear from the successful re-use of other historic industrial sites in Leeds that there is considerable scope for the imaginative re-use of such buildings once an archaeological record has been made of their surviving industrial features."

3.4 The specific reason as presented to the Chair of Scrutiny was:

"The reason is that this is an area of important but vulnerable historic tanneries one of which has already been lost to development and a further two are the subject of current pre-application discussions with developers/owners. In both cases the agents have indicated that the owners wish to demolish all or most of the complexes and they have not been persuaded of the merits of keeping and converting at least part of them. There is a real fear that these and other buildings may soon be lost to the detriment of the city. Conservation area status prevents precipitate action and allows the merits of retention/demolition to be considered as part of the planning process. Speed is clearly of the essence as any premature publicity will reduce the chance of a successful outcome, hence the request to waive normal procedures."

4.00 RECOMMENDATION

4.01 That the Executive Board approve this report as the report of the Leader for submission to Council as the quarterly report in accordance with Access to Information Procedure Rule 16.3
