9.0 Confidential information – requirement to exclude public access

9.1 The public must be excluded from meetings whenever it is likely in view of the nature of the business to be transacted or the nature of the proceedings that confidential information would be disclosed. Likewise, public access to reports, background papers, and minutes will also be excluded.

9.2 Confidential information means

- (a) information given to the Council by a Government Department on terms which forbid its public disclosure or
- (b) information the disclosure of which to the public is prohibited by or under another Act or by Court Order. Generally personal information which identifies an individual, must not be disclosed under the data protection and human rights rules.

10.0 Exempt information – discretion to exclude public access

- 10. 1 The public may be excluded from meetings whenever it is likely in view of the nature of the business to be transacted or the nature of the proceedings that exempt information would be disclosed provided:
 - (a) the meeting resolves so to exclude the public, and that resolution identifies the proceedings or part of the proceedings to which it applies, and
 - (b) that resolution states by reference to the descriptions in Schedule 12A to the Local Government Act 1972 (paragraph 10.4 below) the description of the exempt information giving rise to the exclusion of the public.
 - (c) that resolution states, by reference to reasons given in a relevant report or otherwise, in all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information.
- 10.2 In these circumstances, public access to reports, background papers and minutes will also be excluded.
- 10.3 Where the meeting will determine any person's civil rights or obligations, or adversely affect their possessions, Article 6 of the Human Rights Act 1998 establishes a presumption that the meeting will be held in public unless a private hearing is necessary for one of the reasons specified in Article 6.
- 10. 4 Exempt information means information falling within the following categories (subject to any condition):
 - 1 Information relating to any individual
 - 2 Information which is likely to reveal the identity of an individual.
 - Information relating to the financial or business affairs of any particular person (including the authority holding that information).
 - Information relating to any consultations or negotiations, or contemplated consultations or negotiations, in connection with any labour relations matter arising between the authority or a Minister of the Crown and employees of, or officer-holders under the authority.
 - Information in respect of which a claim to legal professional privilege could be maintained in legal proceedings.
 - 6 Information which reveals that the authority proposes
 - (a) to give under any enactment a notice under or by virtue of which requirements are imposed on a person; or
 - (b) to make an order or direction under any enactment
 - Information relating to any action taken or to be taken in connection with the prevention, investigation or prosecution of crime

Executive Summary

This report informs Members of an application for the review of a Premises Licence under Section 51 of the Licensing Act 2003, sought by West Yorkshire Police in respect of 1063 York Road Leeds 14 6JB. The Licensing Authority is now under a duty to review the Premises Licence held by these premises.

1.0 Purpose of this Report

1.1 This report provides Members with the background and history to the making of the review. The report sets out the relevant law when reviewing licences under the Licensing Act 2003 ("the Act"), and informs members of the options available to them when reviewing a premises licence.

2.0 Background Information

2.1 An application for the conversion of a Justices Licence was received by the Licensing Authority on 12 July 2005. The licensing authority did not receive any

representations therefore the licence was duly granted. We received a transfer in 2006 for which we did not receive any representation. In 2008 we received a further transfer application to the present premises licence holder.

2.0 Premises Licence

- 2.1 The Premises Licence Holder is Mr Kamaljit Singh Sandhu.
- 2.2 A copy of the Premises Licence can be found at Appendix **A** of this report.
- 2.2 In summary, the Premises Licence permits the following:

Sale by retail of alcohol (for consumption off the premises)

08:00 until 23:00 hrs Monday to Saturday 10.00 until 22:30 hrs Sunday

3.0 Designated Premises Supervisor

3.1 The Designated Premises Supervisor for the premises is Mr Kamaljit Singh Sandu.

4.0 Location

4.1 Maps which identify the location of the premises are attached at Appendix **B**.

5.0 Main Issues

- 5.1 The review is being sought by West Yorkshire Police on the grounds of the prevention of crime & disorder, prevention of public nuisance and protection of children from harm. A partial copy of the review application is located at Appendix C of this report. It should be noted that certain information submitted within the application is potentially exempt information under Access to Information Rule 10.4 (2) as it includes information which relates to individuals and is likely to reveal the identity of an individual. This information is contained within appendix D.
- As part of the review procedure, details of the review and an outline of the grounds on which the review is requested must be displayed at the premises for a period of 28 days, commencing the day after the application is received.
- 5.3 Such notices were duly placed on prominent display at the premises on 20th April 2012 and checked on a regular basis. The notices were removed at the end of the consultation period on 17th May 2012.
- 5.4 Section 51 of the Licensing Act 2003 places the Licensing Authority under a duty to review the premises Licence in respect of Bestone/Seacroft Village Store. A summary of the procedure followed in accordance with the Act is attached to this report by way of a flow chart at Appendix **E.**

6.0 Relevant Representations/Support

6.1 Under the Act representations/support can be received from responsible authorities and or interested parties. Representations must be relevant and, in the case of an interested party, must not be frivolous or vexatious.

6.1.2 <u>Letters of support for the premises licence holder</u>

6.1.3 The application has attracted letters of support from interested parties for the premises licence holder Members are drawn to attached background papers.

6.1.4 Additional Information provided by the premises licence holder

6.1.5 The premises licence holder has provided additional information attached at Appendix **F**

7.0 Matters Relevant to the Application

- 7.1 Members of the Licensing Sub Committee must make decisions with a view to promoting the licensing objectives which are:
 - 7.1.1 the prevention of crime and disorder;
 - 7.1.2 public safety;
 - 7.1.3 the prevention of public nuisance; and
 - 7.1.4 the protection of children from harm.
- 7.2 In making their decision Members are obliged to have regard to guidance issued under Section 182 of the Act, a copy of the relevant section is attached at Appendix G. Members must also have regard to the Council's licensing policy, the relevant representations made and evidence they hear.

8.0 Implications for Council Policy and Government

8.1 It is the stated licensing policy of the Council that when considering a review the authority will take into account all relevant circumstances, but will view the matters listed in paragraph 12.13 of the policy with particular seriousness.

9.0 Legal and Resource Implications

- 9.1 There are no resource implications in determining the review.
- 9.2 The Act provides the right to appeal on any decision reached on review. The right of appeal is to the Magistrate's Court.

10.0 Recommendations

- 10.1 Members are requested to determine this review. The Committee must take such of the following steps as it considers necessary for the promotion of the licensing objectives:
 - 10.1.1 to modify the conditions of the licence (which includes adding new conditions or any alteration or omission of an existing condition);
 - 10.1.2 exclude any licensable activities to which the application relates;
 - 10.1.3 to remove the Designated Premises Supervisor;
 - 10.1.4 to suspend the licence for a period not exceeding 3 months; and/or
 - 10.1.5 to revoke the licence.
- 10.2 Members may alternatively decide that no action is necessary and that the circumstance of the review does not require the Committee to take any steps to promote the licensing objectives.

- Members should note the Guidance also suggests it is open to Members to issue an informal warning to the licence holder or to recommend improvement within a particular time. However the Guidance further provides that where responsible authorities have already issued such warnings, the issuing of another warning should not be repeated.
- 10.4 Members of the Licensing Committee are asked to note that they may not take any of the steps outlined above merely because they consider it desirable to do so. It must actually be <u>necessary</u> in order to promote the licensing objectives.

- b) the sale of alcohol to a trader or club for the purposes of the trade or club;



1063 York Road, Seacroft, Leeds LS14 6JB is a small off licensed premises in the Seacroft area of Leeds. The area, as a whole, suffers from a high proportion of alcohol related anti-social behaviour (ASB) and crime and disorder.

The area is closely monitored by the Neighbourhood Policing Team (NPT) for the Killingbeck and Seacroft (KS) area. This team is lead by Inspector Steve Emmett. Much of the work in relation to local issues is conducted in conjunction with partnership agencies and following close liaison with the residents from the community.

This store has been the focus of Police attention for over a year. Concern had been raised within the community that the store was fuelling ASB, street drinking by known persons and the underage sale and consumption of alcohol. Test Purchase activity in the Seacroft area was initiated and the premises was included in this activity.

On 4 February 2011 Officers visited the premises and a sale of alcohol was made to an underage test purchase child. A fixed penalty ticket was issued to the seller. The child was fifteen years old.

On 1 July 2011 Officers conducted a second test purchase operation and 1063 York Road was included in this operation also. A sale of alcohol was made to an underage test purchase child on this second occasion. The child was fifteen years old.

Due to increased concern in relation to ASB, street drinking, intimidation, youth issues and in support of the DPPO a problem solving initiative was commenced in July 2011. 1063 York Road were warned during this process about how they were contributing to the problems in the Seacroft area and seemed dismissive of the issues. They were given the opportunity to tighten their processes to avoid another test purchase failure. They were warned that a further failure would result in the review of the premises licence.

On 17 March 2012 Officers conducted a third test purchase operation at 1063 York Road. The premises sold alcohol to a fourteen year old girl. A review of the premises licence is thought necessary and appropriate given the level of engagement and the most recent failure to uphold the licensing objectives.

A full chronology is attached to the review papers.

- e) That it is an offence to knowingly or recklessly to make a false statement in connection with the review.

The advert is placed for no less than 28 consecutive days starting with the day after the application was given to the applicant.

The Licensing Authority must hold a hearing

The hearing must be held within 20 working days beginning with the day *after* the end of the period during which representations may be made

The Licensing Authority must give notice of the hearing, no later than ten working days before the day of the hearing

Notice of the review hearing must be given to

- a) The premises licence holder
- b) Those that made relevant representations

Representations from interested parties must not be vexatious, frivolous or a repetition.

- A ground for review already specified in an earlier review application of the same premises which has already been determined; or
- Representations considered when the premises licence was first granted; or
- Representations which would have been made when the application for the premises licence was first granted and which were excluded then due to a provisional statement being issued; and
- A reasonable interval has not elapsed since a previous review or the grant of the licence.

Notification that a representation is frivolous, vexatious or repetitious must be given in writing before the review is determined.

Positive Test Purchase

On 1 July 2011 West Yorkshire Police ran a test-purchase operation with juvenile volunteers under 16½ years of age. You should be aware that your premises had a successful test purchase made by a juvenile on this date, resulting in a fixed penalty notice being issued to a member of your staff.

It is important for the police to reduce violent crime and disorder. One of the best ways to do this is to stop unlawful alcohol sales to juveniles who react adversely to alcohol and cannot control their behaviour when they have had too much to drink. Irresponsible licensees whose members of staff do not comply with the law are now easier to deal with under current licensing legislation and have punitive measures taken against them.

You should be aware that not only does this department generally take formal proceedings against a venue that fails three such test purchases in any 12 month period, but under new legislation which became law under The Policing and Crime Act 2009, the criteria for committing an offence of persistently selling to under 18's was reduced from three strikes to two within a three month period. The penalties for this offence, upon conviction, can lead to a ban on alcohol sales for three months and a £10,000 fine. This is shortly to be increased to £20,000.

This was the above premises' second failure in the last 12 months.

I would urge you to ensure that Check 21 posters are displayed at your premises, exercise due diligence when selling to younger looking customers and make every effort to comply with the conditions of your licence to avoid any further difficulty.

Hi Lynn,

I would ask the Police to consider agreeing to the following conditions being added to the premises licence, which I suggest would be a more proportionate outcome to revocation:

- 1. Challenge 25;
- 2. A refusal register to be kept and be made available for inspection by the police and officers of the licensing authority;
- 3. The DPS will attend an external training course regarding the sale of age related products and cascade the training down to the staff who work in the premises;
- 4. All staff will be trained regarding the sale of age related products when they commence employment and they will receive refresher training every 6 months thereafter;
- 5. Training records will be kept for all staff and made available for inspection by the police and officers of the licensing authority;
 - 6. CCTV will be installed in the premises to cover all areas to which the public have access and will record for all hours the premises is open to the public. Recordings will be kept for a minimum of 31 days.
 - 6.1 Signs will be displayed in the premises to advise the public that CCTV is recording in the shop.
