Summary of Main Issues

This is an application for the grant of a premises licence for a premises to be known as Brooklyn Brewery Pop Up, 20 - 24 The Calls, Leeds, LS2 7EW.

The application describes a premises wishing to operate as a temporary arts and cultural space used for the purpose of marketing. The hours and licensable activities applied for are noted at 3.3 of this report.

Responsible Authorities and Ward Members have been notified of this application.

Consequently the application has attracted outright representation on behalf of West Yorkshire Police. In addition to a representation offering suggested measures has been received from Environmental Health, with an agreement to those measures being reached.

It should be noted that these premises are located within an area covered by Cumulative Impact Policy Area 1 – Leeds City Centre.

1.0 Purpose of this Report

- 1.1 To advise Members of an application made under section 17 of the Licensing Act 2003 ("the Act") for a premises licence in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of representations.

2.0 History of Premises

2.1 This is the first application for a premises licence for these premises.

3.0 The Application

- 3.1 The applicant is Broomhouse Investments Limited.
- 3.2 The application form may be found at **Appendix A** to this report.
- 3.3 In summary the application is for:

Sale by Retail of Alcohol (for consumption on and off the premises) 16:00 until 00:30 hours Wednesday to Thursday 12:00 until 00:30 hours Saturday 16:00 until 00:30 hours Sunday

Late Night Refreshment 23:00 until 00:30 hours Wednesday to Sunday

Recorded Music

16:00 until 01:00 hours Wednesday to Thursday 12:00 until 01:00 hours Saturday 16:00 until 01:00 hours Sunday

Non-Standard Timings The application does not propose any non-standard timings for bank holidays or special occasions.

4.0 Other Matters Relevant to the Application

4.1 At the time of writing this report there were no implications for equality and diversity. Any decision taken by the Licensing Sub-Committee will be in accordance with the four licensing objectives as prescribed by the Licensing Act 2003.

5.0 Steps to promote the Licensing Objectives

5.1 The application proposes to take the steps identified in section "P" of the application form to promote the licensing objectives.

6.0 Proposed Designated Premises Supervisor

6.1 Mr. Michael Watson intends to be the Designated Premises Supervisor.

7.0 Location

7.1 A map which identifies the location of this premise is attached at **Appendix B**.

8.0 Cumulative Impact Policy

- 8.1 These premises reside within the Cumulative Impact Area 1 Leeds City Centre.
- 8.2 Cumulative impact means the potential impact on the promotion of the licensing objectives where there are a significant number of licensed premises concentrated in one area.
- 8.3 An applicant wishing to obtain a new licence for a premises falling within any of the cumulative impact areas must identify through the risk assessment process and/or operating schedule the steps that they intend to take so that the council and responsible authorities can be satisfied that granting a new licence will not add to the impact already being experienced.
- 8.4 Details of the Cumulative Impact Policy specific to Leeds City Centre and an outline of the evidence behind the reason for setting this policy is attached at **Appendix C**.

9.0 Representations

- 9.1 Under the Act representations can be received from responsible authorities or other persons. Representations must be relevant and, in the case of another person, must not be frivolous or vexatious.
- 9.2 <u>Representations from Responsible Authorities</u>
- 9.2.1 This application has attracted representations from both West Yorkshire Police and Leeds City Council Environmental Protection Team.
- 9.2.2 We are in receipt of an outright representation submitted by West Yorkshire Police. This remains a matter for Members consideration with a copy attached at **Appendix D** of this report.
- 9.2.3 Some representations by responsible authorities may be agreed prior to reaching hearing. In this instance the operating schedule has been amended to include measures agreed with the Environmental Protection Team, a copy of which can be found at **Appendix E**.
- 9.3 <u>Other representations</u>
- 9.3.1 There are no representations from other parties.

10.0 Options Available to Members

- 10.1 The licensing sub-committee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
 - Grant the application as requested;
 - Grant the application whilst imposing additional conditions and/or altering in any way the proposed operating schedule;
 - Exclude any licensable activities to which the application relates;
 - Refuse to specify the said person as designated premises supervisor; or
 - Reject the whole or part of the application.
- 10.2 Members of the licensing sub committee are asked to note that they may not modify the conditions or reject the whole or part of the application merely because it considers it desirable to do so. It must actually be appropriate in order to promote the licensing objectives.




Area 1 - City Centre

It is the council's policy, on receipt of relevant representations, to refuse new and variation applications in Area 1 for alcohol led premises such as bars, pubs and nightclubs and for premises seeking late night refreshment such as takeaways and late opening restaurants, unless the applicant can demonstrate that their application would not impact on the cumulative effect of such licensed premises in the area.

Rationale

In the five years since the cumulative impact policy for the city centre was introduced, the City Centre has changed. Recent crime statistics show three main hot spots for crime and disorder:

- 1. Call Lane, Boar Lane and the area behind the Corn Exchange
- 2. Woodhouse Lane, Merrion Way and Wade Lane
- 3. The east end of The Headrow and New Briggate

Other areas of concern include the Eastgate area and Briggate.

The council has noticed an increase in applications for premises licences in the Park Square area. It is feasible that this is due to displacement from the East Parade/Greek Street/Park Row part of the cumulative impact policy.

On reviewing these facts and the previous cumulative impact policy, the council has amended the geographical area of the cumulative impact policy to incorporate the crime hotspots and the Park Square area.

In addition there is rising concern about premises which have not been included within the scope of the previous policy, such as restaurants serving hot food and drink after 11pm. These premises have also contributed to crime, disorder and public nuisance in the city centre.

The previous policy referenced high volume vertical drinking establishments. This reference has been removed as it is recognised that all alcohol led licensed premises can contribute to crime and disorder in the area, not just those that are classified as "high volume vertical drinking" establishments.





Fig 2 shows the number and location of nuisance reports received by Leeds City Council, relevant to licensed premises in Area 1 since 2005.

Police analysis has shown the following key findings relating to serious crime in Area 1:


- 94% of serious violent offences have been committed in the night-time economy (NTE) period.
- 63% of offences committed in the NTE are affected by alcohol
- 20% of offences committed in the NTE are committed within licensed premises
- Between 2008 and 2009 incidents have increased by 26 equating to a 32% rise.

Serious Violent Crime hot-spots


Fig 3 shows density of serious violent crime offences in Area 1. The coloured dots are licensed premises however, have not been identified individually by name.

Thank you for submitting your application for the above premises, received at the address above on 29th April 2013.

The application relates to premises which fall within one of the areas of Leeds currently subject to a policy of cumulative impact, as detailed in the present Statement of Licensing Policy 2011-2013, issued by Leeds City Council as the licensing authority.

The area concerned in this particular case is Area 1 Leeds City Centre.

Therefore, in line with the current statutory guidance issued by the Secretary of State under Section 182 Licensing Act 2003, West Yorkshire Police make representations based on the cumulative impact policy of the area concerned and highlighted above, where the licensing objectives and particularly the prevention of crime and disorder and prevention of public nuisance objectives, are being adversely affected.

CIP - Area 1 – Leeds City Centre:

There has been a policy of cumulative impact in Leeds City Centre since January 2005, as a part of the original Statement of Licensing Policy issued by Leeds City Council, made to introduce the 'transitional provisions' of Licensing Act 2003 in February 2005 to full implementation in November 2005.

As a part of the process back then, in 2004 West Yorkshire Police provided detailed statistical analysis of alcohol related crime and disorder and anti social behaviour, in relation to specific areas of the City Centre.

The original policy only applied to certain isolated parts of Leeds City Centre.

In 2007, as part of the first 3 year review of Leeds City Council's Statement of Licensing Policy, further statistical evidence was produced by West Yorkshire Police to ascertain if there was the continuing need for a policy of cumulative impact in Leeds City Centre.

As a result, in December 2007 the revised Statement of Licensing Policy 2007-2010 was issued by Leeds City Council, and whilst the policy of cumulative impact for Leeds City Centre was to continue, there was very little if any relevant change in the wording of the policy and no change at all in the affected areas of the City Centre.

A second review of the Statement of Licensing Policy has taken place in Leeds in 2010 and a 3rd edition has been issued by Leeds City Council as recently as early January 2011.

During this lengthy process, West Yorkshire Police, after being requested to do so, once again provided an up to date 2 year statistical overview of violent offences and anti-social behaviour in Leeds City Centre as a whole.

As a result, on this occasion the policy of cumulative impact for Leeds City Centre has radically changed, both in -:

- 1. a significantly increased geographical area, and
- 2. modification of the wording of the policy, to include all types of alcohol led premises, rather than just a specific type of premises serving alcohol.

The current Statement of Licensing Policy goes into further detail about the significant changes recently made and highlighted above.

For instance-:

- Paragraph 7.16 "In the five years since the cumulative policy for the city centre was introduced, the City Centre has changed. Recent crime statistics show three main hot spots for crime and disorder:
 - 1. Call Lane, Boar Lane and the area behind the Corn Exchange
 - 2. Woodhouse Lane, Merrion Way and Wade Lane
 - 3. The east end of The Headrow and New Briggate.
- Paragraph 7.17 "Other areas of concern include the Eastgate area and Briggate".
- Paragraph 7.19 "On reviewing these facts and the previous cumulative impact policy, the council has amended the geographical area of the cumulative impact policy to incorporate the crime hotspots......".
- Paragraph 7. 20 "In addition there is rising concern about premises which have not been included within the scope of the previous policy, such as restaurants serving hot food and drink after 11pm. These premises have also contributed to crime, disorder and public nuisance in the city centre.

The wording for the current policy of cumulative impact for Leeds City Centre therefore now reads-:

"It is the council's policy, on receipt of relevant representations, to refuse new and variation applications in Area 1 for alcohol led premises such as bars, pubs and nightclubs and for premises seeking late night refreshment such as takeaways and late opening restaurants, unless

the applicant can demonstrate that their application would not add to the cumulative impact of such licensed premises in the area".

The application for a new premises licence does not adequately outline exactly how the proposed venue will operate. On page 4 of the application it is said that it will be a 'Temporary Arts and Cultural Space for the purpose of Marketing'. However, it does not state when the applicant would wish for the premises licence to start or, indeed, if the licence is to be valid for a limited period – something which is suggested in it being described as 'temporary'. Given the proposed premises' close proximity to an area of Leeds which is an alcohol related crime hotspot, Call Lane, and the scant information on how it intends to operate West Yorkshire Police have no option other than to lodge a full objection.

Premises Summary

The application premises is a commercial warehouse type building towards the South of Leeds city centre.

The surrounding area contains a mixture of commercial premises (restaurants/offices etc) and residential dwellings. The closest block of flats being approximately 20 metres to the East at 32 The Calls.

The application is for recorded music, supply of alcohol, and late night refreshment; with licensable activities until 1am in the morning. The proposals have the potential to create noise disturbance from the premises due to music and the activity of patrons, especially to the occupiers of nearby flats. In addition, the application may increase the number of late night revellers in the area. Therefore, there is a greater potential for public nuisance to noise sensitive occupants if this application is granted.

In addition, the application premises is situated within a Cumulative Impact Policy Area, which requires the applicant to submit sufficient information to satisfy this service that granting of a new licence will not add to the impact already being experienced.

The applicant has submitted various steps that are intended to be taken to promote the prevention of public nuisance. Unfortunately, the measures proposed would not seem to adequately control all the relevant issues, especially those in relation to an increase in late night revellers in the area or the activity of patrons smoking outside the premises.

However, it is noted that the applicant has described the proposals as a temporary arts and cultural space for the purpose of marketing. In addition, no external drinking area is shown on the submitted plans. Therefore, if the premises is not going to operate in the manner of a city centre drinking establishment then the potential for public nuisance is greatly reduced. Confirmation of the use as proposed would allow this service to consider that a full objection to this application is not necessary.

Having considered the application under the Licensing Act 2003 for the above premises, the Leeds City Council's environmental action service considers that the following measures are proportionate and necessary in order to promote the following licensing objective:

• Prevention of public nuisance

Noise and Vibration

- 1. At any time that the Premises Licence has effect, the licensable activities will be ancillary to the use of the premises as an arts and cultural space for the purpose of marketing.
- 2. Patrons shall not be permitted to use any external areas of the premises for the consumption of food or drink.
- 3. During hours of licensable activity, smoking by patrons shall only be permitted to the front of the premises which faces onto The Calls.
- 4. The activities of persons using the external areas shall be monitored after 11 pm and they shall be reminded to have regard to the needs of local residents and to refrain from shouting and anti social behaviour etc when necessary.

Summary of main issues

This is an application to vary a premises licence, made by Lynne Keenan, for Darbar Restaurant 17 Kirkgate, Leeds, LS1 6BY

Responsible authorities and Ward Members have been notified of this application.

The application has attracted representations from responsible authorities including West Yorkshire Police and Environmental Health.

Please refer to paragraph 3.3 for details of the application.

The premises are located within an area covered by a Cumulative Impact Policy.

1.0 Purpose of this Report

- 1.1 To advise Members of an application made under section 34 of the Licensing Act 2003 ("the Act") for a premises licence in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of representations.

2.0 History of Premises

- 2.1 An application for the conversion of the former licence into a premises licence was submitted in July 2005 under the Licensing Act 2003. No objection to the conversion application was received and a premise licence was duly granted for the existing hours and activities.
- 2.2 In March 2008 an application to vary the licence was submitted to extend the hours for licensable activities until 05:00 hours. Representations were received from Leeds City Council Environmental Health and West Yorkshire Police, agreements were reached with all parties and a licence was granted as applied for.
- 2.3 A minor variation was submitted in April 2010 applying to remove certain conditions attached to the premises licence and to make structural alterations. The application was refused due to receipt of representation from West Yorkshire Police as they felt the application would significantly change the nature of the business and result in the licensing objectives being undermined.
- 2.4 The licence was transferred from Raza Hussai to Lynne Keenan in May 2012.
- 2.5 A copy of the existing licence is attached at Appendix A

3.0 The Application

- 3.1 The applicant is Lynne Keenan
- 3.2 The application form may be found at Appendix B to this report.
- 3.3 In summary the application is to change the primary use of the premises from a restaurant to a bar, in order to do this the applicant has applied to remove the following conditions;
 - At any time that the Premises Licence has effect, the sale of alcohol for consumption on the premises will be ancillary to the service of table meals.
 - At any time that the Premises Licence has effect a minimum of 60 covers shall be maintained at the premises.

Members are to note that all licensable activities and timings are to remain as existing.

4.0 Other matters relevant to the application

4.1 Members are to note that although the premises licence has the benefit of sale by retail of alcohol, the premises do not have an individual specified as the designated premises supervisor resulting in no alcohol sales to take place at the premises until the licence holder submits an application to nominate a person.

4.2 Equality and Diversity / Cohesion and Integration

4.3 At the time of writing this report there were no implications for equality and diversity. Any decision taken by the Licensing Sub-Committee will be in accordance with the four licensing objectives as prescribed by the Licensing Act 2003.

5.0 Steps to promote the Licensing Objectives

5.1 The applicant does not propose any further measures to promote the licensing objectives.

6.0 Location

6.1 A map which identifies the location of this premises is attached at Appendix C.

7.0 Cumulative Impact Policy

- The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children -

- games or activities which require or encourage, or are designed to require or encourage, individuals to -
 - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - ii. drink as much alcohol as possible (whether within a time limit or otherwise);
- provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
- provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
- d. provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on
 - i. the outcome of a race, competition or other event or process, or
 - ii. the likelihood of anything occurring or not occurring;
- e. selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

- The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

- 8. The responsible person shall ensure that
 - a. where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures:
 - i. beer or cider. 1/2 pint;
 - ii. gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - iii. still wine in a glass:125 ml; and
 - b. customers are made aware of the availability of these measures

Embedded Restrictions

- 9. Alcohol shall not be sold or supplied except during the hours stated on this licence and:

- 11. Suitable non-alcoholic beverage, including drinking water, shall equally be available for consumption with or otherwise as an ancillary to meals served in the licensed premises.

- 15. A suitable CCTV system will be maintained and be operational on the premises at all times when licensed activities are being carried out.

- The licensee will adopt a proof of age scheme which is approved by WYP and West Yorkshire Trading Standards (WYTS).
- 27. The Licensee's staff will ask for proof of age from any person appearing to be under the age of 21 who attempts to purchase alcohol at the premises.
- 28. The Licensee's staff will ask for evidence from any person appearing to be under the age of 18 who attempts to purchase alcohol at the premises.
- 29. Drinks, open bottles and glasses will not be taken from the premises at any time. Empty bottles and glasses will be collected regularly and promptly. Glass and other sharp objects will be stored and disposed of safely using suitable receptacles. Receptacles will be secured and not accessible to the customers.
- The Licensee will prominently display notices which inform customers that open bottles or glasses may not be taken off the premises.
- 31. Plastic or toughened glasses/bottles will be used in all outdoor areas.
- Plastic or toughened glasses or bottles will be used when requested by West Yorkshire Police (e.g. football match days).
- Notices indicating the existence and effect of an Alcohol Designated Public Places Order will be displayed at the exits to the premises.

- 38. Ensure that all licensable activities are conducted and operated so as to prevent the transmission of audible noise or perceptible vibration through the fabric of the building or structure to adjoining properties.




Cumulative Impact Policy

It is the council's policy, on receipt of relevant representations, to refuse new and variation applications in Area 1 for alcohol led premises such as bars, pubs and nightclubs and for premises seeking late night refreshment such as takeaways and late opening restaurants, unless the applicant can demonstrate that their application would not impact on the cumulative effect of such licensed premises in the area.

Rationale

In the five years since the cumulative impact policy for the city centre was introduced, the City Centre has changed. Recent crime statistics show three main hot spots for crime and disorder:

- 1. Call Lane, Boar Lane and the area behind the Corn Exchange
- 2. Woodhouse Lane, Merrion Way and Wade Lane
- 3. The east end of The Headrow and New Briggate

Other areas of concern include the Eastgate area and Briggate.

The council has noticed an increase in applications for premises licences in the Park Square area. It is feasible that this is due to displacement from the East Parade/Greek Street/Park Row part of the cumulative impact policy.

On reviewing these facts and the previous cumulative impact policy, the council has amended the geographical area of the cumulative impact policy to incorporate the crime hotspots and the Park Square area.

In addition there is rising concern about premises which have not been included within the scope of the previous policy, such as restaurants serving hot food and drink after 11pm. These premises have also contributed to crime, disorder and public nuisance in the city centre.

The previous policy referenced high volume vertical drinking establishments. This reference has been removed as it is recognised that all alcohol led licensed premises can contribute to crime and disorder in the area, not just those that are classified as "high volume vertical drinking" establishments.




Fig 2 shows the number and location of nuisance reports received by Leeds City Council, relevant to licensed premises in Area 1 since 2005.

Police analysis has shown the following key findings relating to serious crime in Area 1:


- 94% of serious violent offences have been committed in the night-time economy (NTE) period.
- 63% of offences committed in the NTE are affected by alcohol
- 20% of offences committed in the NTE are committed within licensed premises
- Between 2008 and 2009 incidents have increased by 26 equating to a 32% rise.

Serious Violent Crime hot-spots


Fig 3 shows density of serious violent crime offences in Area 1. The coloured dots are licensed premises however, have not been identified individually by name.



Thank you for submitting your application for the above premises, received at the address above on 1st May 2013.

The application relates to premises which fall within one of the areas of Leeds currently subject to a policy of cumulative impact, as detailed in the present Statement of Licensing Policy 2011-2013, issued by Leeds City Council as the licensing authority.

The area concerned in this particular case is Area 1 Leeds City Centre.

Therefore, in line with the current statutory guidance issued by the Secretary of State under Section 182 Licensing Act 2003, West Yorkshire Police make representations based on the cumulative impact policy of the area concerned and highlighted above, where the licensing objectives and particularly the prevention of crime and disorder and prevention of public nuisance objectives, are being adversely affected.

CIP - Area 1 – Leeds City Centre:

There has been a policy of cumulative impact in Leeds City Centre since January 2005, as a part of the

original Statement of Licensing Policy issued by Leeds City Council, made to introduce the 'transitional provisions' of Licensing Act 2003 in February 2005 to full implementation in November 2005.

As a part of the process back then, in 2004 West Yorkshire Police provided detailed statistical analysis of alcohol related crime and disorder and anti social behaviour, in relation to specific areas of the City Centre.

The original policy only applied to certain isolated parts of Leeds City Centre.

In 2007, as part of the first 3 year review of Leeds City Council's Statement of Licensing Policy, further statistical evidence was produced by West Yorkshire Police to ascertain if there was the continuing need for a policy of cumulative impact in Leeds City Centre.

As a result, in December 2007 the revised Statement of Licensing Policy 2007-2010 was issued by Leeds City Council, and whilst the policy of cumulative impact for Leeds City Centre was to continue, there was very little if any relevant change in the wording of the policy and no change at all in the affected areas of the City Centre.

A second review of the Statement of Licensing Policy has taken place in Leeds in 2010 and a 3rd edition has been issued by Leeds City Council as recently as early January 2011.

During this lengthy process, West Yorkshire Police, after being requested to do so, once again provided an up to date 2 year statistical overview of violent offences and anti-social behaviour in Leeds City Centre as a whole.

As a result, on this occasion the policy of cumulative impact for Leeds City Centre has radically changed, both in -:

- 1. a significantly increased geographical area, and
- 2. modification of the wording of the policy, to include all types of alcohol led premises, rather than just a specific type of premises serving alcohol.

The current Statement of Licensing Policy goes into further detail about the significant changes recently made and highlighted above.

For instance-:


- Paragraph 7.16 "In the five years since the cumulative policy for the city centre was introduced, the City Centre has changed. Recent crime statistics show three main hot spots for crime and disorder:
 - 1. Call Lane, Boar Lane and the area behind the Corn Exchange
 - 2. Woodhouse Lane, Merrion Way and Wade Lane
 - 3. The east end of The Headrow and New Briggate.
- Paragraph 7.17 "Other areas of concern include the Eastgate area and Briggate".
- Paragraph 7.19 "On reviewing these facts and the previous cumulative impact policy, the council has amended the geographical area of the cumulative impact policy to incorporate the crime hotspots...........".
- Paragraph 7. 20 "In addition there is rising concern about premises which have not been included within the scope of the previous policy, such as restaurants serving hot food and drink after 11pm. These premises have also contributed to crime, disorder and public nuisance in the city centre.

The wording for the current policy of cumulative impact for Leeds City Centre therefore now reads-:

"It is the council's policy, on receipt of relevant representations, to refuse new and variation applications in Area 1 for alcohol led premises such as bars, pubs and nightclubs and for premises seeking late night refreshment such as takeaways and late opening restaurants, unless the applicant can demonstrate that their application would not add to the cumulative impact of such licensed premises in the area".

Therefore, in terms of location, in terms of operating as a late night bar/nightclub, and in terms of the proposed variation which seeks to remove two conditions specifically on the licence to restrict the operation to being a restaurant West Yorkshire Police consider that this application implicates the current policy of cumulative impact for Leeds City Centre in every respect, and would rely on paragraphs 13.29 and 13.30 of the current Section 182 guidance in making this representation.

The application premises is situated within a Cumulative Impact Policy Area which require you to submit sufficient information to satisfy this Service that the granting of a new licence will not add to the impact already being experienced.

Your proposals have the potential to create noise disturbance from the premises due to music and the activity of patrons, especially to the occupiers of nearby flats. In addition, the application may increase the number of late night revelers in the area. Therefore there is a greater potential for public nuisance to noise sensitive occupants if this application is granted.

It was noted that various steps intended to be taken to promote the prevention of public nuisance are already included in the existing licence. Unfortunately, the measures proposed would not seem to adequately control all the relevant issues. It also seems unlikely that the applicant would be able to comply with appropriate conditions for the prevention of public nuisance.

Therefore, Leeds City Council Environmental Health Service is of the opinion that your application contains insufficient information about how you intended to meet the licensing objective of the prevention of public nuisance and we regret to inform you that we are fully objecting to your application.
