27 Apologies For Absence

There were no apologies for absence.

28 Minutes - 7th September 2015

RESOLVED – That the minutes of the meeting held on 7th September 2015 be approved as a correct record.

29 Open Forum

In accordance with the Community Committee Procedure Rules, the Chair allowed a period of up to 10 minutes for members of the public to make representations or ask questions on matters within the terms of reference of the Community Committee.

On this occasion no members of the public were present.

30 Outer North West CCTV Report

An officer from Leeds Watch presented a report to Committee which outlined the effectiveness of the 14 cameras, serving the Outer North West Community Committee area. The report provided:

- An analysis of crime and anti-social behaviour by Ward, with CCTV camera locations;
- The different types of incidents and arrests captured by CCTV
 Operators in 'real time', including a focus on the monthly occurrence of
 incidents: and
- Information on the current costs for all CCTV cameras in the Committee area.

The report focused on the period April 2015 – end October 2015.

Members discussed the report in detail, issues included;

Whether Leeds Watch cameras could be used to prosecute car users observed committing a driving offence, such as driving down a one way street. The legality of using cameras for motoring offences was considered and it was agreed that this needed to be reviewed.

Members suggested that businesses which routinely rely on the cameras to operate safely should be asked to contribute to the costs of operating and maintaining them.

Members considered the funding of cameras and how this had evolved and changed over the years. Members felt that the cost of the cameras was high.

The Committee considered that cameras provide a deterrent, however they noted that this is something that could not be quantified.

Members requested an additional meeting of the Environment & Community Safety Sub Group be convened to discuss the usage of Leeds Watch CCTV in detail.

RESOLVED – The Committee resolved to:

- (a) Note the contents of the report; and
- (b) Request that an additional meeting of the Environment & Community Safety Sub Group be convened to review the usage of Leeds Watch CCTV in detail and to report findings back to the Committee at the earliest opportunity.

31 Environmental Services - Service Agreement for 2015/16

The Locality Manager, Environmental Action Service presented a report for approval on the new Service Agreement between the Committee and the Environmental Action Service to help maintain clean and tidy neighbourhoods across the Outer North West area.

The proposed framework had been discussed at the Committee's Environmental Sub Group, with a recommendation made to approve the

Service Agreement and that the plans on a page for each ward, be further developed through meetings with ward Members, which the sub group can then oversee on behalf of the Committee.

Members discussed the collection of bulky items and sought assurance that all bulky items would be collected. It was confirmed that all council owned properties had arrangements in place to ensure bulky waste was collected.

Clarification was sought that Carlton formed part of Otley for the purposes of the shift work undertaken by Environmental Services.

It was confirmed to Members that gulleys were cleared every 5 years on a rota basis but that in addition work is also undertaken reactively when required.

Members were assured that funding had been secured to cover the additional functions that have come into the Locality Team.

The Committee thanked the Locality Manager for the excellent service that his team provides.

RESOLVED - The Committee resolved to:

- (a) Approve the attached Service Agreement for the 2015/16 municipal year; and
- (b) Delegate the responsibility to oversee the development and delivery of the Agreement and the associated "plans on a page" to the Environmental Sub Group, with input through ward member and subgroup meetings.

32 Outer North West Finance Update Report

The Outer North West Area Leader submitted a report which provided members with an update on the budget position for the Wellbeing fund for 2015/16. The report also shows the current position of the Small Grants and skips pots and provides an update on the Youth Activity Fund. Members were also provided with details of the current monitoring position of the Wellbeing fund and the Youth Activity Fund.

Members discussed the allocation of PCSOs for each ward of the Outer North West area. It was confirmed that Horsforth gets 6 full time PCSOs and that 20% of the cost of PCSOs is funded by Leeds City Council the other 80% coming from West Yorkshire Police.

In discussing the Youth Activity Fund Members requested that that monitoring information from groups who have received funding should be returned as soon as possible

Members also noted that most activities appeared to take place in the summer with very few activities taking place in the winter months. The

Committee requested that the Children's Services and Family Health Sub Group look into this.

Following questions from Members about the public perception of crime in the area, Inspector Brady commented that the public had confidence in the Police keeping control of crime in the Outer North West area of the City.

Adult Social Care, Health & Well-Being

Councillor G Latty updated the Committee on the success of a mobile phone "App" which is being developed be Leeds City Council, to identify members of the community who are socially isolated. The suggestion came from a social isolation workshop, held by the Outer North West Community Committee.

Wharfedale Greenway

Purpose of report

 The attached report of the Wharfedale Greenway Steering Group, seeks the support of the Outer North West Community Committee for the principle of a Wharfedale Greenway to run between Pool-in-Wharfedale, Otley, Menston and Burley-in-Wharfedale.

Main issues

- 2. In 2010 the Wharfedale Greenway Feasibility Study was prepared by Sustrans for Otley Town Council. The study highlighted an opportunity to create a series of greenways along extant sections of the former Arthington to Burley-in-Wharfedale railway and to provide primary walk and cycle routes to Menston and Burley railway stations.
- 3. In 2013 the Wharfedale Greenway Steering Group was formed. The steering group decided to follow the recommendations of the 2010 report and put forward the old railway corridor, to be named the Wharfedale Greenway, as the proposed route. Key actions for the steering group include securing support for the project from both Leeds City Council and Bradford Metropolitan District Council through written 'in-principle' agreement.

Recommendations

4. The Outer North West Community Committee is asked to support in principle the proposal for a Wharfedale Greenway.



Wharfedale Greenway - Briefing Note

The Wharfedale Greenway Steering Group seeks the support of the Outer North West Community Committee for the principle of a Wharfedale Greenway to run between Pool-in-Wharfedale, Otley, Menston and Burley-in-Wharfedale.

Greenways can come in many forms and may originate from disused railways, farm tracks or bridleways and are intended for pedestrians, cyclists, wheelchair and pushchair users and usually horse riders. They encourage physical activity by providing attractive traffic free connections between towns, villages and neighbourhoods and are popular for both commuting and leisure journeys and particularly suitable for less confident cyclists and family groups. Where possible, Greenways have a level gradient and a surface suitable for all year use.

A Wharfedale Greenway Feasibility Study was prepared by Sustrans in 2010 for Otley Town Council. This study highlighted the opportunity to create a series of greenways along extant sections of the former Arthington to Burley-in-Wharfedale railway (closed in 1965) and to provide primary walk/cycle routes to Menston and Burley railway stations.

In 2013, the Wharfedale Greenway Steering Group was formed involving Otley Town Council, Burley-in-Wharfedale Parish Council, Menston Parish Council, Pool-in-Wharfedale Parish Council, Bradford Metropolitan District Council, Leeds City Council and Sustrans. There was a desire and objective to see a safe walking and cycling route that would link all these parishes and Wharfedale communities together. It was decided to follow the recommendations of the 2010 report and put forward the old railway corridor, to be named the Wharfedale Greenway, as the proposed route.

The Steering Group commissioned a public consultation on the proposals in 2014 which found that the vast majority of people are in favour of the Greenway. The consultation also highlighted the lack of suitable routes for horse riders in the area and it was decided that the Greenway should be open to them.

The four parishes alongside the two principal authorities have been working with Sustrans on the preparation of an ecology survey and initial negotiations with land owners to establish heads of terms.

A key issue is securing support for the project from both Leeds City Council and Bradford Metropolitan District Council through written 'in-principle' agreement, and to protect the line of the route and make available their land ownerships along the former railway for the Greenway. Formal approvals for funding will be separately pursued. There is an opportunity for both principal authorities to use their land ownerships as 'demonstration projects' to stimulate the entire scheme.

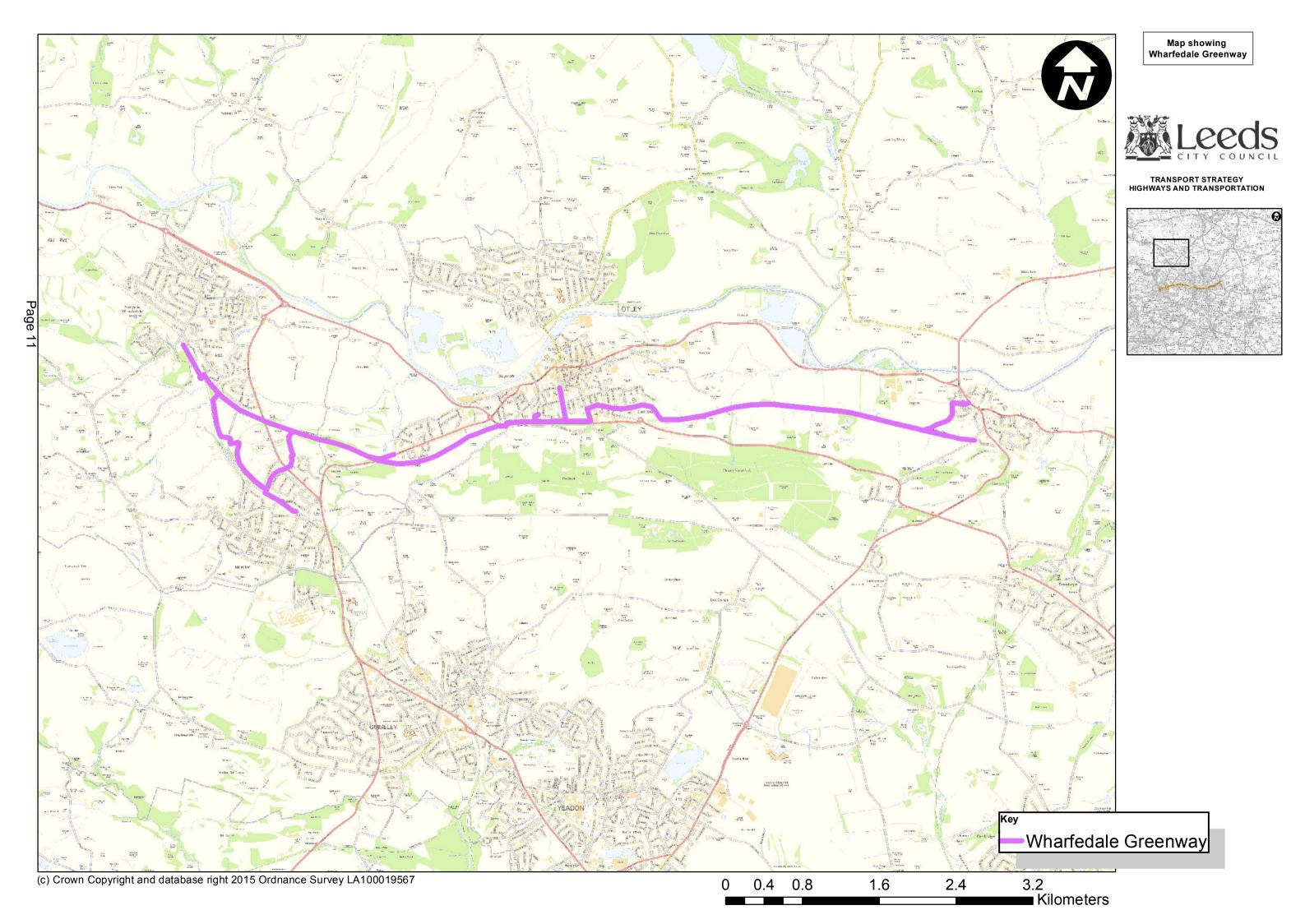
Bradford Metropolitan District Council has confirmed their 'in-principle' support and offered to gift necessary land to Burley-in-Wharfedale Parish Council.

Outer North West Finance Update Report

For Decision

Purpose of report

 This report provides the Community Committee with an update on the budget position for the Wellbeing fund for 2015/16. The report also shows the current position of the Small Grants and skips pots and provides an update on the Youth Activity Fund.

Main Issues

- 2. Community Committees have a delegated responsibility for the allocation of area Wellbeing funding. The amount of Wellbeing funding provided to each committee is calculated using a formula agreed by Council taking into consideration both population and deprivation of an area.
- 3. The Outer North West Community Committee operates a pre-sift process for Wellbeing fund applications. This involves discussions with appropriate ward members for that particular project, in the context of the current area priorities. Where projects do not have support from all three ward members, they are not progressed. All applicants are offered further discussions and feedback if helpful. In order to provide further assurance and transparency to all applicants, where schemes do not garner support these will be reported to a subsequent Community Committee meeting for noting.
- 4. At the June meeting Members were advised of the revenue wellbeing allocation for the Outer North West Community Committee of £127,450 for the financial year 2015/16. The Community Committee have previously agreed that this allocation is split equally by the 4 wards (£31,862 per ward)
- 5. After deducting any existing commitments and taking account of the 2014/15 carry forward position, the Community Committee has £96,231 funding available for allocation. This figure does not include the Youth Activity fund still available to spend.

Wellbeing Budget Statement 2015/16

- 6. The latest Wellbeing Budget Statement for 2015/16 is included at Appendix 1 to this report. This sets out the Wellbeing allocation for 2015/16 and includes carry forward from 2014/15. The Wellbeing budget statement also outlines the current budget position of those projects funded in previous years which still have funding left to spend.
- 7. Table 1 below includes details per ward of the total revenue available for allocation in 2015/16 including carry-forward from previous years and amounts for projects which did not spend the full amount approved, the total amount committed this financial year and the amount of Wellbeing currently available to spend per ward.

- 10. Horsforth CCTV 2015/16

Delivery Organisation: Leedswatch

Amount requested: £2,103

Funding is to cover 50% of the revenue costs of the monitoring and maintenance of one CCTV camera at Old Ball roundabout in Horsforth in 2015/16. This camera is part of a wider network of public space CCTV in Horsforth district centre.

11. Otley & Yeadon CCTV 2015/16

Delivery Organisation: Leedswatch

Amount requested: £18,305

Funding is to cover part of the revenue costs of the monitoring and maintenance of 5 CCTV cameras in Otley, located on Kirkgate, Manor Square, Boroughgate, Cross Green and Market Street, and 3 CCTV cameras all located on Yeadon High Street.

12. Site-based Gardener 2016/17

Delivery Organisation: Parks & Countryside

Amount requested: £12,244 (G&R - £6,949; O&Y- £5,295)

Funding will pay for one site-based gardener to work a five day, 37 hour week for 6 months of the year across various locations in the two wards. The gardener will work for three days per week (21 hours) within Guiseley and Rawdon and two days per week (16 hours) within Yeadon.

13. Mothers of Otley

Delivery Organisation: Mothers of Otley Amount requested: £2,305 (Otley & Yeadon)

Funding is requested to support a mothers group held at the Children's Centre to deliver holistic support for women within a safe and confidential environment. The funding is to pay for agency crèche workers who will provide a safe space for children and thereby enable the mothers to fully access group sessions.

14. Aireborough Supported Activities Scheme

Delivery Organisation: Aireborough Supported Activities Scheme

Amount requested: £6,766

Funding is requested to run summer holiday play schemes for children 4-19 years with moderate to severe learning and/or physical disabilities that live in the north west area of Leeds. The project aims to enhance the lives of children with disabilities by providing them with fun leisure time activities and opportunities to socialise with friends. Many children require one to one and some two to one support in order for them to access activities.

The amount requested for each ward is based on a breakdown of the numbers of children living there: Guiseley & Rawdon £4,159; Otley & Yeadon £1,286; Adel & Wharfedale £1,151 and Horsforth £170. The Inner North West Community Committee has also been asked to contribute £1,622 and the Inner West Community Committee £811.

Youth Activity Funding

- 15. The 2015/16 budget for the Outer North West Youth Activity Fund includes the allocation of £56,470 for the current year and a £1,386 underspend from 2014/15.
- 16. This fund is to commission sports and cultural activities for young people age 8 17 and should be allocated with the involvement and participation of children and young people. Following the commissioning process the community committee has £4,568 of Youth Activity Funding remaining to allocate.

Wellbeing Budget – Small Grants & Skips

- 17. Table 2 below provides details of the small grants which have been approved this financial year. There is £9,837 still available for allocation to small grants.
- 18. Adel & Wharfedale Members have agreed a further £3,000 from their large grant allocation into the small grants budget.

24. In 2012, the Community Committee approved an interest free capital loan of £5,000 to Yeadon Cricket Club, repayable over 4 years. To date £3,750 has been repaid and is reflected in the above table. The final instalment of £1,250 is due in February 2016.

Community Committee Update Report

Purpose of report

- This report updates the Community Committee on the work of the sub groups of the Committee: Environment & Community Safety; Employment, Learning and the Local Economy; Children's Services and Family Health; Adult Social Care, Health & Wellbeing; Highways & Transportation and Policy.
- 2. The report also updates the Community Committee on community forums and partnership working that has taken place in the area since the last meeting.

Main issues

3. The Outer North West Community Committee has a range of sub groups which set priorities, agree topics for consideration at Community Committee and develop action plans to address issues of thematic importance. The committee currently operates six sub groups: Environment & Community Safety; Employment, Learning and the Local Economy; Children's Services and Family Health; Adult Social Care, Health & Wellbeing; Highways & Transportation and Policy.

4. Environment & Community Safety

Community Safety

- 5. At its last meeting the sub group considered feedback from the recent Road Safety workshop. A number of actions are being explored, including a Community Speed Watch Awareness Scheme and also an information leaflet detailing who to contact regarding road safety matters.
- 6. Leeds Anti-social Behaviour (LASBAT), Housing Leeds and the Community Safety Co-ordinator also provided updates on their respective services.

7. On the 6th January there was a special meeting of the Community Safety sub group which was open to all outer north west elected members. The meeting was to discuss CCTV matters in the outer north west area with officers from Leeds Watch and Legal Services in attendance. It was agreed that the 2015/16 CCTV charges for Horsforth, Otley and Yeadon be included in the finance report to be discussed at the next Community Committee.

Environment

- 8. The Environment sub group met on 15th December, the Highways Operations Manager provided an update on the winter maintenance programme for the area and the Locality Team gave details of their current work programme. The group was informed that the most recent activity has focused on street cleaning following the recent flooding in Otley and de-leafing.
- 10. A representative from Otley Town Council presented information on the Wharfedale Greenway project. The proposed project would provide a greenway from Pool-in-Wharfedale through Otley, Menston and into Burley-in-Wharfedale. The sub group agreed to refer this item to the Community Committee for further discussion.

Policy

- 11. The Policy sub group met on 7th January and members agreed to adopt an action tracker for use by each sub group with actions agreed by the relevant group in conjunction with the thematic lead officers. Members also agreed that separate action trackers be considered by each sub group.
- 12. A discussion took place on future Community Committee meetings and it was proposed that a total of four community committees be held in 2016/17 in addition to the Election of Chair meeting and that additional workshops be held on matters agreed by the sub groups.
- 13. Regarding the work of sub groups, the Policy sub group recognised the importance of a workshop or event to look at the surface access strategy and wider transport links to Leeds Bradford Airport and asked that the Chair of the Transport sub group be approached to consider this as soon as possible.
- 14. Citizens@Guiseley & Rawdon Forum
- 15. The forum met on the 25th November to discuss a number of local issues including parking and road traffic problems and an officer from Highways has been asked to attend the next meeting in January to address these concerns.
- 16. Citizens@Yeadon Forum
- 17. The forum met on the 7th December and received a presentation from the Head of Transportation for Leeds on the proposals for a link road to Leeds Bradford Airport. The forum members were asked for their views and these will be fed into the consultation report. The Neighbourhood Policing Team was also in attendance and gave a brief report on recent crime figures in the area.

Conclusions

18. The Outer North West Community Committee sub groups provide the committee with the opportunity to consider information on key areas of work in partnership with officers and community organisations, as well as enabling direct links to be established with the Community Champions and Executive Board Members.
