Summary of main issues

This is an application for the grant of a premises licence, made by Mr Adnan Ali Ahmad, for Potraviny 9 Town Street, Armley, Leeds, LS12 1UG.

The applicant is applying for sale of alcohol for consumption off the premises, Everyday 08:00 – 22:00.

Responsible authorities and Ward Members have been notified of this application.

The application has attracted representations from other persons.

Please note that although this area isn't covered by a Cumulative Impact Policy there are plans to make it so in the very near future.

1 Purpose of this report

- 1.1 To advise Members of an application made under section 17 of the Licensing Act 2003 ("the Act") for a new premises licence in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of representations.

2 History of the premises

2.1 This is the first application for a premises licence for these premises.

3 The application

- 3.1 The applicant's name is Mr Ahmad Adnan Ali
- 3.2 The proposed designated premises supervisor is Mr Ahmad Adnan Ali
- 3.3 In summary the application is for:

Sale by retail of alcohol – Everyday 08:00 – 22:00

Non standard timings

No non-standard timings for bank holidays or special occasions are proposed.

4 The operating schedule

4.1 The applicant proposes to promote the licensing objectives by taking the steps identified in the operating schedule and/or the proforma risk assessment which is attached at Appendix A.

5 Location

5.1 A map which identifies the location of this premises is attached at Appendix B.

6 Representations

6.1 Under the Act representations can be received from responsible authorities or other persons. Representations must be relevant and, in the case of another person, must not be frivolous or vexatious.

- The application has attracted representation from members of the public (described as 'other persons' in the legislation).
- 6.3 The licensing authority is in receipt of ten individual letters of objection all of which are opposed to this application on the grounds of public nuisance and crime and disorder.

In order to protect personal data, redacted copies of the representations are attached at Appendix C. Unredacted copies will be available at the hearing for Members consideration.

7 Local Licensing Guidance

7.1 This application is in an area where the council has put in place Local Licensing Guidance. This means that the area in which this premises is situated have been identified by the Community Committees as vulnerable to problem drinking and there are additional issues that directly impact the promotion of the licensing objectives. The applicant has been sent the Local Licensing Guidance during the application process and has/has not volunteered conditions to mitigate these concerns. The Local Licensing Guidance is attached at Appendix D.

8 Licensing hours

- 8.1 Members are directed to paragraphs 6.8 to 6.15 of the Statement of Licensing Policy which states the criteria that will be applied to any decision for new applications or variations which include extending hours.
- 8.2 In brief the Policy states at 6.14 that restrictions may be made to the proposed hours of use where, after receiving relevant representations, the council considers it appropriate for the promotion of the licensing objectives to do so.
- 8.3 The council will take into account the existing pattern of licensed premises in an area when considering what is appropriate to promote the objectives. Applications which are significantly out of character for a locality will need to demonstrate that granting the hours sought will not impact on the licensing objectives, given the potential for neighbouring premises to seek the same additional hours to prevent rivals gaining a commercial advantage.
- A list of premises in the local area and their licensed hours and activities is provided at Appendix E.

9 Equality and diversity implications

9.1 At the time of writing this report there were no implications for equality and diversity. Any decision taken by the licensing subcommittee will be in accordance with the four licensing objectives as prescribed by the Licensing Act 2003.

10 Options available to Members

- The licensing subcommittee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
 - Grant the application as requested.
 - Grant the application whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
 - Exclude any licensable activities to which the application relates.
 - Refuse to specify the said person as the designated premises supervisor.
 - Reject the whole or part of the application.

10.2 Members of the licensing subcommittee are asked to note that they may not reject the whole or part of the application merely because they consider it desirable to do so. It must be appropriate in order to promote the licensing objectives.

M Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 9)

A suitable Closed-Circuit Television (CCTV) system will be operational at the premises at all times when licensable activities are being carried out and at any other times where members of the public are present on the premises. The CCTV system will cover the main entrance/s and exit/s. The CCTV system will contain the correct time and date stamp information. The CCTV system will have sufficient storage retention capacity for a minimum of 31 days' continuous footage which will be of good quality. A designated member / members of staff at the premises will be authorised to access the CCTV footage and be conversant with operating the CCTV system.

All images to be made available within a reasonable time on request to authorised officers of the Licensing Authority. The premises are secured with roller shutters at the front and a heavy metal security door at the rear. An additional CCTV camera has been installed outside the premises.

b) The prevention of crime and disorder

Spirits of high ABV will be sold behind the counter.

When the DPS is not on duty a contact telephone number will be available at all times.

Records of incidents will be recorded in an Incident log and retained on the premises for 12 months. The Incident Report Register will contain consecutively numbered pages, the date time and location of the incident, details of the nature of the incident, the names and registration numbers of any door staff involved or to whom the incident was reported, the names and personal licence numbers (if any) of any other staff involved or to whom the incident was reported, the names and numbers of any police officers attending, the police incident and / or crime number, names and addresses of any witnesses and confirmation of whether there is CCTV footage of the incident. The premises will operate and record all Incidents of criminal activities, anti-social behaviour and injuries to persons using the following Compliance log books Customer Refusal, Authorisation of Alcohol, ID Signature to assist the police and authorities in carrying out their investigations. All log books are fit for purpose and will be retained on the premises for 12 months.



I am concerned that if the premises open until 2am this will cause a nuisance to me and other residents of the street.

I am a local councillor in Armley. For several years we have been blighted by the scourge of street drinking. This problem has increased in line with the rise in numbers of off licenses on Town Street and surrounding streets. The establishment of a 24 hour off license last year has increased the problem substantially but the large number of licensed premises is a major issue across the board. The police are seeking the closure of the 24 hour business and are in constant communication with the licensee because of the nuisance his shop creates to Town Street residents/shoppers. It is not just this business though, there are many off licenses on Town Street selling to street drinkers who go on to cause alarm, harassment and distress.

There is currently consideration of a Cumulative Impact Policy being applied to Town Street which hundreds of local people have contributed to.

Armley councillors and MP have worked with police and ASB to drive out these drinkers as the DPPO we fought so hard to get 5 years ago has not worked. We successfully went to court to get injunctions for the 5 worst offenders but there are many more drinkers than this and the presence of yet more off licenses only exacerbates the misery for my constituents and businesses on Town Street. Armley councilors have done several street stalls, throughout 2015/16. We spoke to 100s of people and shop keepers and all of them agreed that Town Street was a scary place to live/work/shop. Many men said their wives were too frightened to shop alone on Town Street. Older people spoke of their fear of shopping around drinkers and 2 people described crimes including robbery they had witnessed from their flats overlooking Town Street. One person said he saw the drinkers buying alcohol through the night in the 24 hour off license, he saw men urinating and defecating on the streets and he said they slept at the back of Town Street. 600 people completed a survey about their experience of Town Street attached which universally blamed drinking and easy access to alcohol for much of the deterioration on Town Street.

and she said her female colleagues and she will not use the bus stop outside the Co-op Supermarket because of the drinkers frightening them. My othe sister who lives in Armley and is disabled has stopped shopping on Town street for the same reason. Armley Helping Hands, a local charity working with older people in Armley now transports older people to Morrison's at Middleton to shop as Town Street is too scary.

Businesses have complained in their droves and have even been to the Armley Forum to ask for the seating on Town Street to be removed as drinkers gather there and intimidate shoppers. The owner of the electronic cigarette shop said his business was decimated by the drinkers. The owner of Athlone House, Gudrun Shemilt of GS properties tells me her tenants are leaving as they regularly see men urinating and defecating at the back of the shops and they are intimidated by them and are frightened to walk home after dark. The owner of the Copper Lamp café reported she sees men exposing themselves to her and her staff and regularly raid her bins and throw rubbish onto Town Street. This puts her food business in jeopardy.

I cannot tell you what support we have had from local people and business for our stance to cut down o drinking on Town Street and the allowing of this license would be a kick in the teeth for local democracy and the people working hard to stop the ASB and crime/grime on Town Street. We need to take a stand and this will be a great first step.

I have 2 small children. I avoid Armley Town Street as much as I feasibly can because it is dirty and there are too many people displaying anti social behaviour. I don't want my children to see this. The last time we went a man was lying down on the street, drunk on the compass (on the pavement) and my llittle boy wanted to know why. I dont want my children to see this, or to live in an area where people do not respect the area.

I visited, frequently at armley town street, but ceased going last year, I was becoming more and more nervous of going I saw frequent fights, in the street and (to me) what seemed to be gangs of men drinking cans of alchol and watching shoppers go by. I felt I was becoming a target and felt at risk of getting harrased and possibly even getting hurt, by these men, I used to go to stocks day centre but the travelling of getting there used to make me feel so much worser, so Now I don't attend anymore. I feel for the people who are trying to make Armley town street a better experience for people because it wout be an easy thing to do. Sadly I personally don't think it will ever get any better, and i feel Bramley, shopping centre will become the next target for the same sort of problems.

The drunks on armley Moor early in the morning are intimidating even my 3 year old doesn't like walking past to nursery.

see people drinking in the street, hanging around in groups that you have to walk through as they wont move, its very intimidating, so dont use town street as often now, they even hang around near the cash points too....

The area has become run down and I feel unsafe going there due to groups of adults congregating on the streets which is intimidating. Few shops now worth visiting. Armless used to be a great vibrant hub of retail opportunities and community spirit but not anymore on town street its grubby and seedy

I don't feel safe any more, going back 20 yrs ago I wouldn't of thought twice walking through Armley Town Street. It is a shame.

Armley used to be a lovely place for shopping and taking children for a day out. Now it is unclean untidy and a down right disappointment. I wish i could go to Armley library without feeling threatened, or my mother telling me to stay in the car in case of an emergency.

Armely town street used to be s thriving area where I could shop and buy all my groceries now I feel unsafe shopping there due to the high amount of people drunk on the street and people openly smoking drugs .., totally unsafe for all ages .. It's disgraceful that the street is not policed properly

Over the last few years the area has become run down with little consideration given to the type of shops available. I do not use Armley Town Street at all at any time of the day or night, it's unsafe. I use Wilkinsons and travel by car. It's extraordinary how many takeaways, cash converter type shops and polish food shops are all in one place. Diverse, ethnic shopping is great and I believe adds to the local community the same cannot be said for the vagrants and drunken behaviour that has seriously damaged the area and it's reputation. Having lived in this area all my life I feel that something must be done before the area becomes a ghetto. I am consider Armley when just a short drive away are the thriving areas of Horsforth & Pudsey. My mother who is in her late 70's has been mugged & robbed in the area that she has used for over 40 years. Something must be done before the situation ascalator excellent.

Town street is sometimes a frightening place to come now, putting me off shopping there

Town street just seems 'tired' there's not a lot there apart from food stores, charity shops and cash convertor style stores

I have lived in Armley for 9 years. I feel Armley town street could be better. There are often lots of people hanging around, maybe being bored and it can feel intimidating, although nothing has ever happened to me. There are too many betting shops and cashconverters. I would perhaps be interested in a meeting for local people but I am away from Armley for a year. My house is rented out and I have friends in Armley so am interested in how the area is going to be redeveloped. There are lots of HMOs being built, even one near my home on Hall Lane with residents who cause problems such as using air rifles and being rude to people who have lived there a long time. Armley could be a lot more inviting. I use the wilkos a lot and walk to town on the canal. But recently there have been attacks there which has unfortunately made it feel very unsafe.

Drinking and drug dealing the main problem i no longer go with my children

We work at Armley you walk out of work everyday to seeing someone drunk disorderly and urinating on the streets and you see everyone on show its disgusting. You can hear the drunks shouting at each other and people who walk by them who do nothing wrong. They ask to borrow cigarettes etc and people are feeling obliged to give them due to the fact they daren't say no in case. It's not safe anymore.

Town street has become a gathering for drunks i used to love going shopping but now i wont and especially not alone

I regularly go down armless townstreet as my doctors is there and I also collect my niece from a nursery in the doctors. I'm a young woman and many of times I have seen people with cans of alcohol in their hands. It can make me feel so uncomfortable as it could be 12 in the afternoon. With a little toddler it can be quite off putting to go any further into armley due to this problem.

There is too many drunks congregating on armley town street i live on wesley road and i see them a lot at the back of the chapel and they're all over town street whenever i go to the shop.

too many people loitering on the streets, drinking, causing nuisance, littering,

What happened about the Armley Carr Crofts supermarket? This would have helped improve the area. Also what's happening with the Mikes Carpets (MC Carpets) building? This eye sore also puts off shoppers and future investment. in the area.

I have lived in armley best part of my 26 years and it has gone so down hill since I was young and now im bringing my kids up round here I am considering a move as I dont think its a suitable place to bring my kids up unless it is sorted out!

i am a new buisness on armley town street and already had my signd ripped down twice and also had customers not call into my shop becuse of the drunks that are all over it.

needs more traditional shops, greengrocer, butchers etc and less bookmakers, charity shops and 'international' foodstores.

Another premises would increase competition driving prices lower and increase the availability of alcohol directly within a DPP. 4:16 PM on 22 Apr 2016 I strongly object to this application because I believe iit fails to comply with licensing objectives The Prevention of Crime and Disorder - this new licence will add to the problems of crime and disorder in Armley, already recognised by our MP, councillors and police who, are working with residents and businesses to reduce alcohol-related crime, including shoplifting and anti social behaviour. • The Prevention of Public Nuisance - we already have a proliferation of off licences in a small shopping centre, making it very easy to buy alcohol and drink it on the street. The public nuisance causd by street drinking is bad enough without yet another off licence which would make a bad situation worse. • Public Safety - see above, as a resident of Armley I find Street drinking and easy access to alcohol means that I do not feel safe in my own neighbourhood, particularly if walking along Town Street in the evening. • The Protection of Children from Harm - anti social behaviour by adults can put children at harm. We want to see Armley grow as a friendly, inclusive community where all ages feel safe. We already have far too many off licences in Armeley, affecting the quality of life for all of us ho live here. We hope to see

improvements through a Cumulative Impact Plan. But,in the meantime, I would urge this application, to be rejected on the grounds outlined above and especially in the interests of preventing crime, disorder and public nuisance. I have the same objections to this licence as for the application submitted by Fresh Metro for 90, Town Street.. The fact that two bew applications for off licences have been submitted underlines my point that there are already too many and any more seriously damages public safety.

I strongly object to another off-license opening in an area covered by a Designated Public Place Order (DPPO), which has already proved difficult to enforce effectively.

At last count, there are ten premises selling alcohol in the immediate vicinity of the application, which includes Branch Road and the shopping precinct in Armley Town Street. I have had many constituents contact me about their concerns of how the recent increase of premises licenced to sell alcohol has led to a rise in anti-social behaviour.

We are on the cusp of having a Cumulative Impact Policy implemented on the area covering the DPPO around Armley Town Street and any decision to approve the off-license would be incompatible with the ethos behind why such a scheme is going to be introduced into Armley in the first place.

In fact, the survey that I launched last summer to consult with local residents about Armley Town Street, which had over 600 responses, has been used as evidence for the Cumulative Impact Policy consultation. The consultation had a response of 156 local people. Residents overwhelmingly felt that street drinking was out of control and members of the panel only need to refer to these documents, used by Council officers, to understand the extent of the problem and concern.

Meanwhile, the local police team work tirelessly to enforce the DPPO with limited resources and increasing pressure to get results.

Furthermore, I support the hard work being carried out by local organisations, such as BARCA, that are trying to help habitual street drinkers seek the help they need in order to change their lives. Another off-licence in this area will be harmful to the welfare of my constituents.

Another off-license will, without doubt, undermine the efforts that are being made by the people, who are working incredibly hard, to tackle the chronic problem of alcohol abuse and anti-social behaviour on Armley Town Street, which is giving the whole of Armley a poor reputation.

The Cumulative Impact Policy is due to be approved by the Licensing Panel on May 10th. I find it perverse that the panel are required to make a decision on two off-license applications so shortly before making a substantial decision on recommending a Cumulative Impact Policy for Armley. I, again, call on Leeds City Council to delay both hearings until the Cumulative Impact Policy is in place.

Either way, a decision to approve this application would be deplorable to myself and the constituents I represent. I urge the panel to reject this application.

Applications for new alcohol licenses in Armley

Cllr James McKenna, Chair of the Armley Community Forum has asked me to write to you on behalf of the forum members to object to the two most recent applications for alcohol premises licenses in Armley:

PREM/03760/001 Potraviny, 9 Town Street

The Armley Community Forum is a public meeting attended by 25-35 local residents each month. At every meeting, residents complain about alcohol related anti-social behaviour, particularly around street drinking during the daytime. Despite the DPPO and additional police patrols, street drinking remains a serious issue in the town and is putting people off visiting Town Street as they feel threatened and vulnerable. Over the page I have included extracts from previous minutes to demonstrate the strength of feeling on this issue.

At the meeting on 19th April, members of the forum were advised of two new applications and the Chair asked me to write to you on behalf of the residents to object to the applications based on the negative impact on the town.

- a) Persistent anti-social drunken behaviour on Town Street
- b) Evidence of human waste and other litter in places where street drinkers congregate
- c) The existence of a high number of licensed establishments already selling alcohol on Town Street.
- d) The overwhelming support for the proposed Cumulative Impact Policy demonstrated by the large number of responses to the consultation.

Last year, MP Rachel Reeves co-ordinated a survey of local residents about Town Street. 648 responses were received which highlighted the following issues:

When do you use Armley Town Street?

DAYTIME - 73%

EVENING - 24%

WEEKDAYS - 67%

WEEKEND - 44%

Extracts from Armley Forum Meeting minutes:

April 2016

Q: Individuals with injunctions for street drinking are seen regularly consuming alcohol.

A: The police need statements from the public. Street drinking has reduced by 80%, but it is still difficult to eradicate. Police have limited numbers of officers who patrol when they can, but they need the Courts to support action on injunctions.

January 2016

Officers from trading standards carried out test purchasing on Town Street and three premises failed. One owner is being taken to court and two others received cautions.

Officers are still focused on street drinking, and although the weather has lessened the problems, the police are in the process of applying for two further injunctions on persistent offenders. Out of the existing six injunctions, four are not from the area and have not returned, and two are frequently breeching the order. The police are looking to take them to court, but the injunction does not carry the power of arrest.

September 2015

PCSO Stuart Knowles updated the meeting on ongoing pieces of work, recent activities include:

DPPO – Injunctions to 7 repeat offenders were granted on 17th September. All individuals understand where they can and cannot go and there were 3 arrests in the first couple of weeks with people breaching the injunction. More injunctions are in the pipeline so the overall number will increase. They remain in place for a period of 2 years. Most of the individuals are alcoholics and have been offered help from outside agencies. (NB. Since the injunctions have been in place there have been daily breeches recorded by residents.)

July 2015

Q: As a shop owner on Town Street, the street drinkers are putting people off entering my business. Could the benches outside William Hill be removed?

A: The police acknowledge that this is one of the few businesses that filled in a diary which is very helpful. Cllr McKenna and Cllr Lowe hold the view that the benches are important for older people and were installed following requests from residents. A vote was taken to ascertain whether people thought they should be removed and around two thirds of those at the meeting voted to keep them.

Councillors advised that they will continue to work with the police to keep this issue as a priority and re-iterated the officer's plea for more residents and businesses to make statements.

May 2015

PC Davey welcomed questions from the floor:

Q: Street drinking is still a problem on Town Street and around the back streets, sometimes they are there before 8am.

A: The police and partners are still working on securing injunctions for the worst offenders. The police can only take enforcement action when the law is being broken. If they drink alcohol in the DPPO alcohol control zone on Town Street, their drink will be confiscated. One of the issues around securing the injunction is the lack of statements from the public and business owners.

Cllr McKenna advised that the Councillors through the Community Committee have given funding for an alcohol outreach project and asked for an increased police presence.

February 2015

Police and partners will be putting a lot of work into enforcing the Armley Designated Public Place Order (DPPO) to stop street drinking in the area. Five or six of the main drinkers will be targeted; shops have been given diaries and asked to copplete been over a six week period. It is hoped that the evidence gathered from these diaries can then be used to try and seek an injunction against the main protagonists.

I am writing on behalf of the Armley Tasking partnership meeting which consists of a wide range of partners from the local Neighbourhood Police Officers, Environmental Services, Youth offending Service, Housing, Health, Fire Service, Leeds Anti-social Behaviour Team, Children's Service Cluster, and Safer Leeds. This is in respect of the 2 new applications off licence premises on Armley Town Street and in particular the impact of 2 new premises on the grounds of alcohol related incidents of crime and anti-social behaviour. These comments relate to both applicants for:

Potraviny, 9 Town Street, Armley, Leeds, LS12 1UG,

I would also like to state that the partnership have been working with Licencing, police, health and BARCA and Forward Leeds to address local concerns from business, the local community, and local Clirs and MPs. Part of the work has been tackling an increase in Street drinking and ASB behaviour and domestic Violence of which is linked to alcohol.

Armley has been chosen as one of the Cities Break Through project areas for Domestic Violence and Abuse due to the high incidents in the area, some of which has been linked to alcohol.

In relation to ASB/street drinking, there are a number of injunctions (7) to ban the main drinkers from consuming alcohol on Armley Town Street. There has been some positive outcomes to these actions which include a decrease in the number of street drinkers and ASB associated with this and encourage support through work with BARCA and Forward Leeds. Part of the work has also to develop a Cumulative Impact policy for Armley Town street so that careful consideration can be given to any new applications for off licence premises in the Armley Town Street area. Armley Town street already has a high concentration of Licence premises (11) to date and over the past 12 months there have been increased incidents of anti-social behaviour associated with the consumption of alcohol. There are concerns from the partnership that more off licence premises in this location, increases what is already a saturated market, and we believe will further encourage more alcohol sales which in turn may lead to further increases of ASB incidents. This area also has a Designated Public Places Order in place which allows police officers to confiscate alcohol from people who are behaving in a disorderly manner and this is enforced by the local Neighbourhood Policing Team. This has its challenges for the Neighbourhood Police Team to manage the DPPO area, given resent changes to the police structure and demands on services. Any increase in licenced premises on Armley Town Street we feel, would exasperate tensions between the local businesses, community and street Page 23 drinkers.



Drinkers congregate on street corners and outside the shops at all times of the day (and night) in varying states of drunkenness. Drink related disorder is already rife, with the police regularly being called out to deal with the same. Secondly, it will do nothing to improve the image problem that Town Street already has. Thirdly, there are far too many off licences on the street already. The space would be much better utilised by a different type of independent business. If Armley is to attract investment and/or gentrify in any meaningful way, it will not be achieved by a street full of supermarkets and off

licences.



Local Licensing Guidance

Inner West



You have been sent this guidance note because you have, or are considering, making an application for a licence to sell alcohol or provide late night refreshment in the inner west Leeds area.

This information is provided to anyone applying for a licence to sell alcohol or provide late night refreshment in LS12. It may be used to by residents or other interested people who make a representation against an application. It will be provided to the Licensing Subcommittee at any subsequent licensing hearing.

Why have you been sent this information?

Under the Licensing Act 2003 you are required to complete an 'operating schedule'. You are expected to have regard to the council's Statement of Licensing Policy. You must also be aware of the expectations of the licensing authority and the responsible authorities as to the steps that are appropriate for the promotion of the licensing objectives and to demonstrate knowledge of your local area when describing the steps you propose to take to promote the licensing objectives.

In order to assist you, Leeds City Council has collated information on this area including any special policies that relate to the area. You should make your own enquiries as well and demonstrate how you have considered the following in your operating schedule:

- The layout of the local area and physical environment including crime and disorder hotspots, proximity to residential premises and proximity to areas where children and young persons may congregate.
- Any risk posed to the local area by the your proposed licensable activities; and
- Any local initiatives which may help mitigate potential risks.

Scope

The scope of this guidance includes all premises licensed under the Licensing Act 2003 in post code areas LS12, which is comprised of Armley, Farnley, New Farnley and Wortley.

In LS12, your life expectancy will be lower than that of residents in other areas of Leeds (Joint Strategic Needs Assessment 2012, NHS Leeds). The three contributory factors to a reduced life expectancy are alcohol, obesity and smoking. The Licensing Act 2003 authorises the activity of the sale or supply of alcohol and the provision of late night refreshment and therefore the question is whether reducing people's access to alcohol and high fat content takeaway food will have a positive outcome on life expectancy in LS12.

Local Concerns

Local GP Andrew Sixsmith, who works at the Thornton Medical Centre has expressed his concerns about problematic drinking in the LS12 area and has supported Leeds West Clinical Commissioning Group projects to address this issue. Inner West Community Committee has also expressed concerns about alcohol abuse.

In the LS12 area there is concern about:

Alcohol

- The wide and obvious availability of alcohol in convenience stores, newsagents, corner shops and off licences.
- The contributory factor and possible links between violent crime and domestic violence and exacerbated by the availability of alcohol due to the numbers of premises which sell alcohol for consumption off the premises in the area.
- The higher proportion of premises licensed for alcohol for consumption off the premises.
- The ability for persons with mental health or alcohol problems to easily obtain alcohol.
- The ability for persons who are already intoxicated to easily obtain more alcohol.
- The pack size super strength cider is sold in, which leads to people with alcohol dependency issues to drink more than they need to.

Protection of children

- The normalisation of alcohol abuse and the effect this has on children living in the area
- The sale and supply of alcohol to young persons and children and the impact this has on their behaviour in the community and impact on their health.

Nuisance

- The accumulation of premises providing takeaway food and off sales of alcohol.
- Littering of food wrappers and waste food originating from takeaways.

Responsible Retailing

In 2010 the Government introduced a new Mandatory Code for Alcohol Retailing. This was brought into law by the implementation of 5 new mandatory conditions. These were updated in 2014 and further details can be found on the Home Office website: https://www.gov.uk/alcohol-licensing#mandatory-licensing-conditions

Specifically the Government brought in a new mandatory condition prohibiting the sale of alcohol below cost. Cost is defined as the cost of the VAT and duty charge. More information can be found on the Government website: https://www.gov.uk/government/publications/banning-the-sale-of-alcohol-below-the-cost-of-duty-plus-vat

Responsible retailing, including age related sales of alcohol, has long been promoted by West Yorkshire Trading Standards. More information can be found on their website at http://www.ts.wyjs.org.uk/wyjs-trading-underage-sales.asp

When considering responsible retailing, you may wish to consider what you would do about:

- The sale of large quantities of alcohol
- The sale of super strength alcohol in large containers (2 and 3 litre plastic bottles)
- The sale of alcohol to people who are already drunk
- How to address selling alcohol to people who are pregnant
- How to refer someone who appears to have a drinking problem
- How to display alcohol
- What to name the premises
- Healthy takeaway options available for example 28 fat versions of popular dishes

Nutritional information on all takeaway foods.

It may be useful for you to make yourself aware of organisations in the area that can help people with alcohol addiction and to get acquainted with the local West Yorkshire Police Neighbourhood Policing Team.

Measures to address local concerns

The availability of alcohol is a major concern, as harmful and hazardous drinking is a contributory factor in many of the concerns mentioned in this document. As such the licensing authority would expect anyone wishing to open or extend premises that sell alcohol, or sell hot food to provide extra measures to ensure these problems are not exacerbated.

It is highly likely that any application which includes the sale by retail of alcohol or the sale of hot food and drink will attract representations from a number of interested people. In order to mitigate the concerns stated in this document, you are encouraged to contact Entertainment Licensing, West Yorkshire Police, Environmental Health and Public Health to see if there are any specific measures that can be adopted. Contact details for agencies are included in the application packs and on the council website.

If you don't contact the responsible authorities, and you do not offer additional measures you can expect to be contacted by a number of the agencies about your application. This may be by phone, email or by way of a formal objection to your application.

Entertainment Licensing provides a Proforma Risk Assessment which is a list of suggested measures prospective licensees may like to include in their operating schedule. In addition you may wish to consider if any of the following measures would be appropriate for your business to adopt. These measures could be offered as part of the operating schedule. A form is attached to the end of this document to assist you with this.

Crime and Disorder

- All areas of the premises to be used for the display of alcohol are marked on the plan. The
 display of alcohol will not change without the consent of the licensing authority by way of a
 minor variation application to the licence.
- The display of alcohol will be in a designated area of the premises which is capable of being supervised from the counter area.
- The display of spirits shall be in an area accessible only by staff
- The display of high-strength beers, ciders and lagers of 7.5% alcohol by volume (abv) or higher will be in an area accessible only by staff.
- There will be no sale of cider and lager of 7.5% alcohol by volume (abv) in 1, 2 or 3 litre
 plastic bottles.
- All areas where alcohol is displayed shall be covered by CCTV

Prevention of public nuisance

 Staff will make hourly checks around the premises and remove any litter, including takeaway wrappers, can and bottles.

Protection of children

- There will be a Check 25 proof of age verification scheme in place.
- Alcohol will not be displayed nextpathe public entrance/exit of the premises.

- The name of the premises will not contain reference to alcohol.
- There will be no window display posters or similar advertising contained reference to alcohol displayed on the premises shop frontage or the highway abutting the premises.
- All alcohol sale refusals will be recorded in a register which will be retained on the premises for inspection by responsible authorities on request.







Additional measures already in place

A designated public places order is in place. Designated Public Place Orders (DPPOs) give police officers discretionary powers to require a person to stop drinking and confiscate alcohol or containers of alcohol in public places. Failure to comply with alcohol restrictions in DPPOs can result in arrest and/or a fine of up to £500. DPPOs are implemented by local councils in order to address alcohol-related crime and disorder in public places under section 13 of the Police and Criminal Justice Act 2001.





The majority of "on licensed" premises cease selling alcohol at midnight with a smaller number ceasing alcohol sales at 11pm or 1am. This is significantly earlier than the city centre, but in keeping with other residential areas. In the main off licensed premises cease selling alcohol at 11pm.

Year to Date Numbers in Treatment for both ADS and LAU were lower by the end of Q2 2013/14 than at the same point in 2012/13. The difference for ADS was only 5% but the decrease for LAU was 21%. St Anne's shows a slight decrease between the two Q1 figures and a slight increase by the end of Q2.

Average waiting times haven't changed much for ADS and LAU, with the most noticeable change being a reduction in waiting times for St Anne's.

ADS

Numbers in treatment has remained consistent, with a decline in new presentations and discharges. There has been a slight increase in average waiting times; however 90% are under 3 weeks and 10% within 3-6 week wait. The number of successful completions has declined from 2012/13 baseline of 284 to 249 quarter 1 and 245 quarter 2 of this year.

Leeds Addiction Unit

The numbers in treatment dropped between April and October 2013. There was less than half the number of new presentations in September and October than in April. Between April and October there has been a decrease in discharges.

Waiting times do not appear to have not changed significantly in quarter 2, however, waiting times for 32% of people were between 3-6 weeks, 2% 6-9 weeks and 1% greater than 9 weeks. Therefore 35% of people waited longer than the national target of 3 weeks.

Between 1 April 2013 to 31st January 2014 had 150 active clients who come from LS12.

St Anne's

Numbers in treatment have remained consistent, but there was a decline in new presentations and a slight increase in discharges. There has been a reduction in waiting times and the numbers for successful completions remain constant, people usually remain in treatment through residential or community rehabilitation. St Anne's have 34 clients in treatment who come from LS12.

Fires

Most alcohol related fires in Leeds happen between 21:00 and 03:00 at night with 90% of incidences occurring in residential properties. The majority of incidences are related to cooking. 52% of the injuries occurred in an area of Leeds ranked in the 10% most deprived nationally. Between 2008/09 and 2010/11 56 people suspected of being under the influence of drink or drugs were injured by fires and of these 31 were suspected to be under the influence of alcohol.

Drinking while pregnant

The UK Chief Medical Officer's advice to women is:

'Women who are pregnant or trying to conceive should avoid alcohol altogether. However, if they do choose to drink, to minimise the risk to the baby, we recommend they should not drink more than 1-2 units once or twice a week and should not get drunk.'

The National Institute for Health and Clinical Excellence (NICE) advises healthcare professionals (GPS and nurses):

- Pregnant women and women planning to become pregnant should be advised to avoid drinking alcohol in the first three months of pregnancy, because there may be an increased risk of miscarriage.
- Women should be advised that if they choose to drink alcohol while they are pregnant, they
 should drink no more than 1-2 units of alcohol once or twice a week. There is uncertainty
 about how much alcohol is safe to drink in pregnancy, but at this low level there is no
 evidence of any harm to their unborn baby.
- Women should be advised not get to drunk or binge drink (drinking more than 7.5 UK units
 of alcohol on a single occasion) while they are pregnant because this can harm their unborn
 baby.
- If women want to avoid all possible alcohol-related risks, they should not drink alcohol during pregnancy because the evidence on this is limited.

Obesity

Tackling obesity is one of the most significant public and personal health challenges facing our society. Obesity is a serious threat to health with 22% of men and 23% of women now classed as clinically obese (BMI greater than 30kg/m2). Among people aged 55 – 74 years two thirds of women and three quarters of men are overweight or obese.

The Leeds Joint Strategic Needs Assessment (JSNA) outlines key lifestyle behaviours that are of significance, which includes obesity. The findings suggest obesity levels are rising. The JSNA describes obesity as the second most important preventable cause of death after smoking. The cost to NHS in Leeds was £205m in 2010. In relation to children, 1 in 10 in reception class and this rises to 1 in 5 for those children in Year 6 (primary school) are obese.

The National Obesity Observatory's Report on Obesity and alcohol states that the relationship between obesity and alcohol consumption is complex. Associations between the two are heavily influenced by a number of factors including: patterns and levels of drinking; types of alcoholic drinks consumed; gender; body weight; diet; genes; physical activity levels and other lifestyle factors.

Some of the key points from the report include:

- Many people are not aware of the calories contained in alcoholic drinks
- The effects of alcohol on body weight may be more pronounced in overweight and obese people
- Alcohol consumption can lead to an increase in food intake
- Heavy, but less frequent drinkers seem to be at higher risk of obesity than moderate, frequent drinkers
- The relationships between obesity and alcohol consumption differ between men and women
- Excess body weight and alcohol consumption appear to act together to increase the risk of liver cirrhosis
- There is emerging evidence of a link between familial risk of alcohol dependency and obesity in women

All of this leads to a concern about the availability of alcohol and unhealthy foods.

Summary of main issues

This report advises Members that a temporary event notice has been received from Leeds City Council Environmental Protection Team have served an objection notice on the public nuisance.

Members of the Licensing Sub Committee are asked to consider the temporary event notice and the objection notice.

1 Purpose of this report

- 1.1 To advise Members of a temporary event notice served under section 100 of the Licensing Act 2003 ("the Act") in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of an objection notice from the Environmental Protection Team.

2 History of premises

2.1 These premises had the benefit of a premises licence. However this licence lapsed on the 3rd February 2015 due to the licence holder entering insolvency.

3 The temporary event notice

- 3.1 The proposed premises user is Naison Mubaiwa.
- 3.2 A copy of the temporary event notice is attached at Appendix A
- 3.3 In summary the temporary event notice is for

The sale by retail of alcohol and regulated entertainment

22nd to 23rd July 2016 22:00 -04:00

3.4 The location of the premises can be seen on the map at Appendix B.

4 Representations

- 4.1 LCC Environmental Protection Team have received a copy of the notice.
- 4.2 Environmental Protection Team consider that allowing the premises to be used in the manner set out in the temporary event notice will undermine the public nuisance and have issued an objection notice.
- 4.3 Copies of the objection notice will be available at the hearing for Members consideration.

NOTES

General

In these notes, a person who gives a temporary event notice is called a "premises user".

The police and local authority exercising environmental health functions may intervene on the grounds of any of the four licensing objectives (the prevention of crime and disorder, public safety, the prevention of public nuisance and the protection of children from harm) to prevent the occurrence of an event at which permitted temporary activities are to take place or to agree a modification of the arrangements for such an event. However, the licensing authority may intervene of its own volition in the cases described below.

First, it will issue a counter notice if there is an objection to a late temporary event notice (see note 7 below).

Secondly, it may issue a notice in relation to its decision to impose conditions on a temporary event notice (see note 2 below).

Thirdly, it will issue a counter notice if the first, second, third and fifth of the limits set out below would be exceeded. If any of the limits below are breached or if a counter notice has been issued, any licensable activities taking place would be unauthorised and the premises user would be liable to prosecution. The limitations apply to:

- the number of times a person (the "premises user") may give a temporary event notice (50 times per year for a personal licence holder and 5 times per year for other people);
- the number of times a person (the "premises user") may give a late temporary event notice (10 times per year for a personal licence holder and 2 times per year for other people);
- the number of times a temporary event notice may be given in respect of any particular premises (15 times in a calendar year);
- the length of time a temporary event may last for these purposes (168 hours);
- the maximum aggregate duration of the periods covered by temporary event notices at any individual premises (21 days per calendar year); and
- the scale of the event in terms of the maximum number of people attending at any one time (a maximum of 499).

For the purposes of determining the overall limits of 50 temporary event notices per personal licence holder (in a calendar year) and of 5 for a non-personal licence holder (in a calendar year), temporary event notices given by an associate or a person who is in business with a premises user (and that business involves carrying on licensable activities) count towards those totals. The limits applying to late temporary event notices are included within the overall limits applying to the total number of temporary event notices. Note 15 below explains the definition of an "associate".

When permitted temporary activities take place, a premises user must either ensure that:

- a copy of the temporary event notice is prominently displayed at the premises; or
- the temporary event notice is kept at the premises either in his own custody or in the custody of a person present and working at the premises and whom he has nominated for that purpose.

Where the temporary event notice is in the custody of a nominated person, a notice specifying that fact and the position held by that person must be displayed prominently at the premises.

Where the temporary event notice or a notice specifying the nominated person is not displayed, a constable or an authorised person (for example, a licensing officer, fire officer or environmental health officer) may require the premises user to produce the temporary event notice for examination. Similarly, where the nominated person has the temporary event notice in his custody, a constable or authorised person may require that person to produce it for examination. Failure to produce the temporary event notice without reasonable excuse would be an offence.

It should also be noted that the following, among other things, are offences under the Licensing Act 2003

- the sale or supply of alcohol to children under 18 years of age (maximum fine on conviction is an unlimited fine).
- Allowing the sale of alcohol to children under 18 (maximum fine on conviction is an unlimited fine).
- Knowingly allowing the consumption of alcohol on the premises by a person aged under 18 (maximum fine on conviction is an unlimited fine)
- Allowing disorderly behaviour on the premises (maximum fine on conviction is a fine up to a level 3 on the standard scale, currently £1,000).
- The sale of alcohol to a person who is drunk (maximum fine on conviction is a fine not exceeding level 3 on the standard scale currently £1,000).
- Obtaining alcohol for a person who is drunk (maximum fine on conviction is a fine up to level 3 on the standard scale currently £1,000).
- Knowingly allowing a person aged under 18 to make any sale or supply of alcohol unless the sale or supply have been specifically approved by the premises user or any individual aged 18 or over who has been authorised for this purpose by the premises user (maximum fine on conviction is a fine up to level 1 on the standard scale, currently £200), and
- Knowingly keeping or allowing to be kept on the premises any smuggled goods which have been imported without payment of duty or which have otherwise been unlawfully imported (maximum fine on conviction is a fine up to level 3 on the standard scale, currently £1,000).

In addition, where the premises are to be used primarily or exclusively for the sale or supply of alcohol for consumption on the premises, it is an offence to allow children under 16 to be present when the premises are open for that purpose unless they are accompanied by an adult. In the case of any premises at which sales or supplies of alcohol are taking place at all, it is an offence for a child under 16 to be present there between the hours of midnight and 5am unless accompanied by an adult. In both instances, the penalty on conviction is a fine not exceeding level 3 on the standard scale, currently £1,000.

Note 1

A temporary event notice may only be given by an individual and not, for example, by an organisation or club or business. The individual giving the notice is the proposed "premises user". Within businesses, clubs or organisations one individual will therefore need to be identified as the proposed premises user.

If you include an e-mail address in section 1(7) or 1(9) the licensing authority may send to this the acknowledgement of receipt of your notice or any notice or counter notice it is required to give under section 104A, 106A or 107 of the Licensing Act 2003.

Note 2

For the purposes of the Licensing Act 2003, "premises" means any place. Premises will therefore not always be a building with a formal address and postcode. Premises can include, for example, public parks, recreation grounds or private land.

If a premises licence or club premises certificate has effect in relation to the premises (or any part of the premises) which you want to use to carry on licensable activities, it is possible that any conditions which apply to the licence or certificate may be imposed on the temporary event notice if certain pre-conditions are met. These pre-conditions are that the police or the local authority exercising environmental health functions object to the notice and the licensing authority decides:

- Not to give a counter notice under section 105 of the Licensing Act 2003;
- The conditions apply to the licence or certificate; and
- The imposition of the conditions on the notice would not be inconsistent with the carrying on
 of the licensable activities under the notice.

Note 3

A temporary event notice can be given for part of a building, such as a single room or a plot within with a larger area of land. You should provide a clear description of the area in which you propose to carry on licensable activities. This is important as any licensable activities conducted outside the area of the premises protected by the authority of this temporary event notice would be unlawful and could lead to prosecution.

In addition, when holding the proposed event, the premises user would need to be able to restrict the number of people on the premises at any one time when licensable activities are taking place to less than 500. If more than 499 are on the premises when licensable activities are being carried on, the licensable activities would be unlawful and the premises user would be liable to prosecution. The maximum figure of 499 includes, for example, staff, organisers, stewards and performers.

Note 4

A description of the nature of the premises assists the chief officer of police and local authority exercising environmental health functions in deciding if any issues relating to the licensing objectives are likely to arise. You should state clearly that the premises to be used are, for example, a public house, a restaurant, an open field, a village hall or a beer tent.

Note 5

A description of the nature of the event similarly assists the chief officer of police and local authority exercising environmental health functions in making a decision as to whether or not to make an objection. You should state clearly that the event taking place at the premises would be, for example, a wedding with a pay bar, the supply of beer at a particular farmers' market, a discotheque, the performance of a string quartet, a folk group or a rock band.

Note 6

The licensable activities are:

- the sale by retail of alcohol;
- the supply of alcohol by or on behalf of a club to, or to the order of, a member of a club;
- the provision of regulated entertainment; and
- the provision of late night refreshment.

Please refer to Schedules 1 and 2 to the Licensing Act 2003 for fuller details of the definitions and exemptions relating to regulated entertainment and late night refreshment.

Regulated entertainment, subject to specified conditions and exemptions, includes:

- (a) a performance of a play;
- (b) an exhibition of a film;
- (c) an indoor sporting event;
- (d) a boxing or wrestling entertainment;
- (e) a performance of live music;
- (f) any playing of recorded music;
- (g) a performance of dance;
- (h) entertainment of a similar description to that falling within (e), (f) or (g).

If you are uncertain whether or not the activities that you propose are licensable, you should contact your licensing authority for further advice.

Note 7

Late notices can be given no later than 5 working days but no earlier than 9 working days before the event in relation to which the notice is given. A late notice given later than 5 working days before the event to which it relates will be returned as void and the activities described in it will not be authorised.

The number of late notices that can be given in any one calendar year is limited to 10 for personal licence holders and 2 for non-personal licence holders. These count towards the total number of temporary event notices (i.e. 50 temporary event notices per year for personal licence holders and 5 temporary event notices for non-personal licence holders).

If there is an objection from either the police or local authority exercising environmental health functions, the event will not go ahead and a counter notice will be issued.

Note 8

The maximum period for using premises for licensable activities under the authority of a temporary event notice is 168 hours (seven days).

Note 9

You should state here the times during the event period, for example 48 hours, when you intend to carry on licensable activities. For example, you may not intend to carry on licensable activities throughout the entire 48 hour event period, and may intend to sell alcohol between 8.00 hrs and 23.00 hrs on each of the two days.

Note 10

No more than 499 may be on the premises for a temporary event at any one time when licensable activities are being carried on. If you intend to have more than 499 attending the event, you should obtain a premises licence for the event. Your licensing authority should be able to advise you. The maximum figure of 499 includes not only the audience, spectators or consumers but also, for example, staff, organisers, stewards and performers who will be present on the premises.

Note 11

If you indicate that alcohol will be supplied only for consumption on the premises, you would be required to ensure that no person leaves the premises with alcohol supplied there. If such a sale takes place, the premises user may be liable to prosecution for carrying on an unauthorised licensable activity. Similarly, if the premises user gives notice that only supplies of alcohol for consumption off the premises will take place, he/she must ensure that alcohol purchased is not consumed on the premises. The premises user is free to give notice that he/she intends to carry on both types of supplies. For this purpose the supply of alcohol includes both of the first two licensable activities listed in note 6 above.

Note 12

Relevant entertainment is defined in the Local Government (Miscellaneous Provisions) Act 1982 ("the 1982 Act") as any live performance or any live display of nudity which is of such a nature that, ignoring financial gain, it must be reasonably be assumed to be provided solely or principally for the purpose of sexually stimulating any member of the audience (whether by verbal or other means). Relevant entertainment therefore includes, but is not limited to, lap dancing and pole dancing.

The 1982 Act requires premises which provide relevant entertainment to be licensed under that Act for this purpose. Premises at which there have not been more than eleven occasions on which such entertainment has been provided within a period of 12 months, no such occasion has lasted for more than 24 hours and there has been a period of at least one month between each such occasion are exempt from the requirement to obtain a licence under the 1982 Act. Such premises are likely instead to require an authorisation under the Licensing Act 2003 to be used for such activities as these are a licensable activity (the provision of regulated entertainment – see note 6 above). A temporary event notice may be given for this purpose.

Note 13

The holder of a valid personal licence issued under the Licensing Act 2003 may give up to 50 temporary event notices in any calendar year subject to the other limitations in the 2003 Act. A proposed premises user who holds such a licence should give the details requested.

Note 14

As stated under Note 13, a personal licence holder (issued under the Licensing Act 2003) may give up to 50 temporary event notices (including 10 late notices) in any calendar year. An individual who does not hold a valid personal licence may only give 5 temporary event notices (including 2 late notices) in England and Wales in a calendar year. A calendar year is the period between 1 January to 31 December, inclusive, in any year.

If an event straddles two calendar years, it will count against the limits on temporary event notices (15 for each premises, 21 days for each premises, 50 per personal licence holder and 5 for non-holders) for each year, however, only one notice needs to be given.

For the purposes of determining the overall limits of 50 temporary event notices per personal licence holder (in a calendar year) and of 5 for a non-personal licence holder (in a calendar year), temporary event notices given by an associate or a person who is in business with a premises user (and that business involves carrying on licensable activities) count towards those totals. Note 15 below sets out the definition of an "associate".

If a temporary event notice has been given for the same premises, by the same premises user, and would have effect within 24 hours of the start of the event period under the current proposal or within 24 hours after the end of the event period, the temporary event notice given would be void and any licensable activities carried on under it would therefore be unlicensed.

For the purposes of determining whether or not the required gap of 24 hours is upheld, temporary event notices given by an associate or a person who is in business with a premises user (and that business involves carrying on licensable activities) count as if they had been given by the premises user.

Note 15

An "associate" of the proposed premises user is:

- (a) the spouse or civil partner of that person;
- (b) a child, parent, grandchild, grandparent, brother or sister of that person;
- (c) an agent or employee of that person; or
- (d) the spouse or civil partner of a person within (b) or (c).

For these purposes, a person living with another as that person's husband or wife is to be treated as that person's spouse.

Note 16

It is a requirement that you send at least one copy of this notice to the licensing authority at least ten working days (or five working days for a late notice) before the commencement of the proposed licensable activities. The authority will give you written acknowledgement of the receipt of the notice. This will be important proof that you gave the notice and when you gave it for the purposes of the Act. Some premises may be situated in two licensing authority areas, for example where a building or field straddles the local authority boundary. Where this is the case, at least one copy of the notice must be sent to each of the licensing authorities identified, together with the appropriate fee in each case. In such circumstances, you will receive acknowledgement from all the relevant licensing authorities.

One copy must be sent to each of the chief officer of police and the local authority exercising environmental health functions for the area in which the premises is situated at east ten working days for a standard notice (or five working days for a late notice) before the commencement of the proposed licensable activities. Where the premises are situated in two police areas or environmental health areas, a further copy will need to be sent to the further police force and local authority exercising environmental health functions.

Note 17

Under the Licensing Act 2003, all temporary event notices are given subject to a mandatory condition requiring that where the licensable activities involve the supply of alcohol, all such supplies must be made by or under the authority of the named premises user. If there is a breach of this condition, the premises user and the individual making the supply in question would be liable to prosecution. For this purpose the supply of alcohol includes both of the first two licensable activities listed in note 6 above.


Note 18

It is an offence knowingly or recklessly to make a false statement in or in connection with a temporary event notice. (A person is to be treated as making a false statement if he produces, furnishes, signs or otherwise makes use of a document that contains a false statement). To do so could result in prosecution and an unlimited fine.

Note 19


