#### **Summary of main issues**

This is an application to vary a premises licence, made by Leven Leisure Ltd, for Rolands 39 Call Lane, Leeds, LS1 7BT

Responsible authorities and Ward Members have been notified of this application.

The application has attracted representations from responsible authorities.

The premises are located within an area covered by a cumulative impact policy.

This application was adjourned from the Licensing Sub Committee on 24<sup>th</sup> May 2016 as the applicant or the applicant's agent was unable to attend the original hearing date.

#### Purpose of this report

- 1.1 To advise Members of an application made under section 34 of the Licensing Act 2003 ("the Act") to vary a premises licence in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of representations.

#### 2 History of premises

- 2.1 Rolands have maintained this premises licence since 29<sup>th</sup> November 2013.
- 2.2 A copy of the existing licence is attached at Appendix A.

#### 3 The application

- 3.1 The applicant is Leven Leisure Ltd
- 3.2 Briefly the application is to:
  - Extend the terminal hour for the sale of alcohol until 02:00 every day.
  - Extend the terminal hour for late night refreshment, films, live music & recorded music and opening hour until 02:30 every day.
  - Amend condition 49 under Annex 2 to read "There shall be no admission of new customers after 01:00am". The condition currently reads "There shall be no admission of new customers after 23:00 hours".
  - Remove the following conditions condition 75 under Annex 2 which reads "The PLH/DPS will adopt a cooling down period to draw the evening to a close where no entrants will be allowed after 23:00".
  - Addition of a further four conditions to be added to the operating schedule as below
    - 1. After midnight the maximum occupancy of the premises will be 60 customers.
    - 2. After midnight a minimum of 40 seats will always be provided whenever the premises are conducting licensable activities.
    - 3. After midnight waiter/waitress service will be available to customers.
    - 4. After midnight substantial refreshment will be available to customers and menus will be placed at the bar and on the tables.
  - To add an additional hour to the standard and non-standard timings on the day when British Summertime commences for alcohol, all licensable activities and opening hours.

#### 4 The operating schedule

4.1 The applicant proposes to promote the licensing objectives by taking the additional steps identified in the operating schedule which is attached at Appendix B.

#### 5 Location

5.1 A map which identifies the location of this premise is attached at Appendix C.

#### 6 Representations

6.1 Under the Act representations can be received from responsible authorities or other persons. Representations must be relevant and, in the case of another person, must not be frivolous or vexatious.

#### Representations from Responsible Authorities

- Representations have been received from West Yorkshire Police & Entertainment Licensing in their capacity as responsible authorities. A copy of the representation may be found at Appendix D & E respectively.
- 6.3 Both representations submitted by West Yorkshire Police and Entertainment remain as a matters for Members consideration.

#### Other representations

6.4 There are no other representations.

#### 7 Cumulative Impact Policy

- 7.1 The premises are located within the cumulative impact area for Area 1 City Centre Red Area.
- 7.2 Cumulative impact means the potential impact on the promotion of the licensing objectives due to significant number of licensed premises concentrated in one area.
- 7.3 An applicant wishing to vary a licence for premises which fall within any of the cumulative impact areas must identify, through their operating schedule, the steps they intend to take so that the council and responsible authorities can be satisfied that granting this variation would not add to the impact already being experienced.
- 7.4 Details of the cumulative impact policy specific to Area 1 City Centre Red Area and an outline of the evidence behind the reason for setting this policy is attached at Appendix F.
- 7.5 Members are directed to paragraphs 7.51 to 7.54 of the Statement of Licensing Policy which provides examples of how an application may be considered exceptional and the matters that the council would not normally take into consideration.

#### 8 Licensing hours

- 8.1 Members are directed to paragraphs 6.8 to 6.15 for the Statement of Licensing Policy which states the criteria that will be applied to any decision for new applications or variations which include extending hours.
- 8.2 In brief the Policy states at 6.14 that restrictions may be made to the proposed hours of use where, after receiving relevant representations, the council considers it appropriate for the promotion of the licensing objectives to do so. The council will take into account the existing pattern of licensed premises in an area when considering what is appropriate to promote the objectives. Applications which are significantly out of character for a locality will need to demonstrate that granting the hours sought will not impact on the licensing objectives, given the potential for neighbouring premises to seek the same additional hours to prevent rivals gaining a commercial advantage.
- 8.3 A list of premises in the local area and their licensed hours and activities is provided at appendix G.

#### 9 Equality and diversity implications

10.1 At the time of writing this report there were no implications for equality and diversity. Any decision taken by the Licensing Sub Committee will be in accordance with the four licensing objectives as prescribed by the Licensing Act 2003.

#### 10 Options available to Members

- 10.1 The licensing subcommittee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
  - Grant the variation as requested.
  - Grant the variation whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
  - Exclude any licensable activities to which the application relates.
  - Reject the whole or part of the application.
- 10.2 Members of the Licensing Sub Committee are asked to note that they may not modify the conditions or reject the whole or part of the application merely because it considers it desirable to do so. It must actually be appropriate in order to promote the licensing objectives.

#### Annex 1 - Mandatory Conditions

- Only individuals licensed by the Security Industry Authority may be used at the premises to quard against:
  - a. unauthorised access or occupation (e.g. through door supervision), or
  - b. outbreaks of disorder, or
  - c. damage
- No supply of alcohol may be made under this licence
  - a. At a time when there is no designated premises supervisor in respect of the premises licence, or
  - b. At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 4. The admission of children under the age of 18 to film exhibitions permitted under the terms of this licence shall be restricted in accordance with any recommendations made
  - a. By the British Board of Film Classification (BBFC,) Where the film has been classified by the Board, or
  - b. By the Licensing Authority where no classification certificate has been granted by the BBFC, or,
  - c. where the licensing authority has notified the licence holder that section 20 (3) (b) (74 (3) (b) for clubs) of the Licensing Act 2003 applies to the film.
- 5. The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children -

- a. games or activities which require or encourage, or are designed to require or encourage, individuals to
  - i. drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
  - ii. drink as much alcohol as possible (whether within a time limit or otherwise);
- b. provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
- provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;

- d. provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on
  - i. the outcome of a race, competition or other event or process, or
  - ii. the likelihood of anything occurring or not occurring;
- e. selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- 6. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 7. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- 8. The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

- 9. The responsible person shall ensure that
  - a. where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures:
    - i. beer or cider. 1/2 pint;
    - ii. gin, rum, vodka or whisky: 25 ml or 35 ml; and
    - iii. still wine in a glass:125 ml; and
  - b. customers are made aware of the availability of these measures

#### Conditions consistent with the operating schedule relating to the licensing objectives

#### The prevention of crime and disorder

- 10. A suitable Closed-Circuit Television (CCTV) system will be operational at the premises at all times when licensable activities are being carried out and at any other times where members of the public are present on the premises .
- 11. The CCTV system will cover all areas of the premises occupied by the public under the terms of the licence, including corridors and stairways (excluding WCs and changing rooms).
- 12. The CCTV system will cover the main entrance/s and exit/s and designated emergency egress routes from the premises.
- 13. The CCTV system will cover all external areas of the premises occupied by the public, i.e. queuing areas, beer gardens, smoking areas and car parks.
- 14. The location of CCTV cameras are identified on the site plan of the premises. No amendments to the locations of the cameras will be made without prior consultation with West Yorkshire Police/British Transport Police and the Licensing Authority
- 15. The CCTV system will be of a satisfactory resolution quality which will enable the identification of persons and activities, and other fine details such as vehicle registration number plates.
- 16. The CCTV system will contain the correct time and date stamp information.
- 17. The CCTV system will have sufficient storage retention capacity for a minimum of 31 days continuous footage which will be of good quality.
- 18. The CCTV footage will be controlled and kept in a secure environment to prevent tampering or unauthorised viewing. A record will be kept of who has accessed the system, the reason why and when.
- 19. A designated member / members of staff at the premises will be authorised to access the CCTV footage and be conversant with operating the CCTV system. At the request of an authorised officer of the Licensing Authority or a Responsible Authority (under the Licensing Act 2003) any CCTV footage, as requested, will be downloaded immediately or secured to prevent any overwriting. The CCTV footage material will be supplied, on request, to an authorised officer of the Licensing Authority or a Responsible Authority.
- 20. The CCTV system will be capable of securing relevant pictures for review or export at a later date.
- 21. The CCTV system will be adequately maintained and be capable of transporting recorded material onto a removable media.
- 22. The CCTV system replay software must allow an authorised officer of the Licensing Authority or Responsible Authority to search the picture footage effectively and see all the information contained in the picture footage.
- 23. It must be possible to replay exported files immediately e.g. no re-indexing of files or verification checks.
- 24. A Supervisor's Register will be maintained at the licensed premises, showing the names, addresses and up-to-date contact details for the DPS and all personal licence holders.

- 25. The Supervisors Register will state the name of the person who is in overall charge of the premises at each time that licensed activities are carried out, and this information will be retained for a period of twelve months and produced for inspection on request to an authorised officer.
- 26. A policy for searching patrons at the entrance to premises will be adopted and prominently displayed on the premises.
- 27. The PLH/DPS will inform West Yorkshire Police as soon as practicably of any search resulting in a seizure of drugs or offensive weapons.
- 28. A suitable purpose-made receptacle for the safe retention of illegal substances will be provided and arrangements made for the safe disposal of its contents as agreed with West Yorkshire Police or British Transport Police.
- 29. Notices will be prominently displayed at the entrances of the premises which state:
  - A search will be conducted as a condition of entry to premises;
  - Incidents of crime and disorder will be reported to the police and a full recorded entry will be made in the incident report register.
  - Entry to the premises will be refused to any person who appears to be drunk, acting in a threatening manner or is violent; or appears to be under the influence of drugs.
  - Entry will be refused to any person who has been convicted of an offence of drunkenness, violent or threatening behaviour or the use or distribution of illegal substances
- 30. There will be a communication link via radio to other venues in the city centre. This will be the system recognised by the current Business Crime Reduction Partnership for the city, Leeds City Council and West Yorkshire Police.
- 31. Such communication link will be kept in working order at all times when licensable activities are taking place.
- 32. The communication link will be available to the Designated Premises Supervisor or other nominated supervisor and be monitored by that person at all times that licensed activities are being carried out.
- 33. Any police instructions or directions given via the link will be complied with whenever given.
- 34. All incidents of crime or disorder will be reported via the link to an agreed police contact point.
- 35. The PLH/DPS staff will ask for proof of age from any person appearing to be under the age of 25 who attempts to purchase alcohol at the premises.
- 36. The PLH/DPS staff will ask for acceptable evidence (as agreed by WYP / WYTSS) from any person appearing to be under the age of 25 who attempts to purchase alcohol at the premises.
- 37. Glass and Bottles

Drinks, open bottles and glasses will not be taken from the premises at any time. Empty bottles and glasses will be collected regularly and promptly. Glass and other sharp objects will be stored and disposed of safely using suitable receptacles. Receptacles will be secured and not accessible to the customers.

- 38. The PLH/DPS will prominently display notices which inform customers that open bottles or glasses may not be taken off the premises.
- 39. Plastic or toughened polycarbonate (or similar) glasses/bottles will be used when requested by West Yorkshire Police / British Transport Police (e.g. football match days).

- 40. <u>Alcohol Designated Public Places Orders</u>
  - Notices indicating the existence and effect of an Alcohol Designated Public Places Order will be prominently displayed at the exits to the premises.
- 41. The PLH/DPS will belong to a recognised trade body or Pub Watch Scheme where one exists, whose aims include the promotion of the licensing objectives.
- 42. The PLH/DPS will operate to a written dispersal policy which ensures the safe and gradual dispersal of customers from the premises. The policy will be agreed with WYP. The PLH/DPS will ensure that staff receive training on the policy.
- 43. The Premises Licence Holder (PLH)/Designated Premises Supervisor (DPS) will ensure that a 'Daily Record Register' is maintained on the premises by the door staff (where door staff are employed).
- 44. The Daily Record Register will contain consecutively numbered pages, the full name and registration number of each person on duty, the employer of that person and the date and time he/she commenced duty and finished duty (verified by the individual's signature).
- 45. The Daily Record Register will be retained on the premises for a period of twelve months from the date of the last entry.
- 46. The PLH/DPS will ensure that an Incident Report Register is maintained on the premises to record incidents such as anti social behaviour, admissions refusals and ejections from the premises.
- 47. The Incident Report Register will contain consecutively numbered pages, the date time and location of the incident, details of the nature of the incident, the names and registration numbers of any door staff involved or to whom the incident was reported, the names and personal licence numbers (if any) of any other staff involved or to whom the incident was reported, the names and numbers of any police officers attending, the police incident and / or crime number, names and addresses of any witnesses and confirmation of whether there is CCTV footage of the incident.
- 48. The Incident Report Register will be produced for inspection immediately on the request of an authorised officer.
- 49. There shall be no admission of new customers after 23:00 hours.
- 50. A personal licence holder will be in attendance on the premises at all times after 17:00 hours.
- 51. The concept of the operation shall remain that of a cafe/bar.

#### **Public safety**

- 52. Before opening to the public, checks will be undertaken to ensure all access to the premises are clear for emergency vehicles. Regular checks will be undertaken when the premises is open.
- 53. Written records of all accidents and safety incidents involving members of the public will be kept. These will be made available at the request of an authorised officer.
- 54. During opening hours the cellar door must be kept locked or adequately supervised to prevent unauthorised access by the public.
- A suitably trained and competent person must ensure regular safety checks of the premises including decorative and functional fixtures, floor surfaces and equipment (including electrical appliances) to which the public may come into contact are undertaken. Records of these safety checks must be kept and made available for inspection by an authorised officer.

- 56. Empty bottles and glasses will be collected regularly paying particular attention to balcony areas and raised levels.
- 57. Electrical installations will be inspected on a periodic basis (at least every 3 years or at a frequency specified in writing) by a suitably qualified and competent person. Inspection records/certificates will be kept and made available at the request of an authorised officer. If used, any temporary electrical wiring and distributions will also be inspected. Inspection records/certificates will be kept. These will be made available at the request of an authorised officer.
- 58. One of the following protective measures shall be used for all socket-outlets which may be used for the connection for lighting, video or sound amplification equipment and display models:
  - a) Each socket-outlet circuit will be protected by a residual current device having a rated residual operating current not exceeding 30mA, or
  - b) Each individual socket-outlet will be protected by an integral residual current device having a rated residual operating current not exceeding 30mA.

The current operation of all residual current devices will be checked regularly by pressing the test button. If the device does not switch off the supply, an electrical contractor should be consulted. At the same time action should be taken to prohibit the use of socket outlets associated with a faulty residual current device.

- 59. Regular safety checks of guardings to stairs, balconies, landings and ramps will be undertaken, and a supervision policy will be maintained to prevent people from inappropriate behaviour, including climbing which may lead to a fall from height.
- 60. Safety glass that is impact resistant or shielded to protect it from impact will be used in all areas where the public may come into contact with it.
- A written spillage policy will be kept to ensure spillages are dealt with in a timely and safe manner.
- 62. Members of the public will be prevented from accessing hot food and drink preparation areas to prevent risk of scald or burns.
- 63. A suitably trained First Aider or appointed person will be provided at all times when the premises are open.
- 64. An appropriately qualified medical practitioner will be present throughout any sporting entertainment.
- 65. Adequate and appropriate First Aid equipment and materials will be available on the premises at all times.
- 66. A procedure for dealing with unwell members of the public will be in place including those who appear to be affected by alcohol or drugs. Staff will be appropriately trained in such procedures.
- 67. Where strobes, lasers, smoke machines or any other special effects equipment may be used, a written health and safety policy covering all aspects of their use will be provided and staff will be appropriately trained.
- 68. No strobes, lasers or smoke machines will be used at the premises unless there is a clearly displayed warning at the entrance to the premises that such equipment is in use.

#### The prevention of public nuisance

69. Licensable activities will be conducted and the facilities for licensed activities will be designed and operated so as to prevent the transmission of audible noise or perceptible vibration through the fabric of the building or structure to adjoining properties

- 70. Noise from a licensable activity at the premises will be inaudible at the nearest noise sensitive premises.
- 71. There will be no external loudspeakers.
- 72. Bottles will not be placed in any external receptacle after 23.00 hours and 07.00 hours to minimise noise disturbance to neighbouring properties.
- 73. Clear and legible notices will be displayed at exits, car parks and other circulatory areas requesting patrons to leave the premises quietly having regard to the needs of local residents, in particular emphasising the need to refrain from shouting, slamming car doors, sounding horns and loud use of vehicle stereos and anti-social behaviour.
- 74. The premises supervisor and any door supervisors will monitor the activity of persons leaving the premises and remind them of their public responsibilities where necessary.
- 75. The PLH/DPS will adopt a cooling down period to draw the evening to a close where no entrants will be allowed after 23:00.
- 76. Patrons shall not be allowed to use the rear yard area for the consumption of alcohol, food and smoking after 23:00 hours.

a) General – all four licensing objectives (b,c,d,e) (please read guidance note 9)

This is an application to extend the sale of alcohol until 2am, 7 days a week and all licensable activities which are currently on the licence until 2:30am, 7 days a week.

The applicant is aware that the premises are in Leeds City Council's licensing policy saturation "red zone" and have pre-consulted with both the Local Authority and Police Licensing Officers.

By way of background, the premises have a largely regular clientele who enjoy craft ales and cocktails; it is intended that food will also be available. The customers are mainly aged 25 and over, and enjoy principally being seating in a relaxed atmosphere where, normally, music levels allow conversation. Currently these customers have to leave the premises at midnight when they would far rather stay and continue enjoying their evening at Roland's. The proposed terminal hour is less than a number of premises which are currently situated on Call Lane and these include Black Swan, Revolución De Cuba, Baracoa and Brooklyn Bar Limited.

In terms of addressing the issue of cumulative impact, Roland's will be able to keep its customers in its premises for longe and then they will disperse by 2:30am. It is more likely that they would then decide to end their evening and head home, rather than attend other premises.

With Roland's current terminal hour, particularly on a Friday and Saturday, it is too early for customers to end their evening and they will almost inevitably visit other premises, probably in the cumulative impact area, possibly having to queue and then leave those premises at a much later hour.

It is in this way that the applicant contends that later hours at Roland's will in practice benefit the cumulative impact situation in and around Call Lane.

In addition, a number of conditions are proposed to reinforce and address the issue of cumulative impact (the premises must already trade as a café/bar and this is unchanged) and these are as follows:

- 1. After midnight the maximum occupancy of the premises will be 60 customers;
- 2. After midnight a minimum cf 40 seats will always be provided whenever the premises are conducting licensable activities;
- 3. After midnight waiter/waitress service will be available to customers;
- 4. After midnight substantial refreshment will be available to customers and menus will be placed at the bar and on tables.

The premises are relatively small with a high proportion of seating and have a good trading record, however by retaining its customers longer and not having to enforce the departure of satisfied customers together with the extra conditions applying after midnight this application will actively benefit the existing cumulative impact situation and an exception to the policy can be made.





Thank you for submitting your application for the above premises, received at the address above on 30<sup>th</sup> March 2016.

The application relates to premises which fall within one of the areas of Leeds currently subject to a policy of cumulative impact, as detailed in the present Statement of Licensing Policy 2014-2018, issued by Leeds City Council as the licensing authority.

The area concerned in this particular case is Area 1 Leeds City Centre.

Therefore, in line with the current statutory guidance issued by the Secretary of State under Section 182 Licensing Act 2003, West Yorkshire Police make representations based on the Cumulative Impact Policy (CIP) of the area concerned and highlighted above, where the licensing objectives and particularly the prevention of crime and disorder and prevention of public nuisance objectives, are being adversely affected.

The proposed premises are located in the current <u>red zone</u> in the cumulative impact area. The Council's policy states:

7.20 "The council will seek to refuse <u>all applications in these red areas</u> on the basis that the impact on the licensing objectives are at such a level that the area cannot support any more premises opening or extending their hours no matter how impressive the concept or application is. <u>The council will only grant applications in the red zone in exceptional cases</u>", and

7.24 "It is the council's policy, on receipt of relevant representations, to

- Refuse new and variation applications in the red area
- To seek additional measures for new and variation applications in the amber area
- To seek good quality applications for application sin the green area

7.25 "This applies to alcohol led premises such as bars, pubs, and nightclubs, and for premises seeking late night refreshment such as takeaways and late opening restaurants".

The location of these premises is in very close proximity to a multitude of other licensed premises in this area such as The Black Swan, Neon Cactus, Jakes Bar, Oporto, Call Lane Social, Brooklyn Bar, Revolution, Norman Bar and Back Room Bar.

Some of the other licensed premises in the immediate vicinity are The Duncan Pub, Hirsts Yard, Mook, Veeno, Distrikt, Pieminister, The New Penny, The Bridge, Baracoa, Revolucion de Cuba, The Hourglass, Mission Nightclub, Smokestack, Bar Fibre, Queens Court, Viaduct, Stone Roses Bar, Space Nightclub, and McDonald's. It is an alcohol related violent crime hotspot for robbery, assault and theft. The peak time for crime is between midnight and 04:00 hrs. The extra hours of operation applied for by the applicant therefore fall right in to these peak times.

There is a relevant history to these premises which goes back to 2011 when there was an application for a premises licence after the applicants, the had already signed the lease. The application was refused due to it being held that the applicant had not demonstrated that their proposed operation would not impact adversely on the licensing objectives under the Cumulative Impact Policy for Leeds City Centre. This decision was appealed by the but was dismissed at Leeds Magistrates after the hearing on 29th June 2012 for the same reason. With a lease already signed on a building which could not get a premises licence, the applicants again approached the Licensing Authority and West Yorkshire Police in 2013. A new proposal with much reduced hours of operation was tabled, and given that the hours did not cross in to peak crime times for the area, and additional prescribed measures were offered, agreements were reached, and there was no objection under Cumulative Impact. A premises licence was therefore granted by the Licensing Authority in November 2013 and the venue Roland's was opened in March/April 2014. The existing licence was not granted under the current Cumulative Impact Policy.

Since opening there has been little crime associated directly with the venue but this may well be due to their modest operating hours and this objection is made under CIP which is not about issues directly associated with specific premises but a whole area.

The current application makes mention of a pre-consultation with West Yorkshire Police. It is true that there was a telephone conversation in which I stated the police would object under CIP to any application which took their operation in to the peak times for crime in the area, so this objection under CIP should come as no surprise. In previous discussions the applicant had stated that he now had no desire to operate past midnight as he was getting too old. When challenged over this in the most recent conversation he stated that he now employed younger staff.

The latest analysis of crime data provided to Leeds City Council upon which the Cumulative Impact Policy is based shows that 'the block of premises bounded by Briggate (commonly known as Lower Briggate), Call Lane and Duncan Street remain the predominant hot spot area this year. This area is still highly concerning and the fact that this area is saturated cannot be overestimated. There has been an increase in theft and violent crime in the past twelve months'. The policy also states that in comparison with the other red area, Albion Street/Woodhouse Lane, the theft statistics are seven times as high, and violent crime statistics are four times as high. To quote the policy, 'This alone shows how important it is that the capacity in this area is not increased.' This includes applications to extend hours in the area.

This application is to extend the terminal hour for the sale of alcohol by two and a half hours every day until 02:00hrs, and to extend all other licensable activities and the closing time to 02:30hrs every day. This increase in hours will take the operation right in to the peak times for violent crime and theft in the area – midnight until 04:00hrs. The Council's policy is to only grant applications where they are seen to be exceptional. Extra conditions have been offered to apply after midnight which West Yorkshire Police do not consider make this application exceptional – substantial food to be available, a maximum occupancy of 60, with waiter/waitress service and a minimum of 40 seats to be provided. This is not exceptional in our opinion for the following reasons:

- In reality how many people will actually take advantage of a substantial food offer after midnight?
  This has become a stock condition to offer to try and convince Licensing Authorities that this is
  not just about the sale of alcohol. It may be there on the premises and offered on menus, but at
  that time of night, in that area of the city, the focus is on alcohol consumption.
- 60 extra persons in that area after midnight is 60 persons too many. What is their current
  occupancy as set out in their fire risk assessment? If it is above 60, how will they choose which
  customers to ask to leave in order to comply with this proposed condition? If it is currently 60 then
  this is not an offer of anything exceptional.
- Waiter/waitress service may encourage people to remain seated but, with an offer of 40 seats to be provided, there will be 20 persons standing in this small compact bar which may make this offer unmanageable.

The argument is being used that if they are allowed to operate until 02:30 they will retain their customers and therefore stop them leaving at midnight and visiting other bars which will alleviate some of the CIP area issues. It is also stated that their customers would be more likely to go home if they are allowed to leave at 02:30hours. However, customers would still be leaving Rolands and circulating in the area right at the peak times for crime and disorder, and when Call Lane is at its most congested, with two and a half hours' extra alcohol in their systems. Congestion and people in drink do not mix well, and result in crime and disorder.

The premises were served with a Section 19 Closure Notice (Criminal Justice and Police Act 2001) by West Yorkshire Police during a licensing visit on Saturday 20th February 2016 due to a breach of a number of conditions on their premises licence. The breaches were a CCTV condition connected to the retention period for camera footage, a radio condition, which the door staff said they thought was optional, and a drug safe condition. When asked what they did with any suspected controlled substances, it was stated that they were thrown in the bin. There was also no up to date premises licence being displayed in the venue as required by law. So the offer of additional conditions on top of those mentioned which they are unable or unwilling to currently comply with, does not fill me with confidence, and should not fill the Licensing Authority with confidence either.

Extra police resources have to be deployed to this area on Friday and Saturday evenings, and over Bank Holiday weekends, in an attempt to help reduce the crime and disorder associated with people frequenting the large amount of licensed premises in the immediate area. These crimes/incidents range from thefts and robberies to public order offences, assaults, serious disorder and also sexual offences. An ambulance is also regularly parked at the junction of Briggate/Boar Lane and Duncan Street to help

deal with the amount of injuries sustained due to assaults and accidents caused by over intoxication in the Night Time Economy (NTE). This is in an attempt to help reduce the strain which the NTE puts on the Accident & Emergency Department of the NHS.

The saturation of the area is such that determining which venues may bear some responsibility for the issues is practically impossible, and means that they cannot be dealt with by way of review or enforcement meetings. A strong Cumulative Impact Policy is therefore imperative to prevent already existing venues extending their licensable hours, and to prevent further premises licences being granted in that area which would add to the considerable impact already being felt.

Therefore, in terms of location (RED ZONE), and in terms of applying for a variation to an existing premises licence to operate after midnight until 02:30hours, West Yorkshire Police consider that this application implicates the current policy of cumulative impact for Leeds City Centre in the red area, and is not regarded as exceptional.

Thank you for submitting your applicat on for the above premises.

The area in which the subject premises is located in within a cumulative impact area. It is the council's policy, on receipt of relevant representations, to refuse new and variation applications in this area for alcohol led premises such as bars, pubs and nightclubs and for premises seeking late night refreshment such as takeaways and late opening restaurants, unless the applicant can demonstrate that their application would not impact on the cumulative effect of such licensed premises in the area.

I note that the application is to extend all licensable activities to a terminal hour of 2am every day, with a closing time of 2.30am. You have offered a maximum capacity of 60, 40 seats to be provided, waiter/waitress service to be available and substantial refreshment after midnight.

Bearing in mind the severity of the problems being experienced in the area with this area suffering from the highest levels of violent crime and disorder incidences in the city centre, the Licensing Authority is of the opinion that despite the additional measures you offered, your application contains insufficient information about how your application would not add to the impact already being experienced in the area. Offering seats, waitress service and a substantial refreshment offer does not detract from the fact that this application is to extend drinking facilities into the period of the night where this area suffers the most. Although you suggest your customers will remain in the premises, rather than relocate to other premises in the area, the net effect of this is to increase customer capacity in the area at a time when the violent crime and disorder incidences are at their most severe.

Therefore the licensing authority submits a formal representation against your application on the grounds of:



## City Centre CIP 2016

## **Licensing Act 2003**





Area 1 relates to the city centre. West Yorkshire Police has shared information and statistics that show that the nature of the city centre is such that the cumulative impact of licensed premises leads to problems that aren't experienced in other parts of the city and this can be attributed to the density of licensed premises in specific areas. The number and close proximity of venues on a street can result in difficulties in identifying individual premises as causing problems and so action planning and reviewing individual licences is not possible.

As a consequence the closure or opening of businesses can have a dramatic effect on reported crime and reported incidents in an area. While individual premises are dealt with using the review process, there are areas in Leeds city centre which may become saturated as new businesses open or existing businesses change their style of operation.

In addition the council recognises that a previous problem area can be improved by the introduction of new styles of business types, such as food led premises and seeks to encourage this.

This dynamic nature has created difficulties in setting a policy for the city centre that will be relevant for five years until the next formal review. Therefore the council has adopted an approach of designating areas within the city centre CIP as 'red' or 'amber' based upon an analysis of crime and disorder in the night time economy and will review these areas on an annual basis.

Areas that are considered highly saturated and that are experiencing particularly high levels of crime, disorder and/or nuisance will be designated as red areas. The policy states that the council will seek to refuse all applications in these **red areas** on the basis that the impact on the licensing objectives is at such a level that the area cannot support any more premises opening or extending their hours and that the council will only grant applications in the red zone in exceptional cases, and those exceptional cases would be where the premises can demonstrate that they will not impact on the issues already being experienced in the area.

Any variation that will effectively increase the occupancy of premises will be viewed in a similar light to new applications as they will increase the available capacity in the same way a new premises in that area would, which in the red area would be unacceptable. Management controls such as door staff checking occupancy may not be effective enough on busy nights to stop an increase in the number of people within the red zone and so potentially lead to more crime and disorder.

The amber area is an area which is of concern based upon an analysis of issues within the night time economy that are relevant to the licensing objectives, and the council will expect applicants to offer additional measures tailored to the problems in that area.

All other areas within the city centre CIP will be designated **green areas** where good quality applications will be generally be more acceptable even though the area is a CIP area.

It is the council's policy, on receipt of relevant representations, to

- refuse new and variation applications in the red area
- to seek additional measures for new and variation applications in the amber area
- To seek good quality applications for application in the green area

This applies to alcohol led premises such as bars, pubs and nightclubs, and for premises seeking late night refreshment such as takeaways and late opening restaurants.

#### Changes in the last year

In the last year the Council has received a number of applications within the area designated as the red zone in 2015. There has been a trend for existing operators to apply for minor and full variations to bring into use areas which were unlicensed previously, such as roof spaces and redundant boiler rooms. In all cases the premises licence holder has undertaken to keep their capacity the same. However this trend for increasing the licensed area is concerning as the ability to control capacity is difficult.

The issues with disorder in the street on Call Lane has led to a number of variations of a road closure during the night time economy hours, with the council settling on a full road closure between 11pm and 5am on the Friday, Saturday and Sunday night which took effect in October 2015. The sheer numbers of people, often intoxicated, in the street during these hours highlights the need for the overall capacity of the red area to decrease, not increase and so encourage people to drink elsewhere in the city.

#### **Police Reporting**

West Yorkshire Police has produced a crime report "Leeds City Centre: Night Time Economy Related Crime" dated November 2015 which has been referred to when reviewing the red and amber zones for 2016. This report is referred to as the Police report in this document.

In 2014 Her Majesty's Inspectorate of Constabulary carried out an inspection into the way the 43 police forces in England and Wales recorded crime data. This inspection was the most extensive of its kind that HMIC has ever undertaken into crime data integrity. Further information on the Inspection can be found here:

The subsequent report made a number of recommendations and police forces responded by introducing changes in crime recording practices. This has resulted in an increase in the number of recorded crimes in West Yorkshire. Analysis of the changes in crime levels, along with a number of other measures, concluded that a proportion of these recent increases were related to administrative change rather than an increase in criminality. Specifically this change in recording practise has impacted on the level of 'violence against the person', in particular 'violence without injury' as many lower level offences were not previously being recorded.

With respect to the police report, which is extracted in this document, the figures relating to crime other than violent crime are comparable to previous years. The comparisons between red zones provided in this report can also be considered accurate when compared against the same year.

However when viewing the statistics in this report, it must be borne in mind that the Licensing Authority will wait until the report is repeated next year to see if there is a true increase in crime before making substantial changes to the red areas based on violent crime reporting.

#### General

There are two distinct areas in the city where extra police resources are deployed on a regular basis. These areas are the Call Lane area and the Albion Street/Woodhouse Lane area. Premises in those areas also deploy street marshals at their own expense as it has been recognised that incidents on the street require extra attention and that early intervention can prevent an escalation in the severity of incidents on the street.

As police resources are reducing each year, priorities have been realigned. There has been a reduction in the number of arrests for drunk and disorderly but an increase in assault. The increase in assaults could be due to early intervention methods being cut back, such as the street marshalling scheme and intervention at an early level (i.e. arresting people for being drunk and disorderly), and so the low level offences are escalating to the more serious assault charge.

The following tables have been extracted from the police report and show the levels of crime reported over the last three years.

Theft, which in the night time economy is generally theft of mobile phones, has reduced significantly due in part to changing technology making phones less attractive but also due to significant work by West Yorkshire Police and the licensed premises on campaigns about keeping phones safe.

The top 10 streets for crime in the city centre remain broadly the same. The top three streets have not changed in the last 3 years although reported crime has reduced overall. The levels are still considered very high. The table below shows the top 10 streets where night time economy offending occurs


#### **Call Lane Red Area**

The block of premises bounded by Briggate (also known as lower Briggate), Call Lane and Duncan Street remain the predominant hot spot area this year.

This area is still highly concerning and the fact that this area is saturated cannot be overestimated.

There has been an increase in theft and violent crime in the past twelve months. Comparing the assault statistics between the three areas of most concern shows this area to have almost seven times the thefts and four times the violent crime of the other red area, Albion Street/Woodhouse Lane.

This alone shows how important it is that the capacity in this area is not



increased and the desire would be to reduce capacity in this area. This increase in capacity would be a consideration for applications to extend hours as well as licensable area.


In the last year there have been no significant problems around Assembly Street or the area behind the Corn Exchange. The problems that have been experienced in this area, in most cases, can be attributed to one premises, which is currently under action planning and is working with West Yorkshire Police to resolve the issues. Therefore the red area has been reduced to remove Assembly Street and the area behind the Corn Exchange.

In the last year the Licensing Authority has received a number of applications in the red area. One premises applied to remove conditions that tied the premises into a food led operation, which was refused. The licensing subcommittee did approve some structural alterations.

Another application for extended hours was granted, but the operating schedule offered to shut parts of the premises earlier, offered a food led operation on the first floor, and applied various other conditions. A third application for the grant of a new premises licence proposed an early closing time, full food menu and an emphasis on music concurrent with their retail business. This was considered an exceptional application and was granted.

These applications show that providing an exceptional case that proves the premises would not impact on the issues already being experienced in the area does allow the Licensing Authority to grant applications in the red area.

There has been a dramatic increase when comparing theft and violent crime in 2013/14 to 2014/15. However, as previously stated this could be due to a change in reporting with the 2014/15 figures being a truer reflection of criminality in this area.







#### Albion Street/Woodhouse Area




In the last year we have received three applications for licensed premises in this area – a restaurant serving a range of Caribbean food and cocktails and two takeaway premises. The restaurant was granted with conditions which tied it to a food led operation closing at 1am, but the two takeaway applications were refused.

Albion Street and Woodhouse Lane remain in the top 4 streets for reported crime.

Although the crime stats show a reduction in theft, robbery and a slight decrease in sexual offences, there is a worrying increase in violent crime and new secondary peak in the time analysis which shows that crime in this area is now a problem from 23:00hrs. This could be attributed to the change in recording of violent crime and so this will need to be reviewed next year.

The possible increase in violent crime and the early peak time shows it is important to maintain this red area.






As reported last year, a new area in Leeds has been developed in the north of the city. The new bars mentioned in last year's report have opened and as predicted have proven very popular.


There is a worrying increase in violent crime and theft in this area compared to last year but this may be attributed to the change in recording of crime as mentioned earlier in this report.


Although busy this area is not a major concern to the Licensing Authority. There

have been one off incidents but these have been attributed to specific premises which have been subject to action planning.

This area remains in the amber area this year, as this provides the most flexibility to negotiate with applicants regarding safeguards that can be put in place. However if crime levels increase further this area will be subject to further review next year and may face being placed in a red zone.

#### Conclusion

The conclusions from the Police report are:

- Overall offending in Leeds City centre has dropped in the 14/15 year by 785 when compared to 13/14.
- Most incidents in licensed premises are thefts or assault. The number of assaults in licensed premises has increased in 14/15 compared to 13/14, as has the number of associated alcohol involved flags.
- During the DTE, thefts are a problem despite a drop in 14/15 compared to 13/14.
- During the NTE, assaults increase and are greater than the same figure last year.
- Call Lane, Briggate and Albion Street have had the most offences in 14/15.
- Assaults are roughly split between off street and on street offending in 14/15 and are consistently so over the examined period. There are more reports of off street theft offences than on street.
- Seasonality shows assault, drunk & disorderly, theft from person and theft non-specific reduce over the summer months of May – August and increase steadily peaking in December.
- Hotspot locations for NTE offending are around Duncan Street and Lower Briggate.
- The top 3 offence categories assault, theft from person and theft non-specific, tend to occur in two broad locations. Area 1 is around Merrion Street/Woodhouse Lane/New Briggate. Area 2 is around Boar Lane/ Duncan Street/Lower Briggate/ Call Lane and has a denser amount of offences.
- Males are generally victims and offenders in assaults. Females are more likely to be victims in theft offences.

With these conclusions in mind the Licensing Authority has determined that the red area around Assembly Street and Crown Street be reduced. All other areas remain the same. Merrion Street/Cross Belgrave Street area will be closely monitored with a view to placing it in a red zone should the crime figures not improve in the next 12 months. Similarly the worrying increase in theft and violent crime in the two red areas will be closely monitored.
