Summary of main issues

.

This is an application for the grant of a premises licence, made by Mr Parvinder Bhadal, Mr Ravinder Bhadal, for New Moorside Club, Holborn Approach, Woodhouse, Leeds, LS6 2PW.

Responsible authorities and Ward Members have been notified of this application.

The application has attracted representations from a responsible authority.

1 Purpose of this report

- 1.1 To advise Members of an application made under section 17 of the Licensing Act 2003 ("the Act") for a new premises licence in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of representations.

2 History of the premises

This is the first application for a premises licence for these premises, although they currently have the benefit of a Club Premises Certificate.

The hours of operation for the Club Premises Certificate, mirror the hours applied for on the premises licence, which can be found in 3.3, detailed below.

2.1 This premises licence application follows on from a number of visits to the premises by Leeds City Council's Enforcement Officers (some of the visits in company with WYP Licensing), after both noise and beyond permitted hours complaints were received. Whilst there was no decisive evidence to back up the complaints, it became apparent after time that the members of the club had put the day to day control and financial affairs of the club into Mr Bhadal's hands.

A pragmatic approach to the situation was taken in that until a premises licence is granted, then the club being allowed to trade under a club premises certificate is of benefit to the members.

3 The application

- 3.1 The applicant's name is Mr Parvinder Bhadal, Mr Ravinder Bhadal, .
- 3.2 The proposed designated premises supervisor is Mr Parvinder Singh Bhadal
- 3.3 In summary the application is for:

Plays, indoor sporting events and performance of dance

Every day 11:00 until 23:00

Films

Monday to Thursday 11:00 until 00:30

Friday to Sunday 11:00 until 01:30

Boxing or wrestling

Every day 11:00 until 22:00

Live music and recorded music

Monday to Thursday 11:00 until 01:00

Friday to Sunday 11:00 until 02:00

Late night refreshment

Monday to Thursday 23:00 until 00:30

Friday to Sunday 23:00 until 01:30

Sale of alcohol

Every day 10:00 until 01:30

Non standard timings

Live music, recorded music, performance of dance - New Years Eve extension to 01:30

Late night refreshment and sale of alcohol – New Years Eve extension to 02:00.

3.4 Outdoor exhibition of film to be restricted to 22.30 hrs.

Outdoor live music and performance of dance, restricted to 20:00 hours during summer months only.

4 The operating schedule

4.1 The applicant proposes to promote the licensing objectives by taking the steps identified in the operating schedule which is attached at Appendix A.

5 Location

5.1 A map which identifies the location of the premises is attached at Appendix B.

6 Representations

6.1 Under the Act representations can be received from responsible authorities or other persons. Representations must be relevant and, in the case of another person, must not be frivolous or vexatious.

Representations from Responsible Authorities

6.2 Representations have been received from The Environmental Protection Team in their capacity as a responsible authority which may be found at Appendix C.

Other representations

6.3 There are no other representations.

7 Licensing hours

- 7.1 Members are directed to paragraphs 6.8 to 6.15 of the Statement of Licensing Policy which states the criteria that will be applied to any decision for new applications or variations which include extending hours.
- 7.2 In brief the Policy states at 6.14 that restrictions may be made to the proposed hours of use where, after receiving relevant representations, the council considers it appropriate for the promotion of the licensing objectives to do so.
- 7.3 The council will take into account the existing pattern of licensed premises in an area when considering what is appropriate to promote the objectives. Applications which are significantly out of character for a locality will need to demonstrate that granting the hours sought will not impact on the licensing objectives, given the potential for neighbouring premises to seek the same additional hours to prevent rivals gaining a commercial advantage.
- 7.4 A list of premises in the local area and their licensed hours and activities is provided at Appendix D.

8 Equality and diversity implications

8.1 At the time of writing this report there were no implications for equality and diversity. Any decision taken by the licensing subcommittee will be in accordance with the four licensing objectives as prescribed by the Licensing Act 2003.

9 Options available to Members

- 9.1 The licensing subcommittee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
 - Grant the application as requested.
 - Grant the application whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
 - Exclude any licensable activities to which the application relates.
 - Refuse to specify the said person as the designated premises supervisor.
 - Reject the whole or part of the application.
- 9.2 Members of the licensing subcommittee are asked to note that they may not reject the whole or part of the application merely because they consider it desirable to do so. It must be appropriate in order to promote the licensing objectives.

Annex 1- Mandatory Conditions we will undertake as part of our application

1. Only individuals authorised by the licence holder i.e. The Police used at the premises to guard against:-

- Unauthorised access or occupation
- Outbreaks of disorder
- Damage
- 2. No supply of alcohol may take place under this licence
- At a time when the licence permissions do not allow
- 3. Every supply of alcohol sold under the premises licence must be made under by an authorised personal licence holder or a nominated member of staff
- 4. The premises licence holder will ensure that staff and those authorised to sell alcohol will not participate in irresponsible promotions in relation to the premises licence:-
- Selling alcohol to glamourize anti-social behaviour i.e. causing drunkenness in a favourable manner
- Dispensing alcohol directly by one person into the mouth of another (without reason of disability)
- 5. The premises licence holder will ensure that FREE water is provided on request to customers where it is reasonably available and requested upon.
- 6. The premises licence holder will ensure that any age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- Verification will only be allowed through known official documentation
- i) Passport
- ii) Driving Licence
- iii) Student ID
- iv) Registered third party organisation who HAS ALREADY verified AGE
- 7. The premises licence holder will ensure that:-
- Where any of the following alcoholic drinks is sold or supplied for consumption on the premises(other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in securely closed container) it is available to customers in the following measures:
 - i) Beer or cider : ½ pint, 1 pint
 - ii) Gin, Rum, Vodka or whiskey (spirits) : 25ml or 50ml
 - iii) Wine in glass : 125ml, 175ml, 250ml
- These measures will be displayed in a menu: price list or printed material which is readily available to customers on the premises.
- 8. The premises licence holder will ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

Page 5

For the purposes of the condition set out in paragraph 1 of this condition:-

- "duty" is to be construed in accordance with Alcohol Liquor duties Act 1979.
- "permitted price" is the price found by applying the formula P=D + (DxV) where :-
- i) P is the permitted price
- ii) D is the amount of duty chargeable in realtion to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- iii) V is the rate of "value added tax (VAT) chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of alcohol.
- "relevant person" means, in realtion to the premises in respect of which there is in force a
 premises licence:-
- i) The holder of the premises licence
- ii) The designated premises supervisor(if any) in respect of such licence, or
- iii) The personal licence holder who makes or authorises a supply of alcohol under such licence
- "relevant person" means, in relation to the premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question and
- "value added tax" means value added tax charged in accordance with Value Added Tax Act 1994.

Where permitted price given by paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

- Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day (" the first day") would be different from the permitted price on the next day ("second day") as a result of a change to the rate of duty or value added tax.
- The permitted price which would apply on the first day applies to sales or suuplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2- Conditions consistent with the operating schedule

The prevention of crime and disorder

- 9. A suitable Closed Circuit Television (CCTV) system will be operational at the premises at all times when licensable activities are being carried out and any other times where members of the public are present on the premises.
- 10. The CCTV system will contain correct time and date stamp information.
- 11. The CCTV will have sufficient storage retention capacity for a minimum of 31 days continuous footage which will be of a good quality.
- 12. The PLH/DPS staff will ask for proof of age from any person appearing to be under the age of 25 who attempts to purchase alcohol at the premises.
- 13. The PLH/DPS will belong to a recognised body or Pub Watch scheme where one exists, whose aims include the promotion of licensing objectives.

Public Safety

- 14. A log book or recording system shall be kept upon the premises in which shall be entered particulars of inspections made, those required to be made by statute and information complied to comply with any public safety condition attached to the premises licence that requires the recording of such information. The log book shall be kept available for inspection when required by persons authorised by The Licensing Act 2003 or associated legislation.
- 15. All parts of the premises and all fittings and apparatus therein, door fastenings and notices, lighting, heating, electrical, air conditioner, sanitary accommodation and other installations, will be maintained at all times in good order and in a safe condition.

The Prevention of Public Nuisance

- 16. Licensable activities shall be conducted and the facilities for licensed activities shall be designed and operated so as to prevent the transmission of audible noise or perceptible vibration through the fabric of the building or structure to adjoining properties.
- Noise from a licensable activity at the premises will not be audible at the nearest noise sensitive premises at Holborn Approach, Institution Street, Woodhouse Street after 2300 hrs.
- 18. There shall be no external loud speakers after 22.30hrs.
- 19. Bottles will not be placed in any external receptacle between 2300 hrs and 0700 hrs the following day to minimise noise disturbance to neighbouring properties.
- 20. Noise from plant or machinery shall not be audible to the nearest noise sensitive premises during the operation of the plant or machinery. Plant and machinery shall be regularly serviced and maintained to meet this level.
- 21. The PLH/DPS will ensure patrons use beer gardens, external areas and play areas in a manner which does not cause disturbance to nearby residents and businesses in the vicinity. Patrons will not use such areas after 2300hrs except for smoking.
- 22. The activities of the persons using external areas shall be monitored after 2100 hrs and they shall be reminded to have regard to the needs of local residents and to refrain from shouting and anti/social behaviour etc. when necessary.
- 23. The PLH/DPS will adopt a cooling down period where music volume is reduced towards the closing down time of the premises.
- 24. The PLH/DPS shall ensure that litter arising from people using the premises is cleared away regularly and that promotional materials such as flyers do not create litter.
- 25. Clear and legible notices will be will be displayed at exits, car parks, and other circulatory areas requesting patrons to leave the premises quietly having regard to the needs of local residents, in particular emphasising the need to refrain from shouting, slamming car doors, sounding horns and loud use of vehicle stereos and other anti-social behaviour.
- 26. The designated premises supervisor and any door supervisors will monitor the activity of persons leaving the premises and remind them of their public responsibilities where necessary.
- 27. SIA registered door staff will be employed when required and used where queues are likely to form to manage the queues and ensure that queues are restricted to cordoned areas to prevent them obstructing foot paths and spilling onto roads, and to keep noise and obstructions away from residential property.
- 28. A facility will be provided for customers to order hackney / private hire vehicles.
- 29. Deliveries of goods necessary for the operation of the business will be carried out at such a time or in such a manner as to prevent nuisance and disturbance to nearby residents.

- 30. The DPS will ensure that staff who arrive early morning or depart late at night when the business has ceased trading, conduct themselves in such a manner to avoid causing disturbance to nearby residents.
- 31. Customers will be asked not to stand around loudly talking in the street outside the premises.
- 32. Customers will not be admitted to the premises outside opening hours.
- 33. The movement of bins and rubbish outside the premises will be kept to a minimum after 2300 hrs.
- 34. Any lighting on or outside the premises will be positioned and screened in such a way as to not cause a disturbance to nearby residents,
- 35. Adequate waste receptacles for use by customers will be provided in the local vicinity.

PROTECTION OF CHILDREN FROM HARM

36. Patrons especially parents will be instructed to supervise children under 16 at all times in the premises and the surrounding areas so as to make the child's safety paramount at all times during visiting the business.

Leeds City Council's Environmental Action Service Proposed Controlled Measures under the Licensing Act 2003 Name and Address of Premises: Moorside Social Club, Holborn Approach, Woodhouse, Leeds, LS6 2PW,

The premises is located in a predominantly residential area, the closest properties lie 35m west of the property on Midgley Terrace, 20m South of on Holborn Approach. There are also residential properties north and east of the Site.

The premises historically held a Club Premises Certificate until 2011 and from 2015. This allows only club members use of the facilities and have to sign in on entry. This allows a certain element of control over patrons who use the premises. A premises licence will open up use of the club to anyone therefore there is less control over patrons entering the premises; this could lead to increased disturbance from internal music and patrons using external areas. The current operating hours are similar to the hours requested in this application

Due to the proximity to residential properties there is potential for noise disturbance from amplified music, patrons in external areas, drinking and smoking resulting in raised voices. There is potential noise from use of vehicles arriving/leaving including banging car doors, revving engines, use of car stereos.

There is a history of noise complaints in 2015 and 2016 associated with the premises. Complaints have arisen as a result events operating since the premises reopened in 2015 and recently when Temporary Event Notices (TENs) have been used to extend operating hours. There is an ongoing investigation into amplified music disturbing local residents.

Conditions have been offered in the proforma to control noise from the site. However due to the combination of recent complaints, opening up the premises to non-members and the difficulty in controlling patrons in external areas, the hours applied for will result in increased disturbance to local residents.

Having considered the application under the Licensing Act 2003 for the above premises, we consider that the following measures are relevant and reasonable in order to meet the following aim of the licence:
