Summary of main issues

This is an application for the grant of a premises licence, made by Leonie Johnson & Philipa Mann, for Amico 250 Whitehall Road, Drighlington, Bradford, BD11 1BB.

Responsible authorities and Ward Members have been notified of this application.

The application has attracted representations from other persons.

1 Purpose of this report

- 1.1 To advise Members of an application made under section 17 of the Licensing Act 2003 ("the Act") for a new premises licence in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of representations.

2 History of the premises

2.1 This is the first application for a premises licence for these premises.

3 The application

- 3.1 This application is made in the names of Leonie Johnson and Philipa Mann.
- 3.2 The proposed designated premises supervisor is Phillipa Mann.
- 3.3 In summary the application is for:

Sale by retail of alcohol, Performance of a play, Exhibition of a film, Indoor sporting events, Performance of live music, Performance of recorded music, Performance of dance, Entertainment of a similar description.

Sun - Thurs 08:00 - 23:00

Fri - Sat 08:00 - 00:00

Late night refreshment

Sun - Thurs 23:00 - 23:30

Fri - Sat 23:00 00:30

3.4 The sale of alcohol is for both consumption on and off the premises.

4 The operating schedule

4.1 The applicant proposes to promote the licensing objectives by taking the steps identified in the operating schedule which is attached at Appendix A.

5 Location

5.1 A map which identifies the location of this premises is attached at Appendix B.

6 Representations

6.1 Under the Act representations can be received from responsible authorities or other persons. Representations must be relevant and, in the case of another person, must not be frivolous or vexatious.

Representations from Responsible Authorities

6.2 There have been no representations from responsible authorities.

Other representations

- The application has attracted representation from members of the public (described as 'other persons' in the legislation).
- The licensing authority are in receipt of 4 representations from members of the public.
- In order to protect personal data, redacted copies of the representations are attached at Appendix C. Unredacted copies will be available at the hearing for Members consideration.

7 Licensing hours

- 7.1 Members are directed to paragraphs 6.8 to 6.15 of the Statement of Licensing Policy which states the criteria that will be applied to any decision for new applications or variations which include extending hours.
- 7.2 In brief the Policy states at 6.14 that restrictions may be made to the proposed hours of use where, after receiving relevant representations, the council considers it appropriate for the promotion of the licensing objectives to do so.
- 7.3 The council will take into account the existing pattern of licensed premises in an area when considering what is appropriate to promote the objectives. Applications which are significantly out of character for a locality will need to demonstrate that granting the hours sought will not impact on the licensing objectives, given the potential for neighbouring premises to seek the same additional hours to prevent rivals gaining a commercial advantage.
- 7.4 A list of premises in the local area and their licensed hours and activities is provided at Appendix D.

8 Equality and diversity implications

8.1 At the time of writing this report there were no implications for equality and diversity. Any decision taken by the licensing subcommittee will be in accordance with the four licensing objectives as prescribed by the Licensing Act 2003.





Dear Sir/Madam

Following on from a telephone conversation regarding the above licence application. The website (Public access) is currently not working fully meaning that comments cannot be recorded. A message is coming up that says there is an error on the system. I suspect this is the reason that no comments have been recorded against this application.

Our comment/objection is as below:

Regarding Licence Application Reference PREM/03979/001 Amico Cafe, Whitehall Road, Drighlington, BD111BB

We would like to express our concerns regarding the licence application submitted by the above cafe. The proposed licence times would have a negative impact on the local community and could result in a risk to public and safety, cause a public nuisance and could increase the rate of alcohol related crime in the area.

The cafe in question is tiny with tables and chairs outside on the pavement. During the day this is a lovely feature but later on this would mean that the sound would travel to adjacent properties and late into the evening this would not be acceptable. The cafe itself joins on to residential properties, is next to a private access road to houses to the rear and is in the midst of properties housing young families and mature people. There is potential harm to children also if their sleep is disturbed late at night or if undesirable characters are drunk opposite the children's play area. The possibility of 'live music' would be another element here as customers would spill out on to the pavement seating with sound traveling to neighbouring properties.

There is no car park for the cafe meaning that road side parking is the only option. Again, this cafe is in the midst of residential properties whose owners also need to park on the roadside. The cafe is just above a junction on the main A58 where there have been many bumps in the past, it has also become increasingly difficult for cars to get out of Park Close due to parked cars close to the junction (our rear access is on Park Close so this has an impact on us). This would be far worse on an evening if the cafe were to open late and is a potential risk to public safety.

Another concern is that, if the licence is approved, alcohol will be on sale here after other establishments have closed so it could become a gathering point and a potential for alcohol related crime. We have had issues in the past with gangs of youths gathering on the park opposite though, fortunately, this has not happened for some time but it would be a worry that this would return with potential alcohol sales at the cafe.

So, to sum up, whilst we want to support local businesses to thrive, we do not think that the licence applied for is appropriate for this property. The risks are too high and we will be strongly opposing any such plans.

We are writing to register our objection to the application for a premises alcohol and entertainment license by Amico 250/250A Whitehall Road, Drighlington, Bradford BD111BB. Application number PREM/03979/001. This is with particular regard to the vastly extended opening hours in which alcohol can be sold and the activities to provide regulated entertainment.

Amico lies in a residential area within which we live. It is situated on a main road near a junction and almost opposite a children's park with moorland directly in front of it.

At present Amico trades under the name of Espresso and Café bar and does NOT sell alcohol or offer any type of entertainment. Opens on limited hours, which vary through the week and weekend. A Café bar which serves the whole community.


Granting a license with the vastly extended opening hours in our opinion is a recipe for disaster as it will completely have a negative impact on the area. The park, moorland and residential area would potentially become a meeting place for drunks and gangs, which will gravitate to these areas. In turn this would give greater liability to noise, litter, broken bottles, which in turn would be another hazard to children and residents alike.

Amico is situated in a small building on the main Whitehall Road (A58 Leeds to Halifax) directly opposite a junction. It is 200 yards away from a small side road, which at the present time is almost impossible to see the traffic coming up and down. This is due to the fact there is no off road parking at Amico, therefore the main road is becoming saturated with parked cars. Granting longer opening hours would just accentuate this problem and make this public risk even greater.

The inclusion of entertainment as listed would have a very negative impact on the immediate vicinity causing a public safety issue to customers and neighbours alike. The possibility of intoxicated people spilling out onto the pavement area would in itself be a public nuisance.

In conclusion we are people who like to support local businesses but unfortunately feel very strongly that we have a moral right and duty to object to something, which is not going to benefit our community in any slightest way.

If the licence is for the hours already passed on the planning application when it was (Change of use from Pet Shop to Coffee shop) 4/5 years ago, then we cannot see a problem. As the new hours are way over the original planning agreement, would have thought that this would have been a new planning application to be applied for.

The premises were originally a back to back house for the café side. A one up and a one down, all the requests for Dance, films, live music, sporting events etc, there is not adequate room?

We have been in contact with the owners of the business, and have been assured that they would not be opening to these late hours, but once these hours have been granted, there is no way of knowing what would happen to any new and future owners, should this happen. Once permission has been granted then we have a problem again.

- 6. Section G Performance of dance amend Sunday to Wednesday to 0800-2000 and Thursday to Saturday to 0800-2200
- 7. Section H amend Sunday to Wednesday to 0800-2000 and Thursday to Saturday to 0800-2200
- 8. Section I Late Night Refreshment amend Sunday to Wednesday to 0800-2030 and Thursday to Saturday to 0800-2230
- 9. Section J Supply of alcohol amend Sunday to Wednesday to 0800-2000 and Thursday to Saturday to 0800-2200
- 10. Section L Hours open amend Sunday to Wednesday to 0800-2030 and Thursday to Saturday to 0800-2230

- 1.2 Members are required to consider this application due to the receipt of representations.

2 History of premises

- 2.1 The premises has the benefit of a premises licence which permits the sale of alcohol, performance of live music, performance of recorded music every day from 9am to midnight.
- 2.2 A copy of the existing licence is attached at **Appendix A.**

3 The application

- 3.1 The applicant is Punch Taverns Plc.
- 3.2 Briefly the application is to:
 - Remove the Christmas Day restriction
 - The main changes are the addition of fixed seating in the lounge area, and the
 extension to the licensable area, in order to permit alcohol sales from the front
 of the premises.
 - A pavement licence application is proposed to be submitted in order to permit furniture on the public highway to the front of the premises.
 - Change the layout of the premises

Annex 1 - Mandatory conditions

Mandatory Conditions imposed under the Licensing Act 2003

Only individuals licensed by the Security Industry Authority may be used at the premises to quard against:-

- a. unauthorised access or occupation (e.g. through door supervision), or
- b. outbreaks of disorder, or
- c. damage

No supply of alcohol may be made under this licence

- At a time when there is no designated premises supervisor
- b. At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence

Embedded Restrictions

Alcohol shall not be sold or supplied except during the hours stated on this licence and:

- a. On Christmas Day, 12 noon to 3 p.m and 7 p.m to 10.30 p.m.
- b. On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day, midnight on 31st December).

The above restrictions do not prohibit:

the taking of the alcohol from the premises, (unless the alcohol is supplied or taken in an open vessel,) during the first thirty minutes after above hours;

the consumption of the alcohol on the premises by persons taking meals there during the first thirty minutes after the above hours, if the alcohol was supplied for consumption ancillary to those meals.

consumption of the alcohol on the premises by, or, the taking, sale or supply of alcohol to any person residing in the licensed premises;

the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;

the sale of alcohol to a trader or club for the purposes of the trade or club;

the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's Naval, Military or air forces;

the taking of alcohol from the premises by a person residing there; or

the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied;

the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.

Where the number of children attending the entertainment exceeds 100 the licensee shall ensure that the provisions of Section 12 of the Children and Young Persons Act 1933 are complied with.

Annex 2 - Conditions consistent with the Operating Schedule

Conditions agreed with West Yorkshire Police

Adopt a check 21 Proof of age scheme in accordance with guidance issued by West Yorkshire Police (or a similar proof of age scheme)

Participate in a local pubwatch scheme or licensing association (where one exists) that is recognised by West Yorkshire.

When permission is sought for the sale or supply of alcohol during non-standard hours for any Bank Holiday period, an event of national interest or a televised sporting event of national interest, the following will apply:

- The applicant must give West Yorkshire Police at least 10 clear working days written notice of any Bank Holiday period or any other event of national interest.
- The applicant must have made no more than 12 such applications relating to either an event of national Interest or televised sporting event of national interest in any one calendar year.
- If after the 5th working day commencing the day after the request is received, West Yorkshire Police do not respond, and then consent will be deemed granted.
- In relation to any request for non-standard hours, West Yorkshire Police retain the right to suggest any reasonable variation in promoting the prevention of crime and disorder objective.

Annex 3 - Conditions attached after a hearing by the licensing authority

The Designated Premises Supervisor will ensure that written records of all accidents and safety incidents involving members of the public are kept. The Designated Premises Supervisor shall ensure that these will be made available at the request of an authorised officer.

The Designated Premises Supervisor will ensure that regular safety checks of premises including decorative and functional fixtures, floor surfaces and equipment (including electrical appliances) to which the public may come into contact are undertaken. Records of these safety checks must be kept and made available for inspection by an authorised officer.

The Designated Premises Supervisor will ensure that electrical installations will be inspected on a periodic basis (at least every 3 years or so at a frequency specified in writing) by a suitably qualified and competent person.

The Designated Premises Supervisor will ensure that inspection records/certificates will be kept. These will be made available at the request of an authorised officer.

Before opening to the public the Designated Premises Supervisor will ensure that checks are undertaken to ensure all access to the premises are clear for emergency vehicles. The Designated Premises Supervisor shall ensure that regular checks will be undertaken by him when the premises are open.

The Designated Premises Supervisor will ensure that a written spillage policy will be kept to ensure spillages are dealt with in a timely and safe manner.

The Designated Premises Supervisor will ensure that a suitably trained First Aider of appointed person will be provided at all time when the premises are open.

The Designated Premises Supervisor will ensure that adequate and appropriate First Aid equipment will be available on the premises.

The Designated Premises Supervisor will ensure that during opening hours the cellar door must be kept locked or adequately supervised to prevent unauthorised access by the public.





Summary of Main Issues

This is an application for the grant of a premises licence made by Leeds Beckett University for Cloth Hall Court, Quebec Street, Leeds, LS1 2HA.

The application is made for a premises operating as a conference centre mostly hosting training events and conferences. There is however the proposal on occasions to provide drinks, canapé receptions and minimal ad hoc buffet dinners.

Members should note that these premises reside within the 'Amber Zone' of the Leeds City Centre Cumulative Impact Area. Further information on the policy in place for this area is included within this report.

Responsible authorities and Ward Members have been notified of this application.

The application has attracted one representation submitted by a solicitor acting on behalf of a client with business interests in the vicinity.

It should also be noted that the operating schedule has been amended to include additional measures to promote the Protection of Public Nuisance objective.

1 Purpose of this report

- 1.1 To advise Members of an application made under section 17 of the Licensing Act 2003 ("the Act") for a new premises licence in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of a representation.

2 History of the premises

2.1 This is the first application for a premises licence for these premises.

3 The application

- 3.1 The application is made on behalf of Leeds Beckett University.
- 3.2 The proposed designated premises supervisor is Miss Clare Jane Vidler.
- 3.3 In summary the application is for:

Sale by Retail of Alcohol Monday to Sunday 12:00 until 00:00 hours

Performance of Plays
Exhibition of Films
Live Music
Recorded Music
Performance of Dance
Entertainment of a Similar Description
Monday to Sunday 08:00 until 00:00

Non standard timings

If there is a requirement for an event to exceed 00:00 hours i.e. until 02:00 hours, the University will provide written notice to West Yorkshire Police and Leeds City Council 10 days prior to the event.

Opening Hours

The premises propose to open to the public; Monday to Sunday 08:00 until 00:00 hours.

4 The operating schedule

- 4.1 In order to provide members with as much information as possible a full copy of the operating schedule has been attached at Appendix A. This includes a general description of the premises, all licensable activities/hours applied for including further details on each activity and the steps identified in Section M of the application form to promote the licensing objectives.
- 4.2 Additional documentation accompanied the application including a risk assessment, safeguarding policies, a security assessment along with others. Such documents will be circulated to all parties at the hearing.

4.3 Although a formal representation has not been submitted, discussions between the Environmental Protection Team and the applicant have taken place and resulted in the operating schedule being amended to include further measures aimed at tackling noise nuisance. In order to assist Member's deliberation the thread of e-mails and a copy of the agreed measures has been included at Appendix B of this report.

5 Location

5.1 A map which identifies the location of these premises is attached at Appendix C.

6 Representations

6.1 Under the Act representations can be received from responsible authorities or other persons. Representations must be relevant, and in the case of another person, must not be frivolous or vexatious.

Representations from Responsible Authorities

6.2 There have been no representations from responsible authorities.

Other representations

- 6.3 The application has attracted representation from a solicitor acting on behalf of a freehold owner with business interests in the area (described as 'other persons' in the legislation).
- 6.4 The representation highlights concerns that could have a potential impact on each of the four licensing aims. However the letter concludes by inviting the applicant to provide further information and/or measures in attempt to appease the client's concerns.
- 6.5 Following expiry of the application's consultation period numerous e-mails have been exchanged between the solicitor acting on behalf of the objector and the applicant aspiring to reach an agreement. However at the time of writing this report discussions remain on-going and no agreement has yet materialised.
- In order to protect personal data, a redacted copy of the representation and the exchange of e-mails can be found at Appendix D. An copy of the original representation will be available at the hearing for Member's consideration.

7 Cumulative Impact Policy

- 7.1 The premises are located within the 'Amber Zone' cumulative impact area for Leeds City Centre.
- 7.2 Cumulative impact means the potential impact on the promotion of the licensing objectives due to the significant number of licensed premises concentrated in one area.
- 7.3 An applicant wishing to obtain a new licence for premises falling within any of the cumulative impact areas must identify, through the risk assessment process

and/or the operating schedule, the steps they intend to take so that the council and responsible authorities can be satisfied that granting a new licence would not add to the impact already being experienced.

- 7.4 Details of the cumulative impact policy specific to Leeds City Centre and an outline of the evidence behind the reason for setting this policy is attached at Appendix E.
- 7.5 Members are directed to paragraphs 7.51 to 7.54 of the Statement of Licensing Policy which provides examples of how an application may be considered exceptional and the matters that the council would not normally take into consideration.

8 Licensing hours

- 8.1 Members are directed to paragraphs 6.8 to 6.15 of the Statement of Licensing Policy which states the criteria that will be applied to any decision for new applications or variations which include extending hours.
- 8.2 In brief the Policy states at 6.14 that restrictions may be made to the proposed hours of use where, after receiving relevant representations, the council considers it appropriate for the promotion of the licensing objectives to do so.
- 8.3 The council will take into account the existing pattern of licensed premises in an area when considering what is appropriate to promote the objectives. Applications which are significantly out of character for a locality will need to demonstrate that granting the hours sought will not impact on the licensing objectives, given the potential for neighbouring premises to seek the same additional hours to prevent rivals gaining a commercial advantage.
- A list of premises in the local area and their licensed hours and activities is provided at Appendix F.

9 Equality and diversity implications

9.1 At the time of writing this report there were no implications for equality and diversity. Any decision taken by the licensing subcommittee will be in accordance with the four licensing objectives as prescribed by the Licensing Act 2003.

10 Options available to Members

- 10.1 The licensing subcommittee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
 - Grant the application as requested.
 - Grant the application whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
 - Exclude any licensable activities to which the application relates.
 - Refuse to specify the said person as the designated premises supervisor.
 - Reject the whole or part of the application.

10.2 Members of the licensing subcommittee are asked to note that they may not reject the whole or part of the application merely because they consider it desirable to do so. It must be appropriate in order to promote the licensing objectives.

b) The prevention of crime and disorder

Cloth Hall Court will be supported by access control to main entrances and designated offices and training areas within the building.

All policies relating to bomb threat, drug use and counter terrorism training will be given to staff working in the area.

This will be supported in Cloth hall Court by the receptions, General Assistants and CHC Manager. With support from City Campus security as required, the reception will have a panic alarm and radio.

The majority of events will be conference events, exhibition, training and dinners, however, there could be an occasion, such as a birthday event, when children will attend when alcohol is available.

Children are not permitted on University property unless accompanied by an adult, and the University will adhere to their Safeguarding Policy and Procedure and the University Safeguarding Code of Conduct.

Clare Vidler, Conferencing Manager, is the designated Conferencing Safeguarding Officer, who has attended the appropriated training.

It is proposed that the main conference staff will be trained appropriately, they will undergo Personal Licence holders training and will adhere to the 'Challenge 21' scheme where anyone who appears to look under the age of 21 will be asked to provide proof.





OBJECTION TO NEW PREMISES LICENCE - CLOTH HALL COURT, LEEDS BECKETT UNIVERSITY, QUEBEC STREET, LEEDS LS1 2HA



Our client wishes to make a representation to the premises licence application made by Leeds Beckett University for the Premises on the following grounds:

As the applicant is no doubt aware, the Premises is located within a cumulative impact zone. There is 'a rebuttable presumption' that if the application is, 'likely to add to the existing cumulative impact' it will 'normally be refused if relevant representations are received'. It goes on to say that, 'it is for the applicant to demonstrate that their application would not add to the cumulative impact of such licensed premises in the area'. With this in mind 'applicants must identify, through the risk assessment process (if used) and operating schedule, the steps that he or she intends to take so that the council and responsible authorities can be satisfied that granting a new licence will not add to the impact already being experienced'. Furthermore, as the Premises is located within the 'amber area' of the City Centre cumulative impact zone, there is a concern 'based upon an analysis of night time economy related issues that are relevant to the licensing objectives, and the council will expect applicants to offer additional measures tailored to problems in that area'.

From the information provided on Leeds City Council on-line licensing register, the only measures that have been proffered are:

- a Challenge-21 policy; and
- the use of CCTV.

This is wholly inadequate given the size and location of the Premises.

In particular, our client is concerned that any grant will have the following impact on the licensing objectives, namely:

Public Nuisance

The Premises has a large footprint and has applied, not only for the sale by retail of alcohol, but also recorded and live music. Given this, there is nothing at present preventing the Premises from operating as a large and 'lively' bar with loud music and dancing in an area which is already saturated. Coupled with the young audience that university buildings attract, there is a real risk of disturbance being caused in the local area from:

- a) Noise escape from activities taking place inside the Premises. No details have been provided in respect of any noise surveys nor conditions proffered relating to the installation of noise limiters, acoustic protection etc.
- b) Disturbance in the form of chatting, laughing and shouting from patrons accessing and leaving the Premises, the slamming of car doors and the dropping of litter.

Crime & Disorder

The threat of increased crime and disorder is closely linked to that of public nuisance. There is a fear that the grant of another premises licence could lead to fights, drug use, public urination and petty acts of vandalism fuelled by alcohol consumption. It is somewhat surprising that there has been no mention of employing door supervisors.

Protection of Children from Harm

Despite the application being for a university building, the only suggested control to ensure that underage sales are avoided is to have a Challenge-21 policy. No mention has been made of the extensive staff training required to ensure that such a venue does not become a target for underage drinkers.

Public Safety

From considering the application it is not clear how patrons will be managed to ensure that public safety is not compromised. What will the capacity limit be? How will it be enforced?

At present, the application as submitted raises more questions than it answers. As matters stand, the Licensing Sub-Committee is urged to reject this application for a new premises licence in its entirety. However, the applicant is invited to provide further information and proffer further conditions in an attempt to appease our client's concerns.

Sorry about the slow response - I have now taken further instructions.

Having considered the documentation provided in further detail, my client is not opposed to the style of operation described but has concerns that there are insufficient 'checks and balances' to ensure that the offer does not evolve into hosting events which fail to uphold the licensing objectives. With this is mind, my client would be prepared to withdraw its objection provided that the hours/activities sought and the conditions proffered are amended as follows:

Hours/Activities:

My client does not consider that it is appropriate or necessary to have a midnight terminal hour for the sale of alcohol. It is particularly concerned that by merely providing notice (which does not require agreement) the premises could sell alcohol until 2.00 a.m. Given this, there is nothing stopping the premises from serving alcohol until such time every day of the year. In the spirit of compromise, my client would be prepared to accept a terminal hour of 11.00 p.m. with an extension until 2.00 a.m. on Fridays and Saturdays provided that West Yorkshire Police or Leeds City Council could refuse such a request if it is considered that the licensing objectives might not be upheld. The premises would still have its full Temporary Event Notice allocation.

Furthermore, my client asks that you amend the application to remove live and recorded music. Background music is not a licensable activity and hence can be played in any event. Furthermore, the Live Music Act 2012 changed the law so that you will be able to play regulated live and recorded music in any event up until 11.00 p.m. for an audience of up to 500. In other words, we do not consider that you need to formally apply for live and recorded music. By removing such a request it would reassure my client that the premises will not hold noisy club or dance nights.

Conditions:

It is appreciated that you have already proffered a number of conditions. However, it is considered that by proffering certain key additional conditions, any premises licence can be 'future proffered' to ensure that the use of building does not adversely change. Given this, would you be prepared to proffer the following?

- Licensable activities shall only be provided at pre-booked ticketed events.
- Where licensable activities are to take place after 10.00 p.m. a minimum of 2 door supervisors shall be on duty from 9.00 p.m. until 30 minutes after close.
- All licensable activities shall be carried out by employees of the premises licence holder. The premises shall not be hired to third parties to carry out licensable activities.

If the above is acceptable there will be no need for a meeting.

- University Safeguarding policy in relation to staff and visitors to the premises this will be
 adhered to and support from the University's Security team will be imperative to ensure the
 smooth running of any events in the building.
- Building capacity/ public safety control of numbers
- Email from Leeds City Council Environmental Health the University was asked to complete
 an extra 'Profoma Risk Assessment Noise/public nuisance conditions'. This was
 subsequently submitted and the conditions will be attached to the licence LCC
 Environmental Health are no longer objecting to this application, please see attached email
 outlining the Conditions.

Please note that our main target market will be business to business for the likes of training, conferences and exhibitions and will also be home to the University's Enterprise department and the Institute of Directors. These activities will be primarily during the day time; any late evening events or where events with alcohol is provided or there is a 'cash bar' there will be a security provision to support the event.

Security's primary role will be:

- to ensure a smooth running event with necessary checks where appropriate
- to ensure there is no underage drinking (linking to the Challenge 21 Policy)
- there will also be facilitated access 'in and out' of the building to ensure minimised noise or disruption
- there will be CCTV in place both internally and externally to monitor the premises
- all the Security staff are all SIA Door Supervisor trained and have experience of dealing with these types of events within the University, please note that this is still a University building and will be managed, and locked/alarmed at the end of each evening
- the building will be monitored 'out of hours' by the Security team and any 'out of hours' alarms will be responded to from our Security Control room
- Please note the University Drug Policy, along with Safeguarding for minors will be adhered to at all times
- All our Security staff are fully first aid qualified and have also had training on conflict management, counter terrorism and are responsible for all fire evacuations across the University buildings/campuses
- Also included in the SOP is reference to the University to Bomb Threat and the appropriate channels for dealing with business recovery

Please note that this is not a student building and would not have an audience in the same way as other University buildings, or bar areas. Where alcohol is served it is pre booked as part of the conference/meeting/event requirement for the registered delegates only.



Cumulative Impact Assessment

City Centre – December 2016





Area 1 relates to the city centre. West Yorkshire Police has shared information and statistics that show that the nature of the city centre is such that the cumulative impact of licensed premises leads to problems that aren't experienced in other parts of the city and this can be attributed to the density of licensed premises in specific areas. The number and close proximity of venues on a street can result in difficulties in identifying individual premises as causing problems and so action planning and reviewing individual licences is not possible.

The closure or opening of businesses can have a dramatic effect on reported crime and incidents in an area. While problems at individual premises are dealt with using action planning and the review process, there are areas in Leeds city centre which become saturated as new businesses open or existing businesses change their style of operation.

In addition the council recognises that a previous problem area can be improved by the introduction of new styles of business types, such as food led premises and seeks to encourage this.

The dynamic nature of the city centre has created difficulties in setting a policy that will be relevant for five years until the next formal review of the Licensing Policy. Therefore the council has adopted an approach of designating areas within the city centre CIP as 'red' or 'amber' based upon an analysis of crime and disorder in the night time economy and will review these areas on an annual basis.

Areas that are considered highly saturated and that are experiencing particularly high levels of crime, disorder and/or nuisance will be designated as red areas. The policy states that the council will seek to refuse all applications in these **red areas** on the basis that the impact on the licensing objectives is at such a level that the area cannot support any more premises opening or extending their operation and that the council will only grant applications in the red zone in exceptional cases. Exceptional does not mean that an application is innovative or novel, but that it allows Members to make an exception to their policy. Those exceptional cases would be where the premises can demonstrate that they will not impact on the issues already being experienced in the area, i.e. by containing their operation within the hours of the daytime and early evening economy.

Any variation that will effectively increase the occupancy of premises will be viewed in a similar light to a new application as it may increase the available capacity in the same way a new premises in that area would, which in the red area would be unacceptable. Similarly new businesses seeking to introduce a new concept, and so attract different people into the area, may be acceptable in the amber area but in the red area the problems are exacerbated by the sheer number of people on the street during the peak hours and introducing a new or extended business, even with a different concept, would add to the impact rather than reduce it.

Management controls such as door staff will not be adequately effective in preventing an increase in the number of people within the red zone.

The **amber area** is an area which is of concern, based upon an analysis of issues within the night time economy that are relevant to the licensing objectives, and the council will expect applicants to offer additional measures tailored to the problems in that area. Applicants are strongly advised to consult with West Yorkshire Police and the licensing authority during their application process. By working together, the responsible authorities and businesses can establish working practices that reduce crime and disorder and so benefit the long term aims of the city to be a vibrant, thriving economy.

All other areas within the city centre CIP will be designated **green areas** where good quality applications will be generally be more acceptable even though the area is a CIP area.

It is the council's policy, on receipt of relevant representations, to

- refuse new and variation applications in the red area
- to seek additional measures for new and variation applications in the amber area
- to seek good quality applications for application in the green area

This applies to alcohol led premises such as bars, pubs and nightclubs, and for premises seeking late night refreshment such as takeaways and late opening restaurants.

Extra scrutiny is given to applications which appear to adopt a number of different styles during their trading. For example businesses that purport to be food led but seek late opening hours may be judged to be predominantly alcohol led due to their late night activities. It is for the applicant to demonstrate how their business will not impact on the licensing objectives.

Changes in the last year

There are two distinct areas in the city where extra police resources are deployed on a regular basis. These areas are the Call Lane area and the Albion Street/ Woodhouse Lane area. Premises in those areas deploy street marshals at their own expense as it has been recognised that incidents on the street require extra attention and that early intervention can prevent an escalation in the severity of incidents on the street.

As police resources are reducing each year, priorities have been realigned. There has been a small reduction in the number of arrests for drunk and disorderly but an increase in assault. The increase in assaults could be due to early intervention methods being cut back, such as the street marshalling scheme and intervention at an early level (i.e. arresting people for being drunk and disorderly), and so the low level offences are escalating to the more serious assault charge.

The issues with disorder in the street on Call Lane has led to a road closure between 11pm and 5am on the Friday, Saturday and Sunday night which took effect in October 2015. The sheer numbers of people, often intoxicated, in the street during these hours highlights the need for the overall capacity of the red area to decrease, not increase.

The Council continues to receive applications within the areas designated as red. There has been a trend for existing operators to apply for minor and full variations to bring into use areas which were unlicensed previously. In all cases the premises licence holder has undertaken to keep their capacity the same. However this trend for increasing the licensed area is concerning as the ability to control capacity is difficult. Any application seeking an increase in floor space, even without an increase in stated capacity, can expect close scrutiny.

Police Crime Reporting

West Yorkshire Police has produced a crime report "2016-10 Night Time Economy – City v4" dated October 2016 which has been referred to when reviewing the red and amber zones for 2017. This report is referred to as the Police report in this document. It uses reported crime figures from 01/09/2014 - 31/08/2016.

In 2014 Her Majesty's Inspectorate of Constabulary made recommendations to change crime recording practices. This resulted in an increase in the number of recorded crimes in West Yorkshire in 2015. Analysis of the changes in crime levels, along with a number of other measures, concluded that a proportion of these recent increases were related to administrative change rather than an increase in criminality. Specifically this change in recording practise has impacted on the level of 'violence against the person', in particular 'violence without injury' as many lower level offences were not previously being recorded.

The police report only compares statistics from the last two years, as the statistics are not comparable going further back than that due to the changes in the way in which crime is recorded.

The following data tables and key findings (signified by bullet points) have been extracted from the police report.

The tables clearly show that there has been in increase in crime across the city centre. The police report conclusions state:

- An analysis of the examined offences shows overall offending in the City Centre has increased by 13% compared with the previous examined period.
- During 01/09/2015 31/08/2016 Assaults and Public order offences have seen the highest increases in terms of volume compared with the previous year. Public Order and Robbery offences have experienced the greatest percentage change. The majority of the examined offences experienced an increase with the exception of Drunk and Disorderly and Murder / Manslaughter offences.
- Assaults and Thefts have the highest number of offences with a licensed premises flag and experienced the greatest increases during the period 01/09/2015 31/08/2016 compared with the previous 12 months.
- Assaults continue to be the highest alcohol related crime, followed by Drunk and Disorderly
 offences. Only Drunk and Disorderly and Theft Non Specific offences had a reduction.

- Assaults and Thefts are the top offence categories for both the day time economy and night time
 economy. For both time periods, the highest increases were in Assaults and Public Order
 offences.
- In both the examined periods there are more reports of 'off street' offences than 'on street'. The number of assaults occurring 'on street' or 'off street' are fairly similar in both years. There are slightly more assaults which occur 'on street'.

Street Level Data

The tables below relate to Leeds City Centre night time economy offending only (18:00 to 05:59) and show the top ten streets and the top ten streets of increasing concern for the night time economy offending. The table shows the percentage of the street compared with the city centre total as shown in Figure 5.

These clearly show that the Briggate and Call Lane areas are responsible for 35% of crime reported in the city in the last year. 15% of crime was reported in the other red area of Albion Street/Woodhouse Lane.


The police report conclusions were:

• Call Lane, Briggate, Albion Street and Woodhouse Lane are the top streets for offending in the night time economy for both examined periods. These streets are located within the two city centre CIP red areas, supporting the view that both red areas should be maintained.

The stated crime figures and time analysis is taken from offences occurring within the red outlining square, between 18:00 – 05:59. Assaults, theft from person, theft non-specific, robbery and sexual offences have been included in this analysis.

The police report conclusions were:

- The Call Lane red area remains the predominant hot-spot area. Geo-spatial analysis shows the main risk area within the city centre is the area of Call Lane and Briggate. The highest concentration of offences remains in this area and has slightly extended compared with the previous 12 months, but still falling within the existing designated area. The peak time for offending in the Call Lane area is now 00:00 05:00.
- Within the Call Lane area, all the examined offences namely assaults, robberies, sexual offences
 and thefts have increased during 2015-2016 with assaults and theft from persons experiencing
 the largest gains.

Not only have all crimes increased in this area by 17%, the peak times have lengthened from midnight to 4am to midnight to 5am. The risk days have changed from Friday, Saturday and Sunday to Thursday, Friday and Saturday. Most worrying are the increases in assault and theft from person.


This shows not only how important it is that the number of people using this area during the night time does not increase but that it would be desirable for the number of people using this area during peak hours to reduce. Therefore any change to the current licences, either new premises or any increase in the operation of the existing premises should not have the effect of increasing visitors to the area.

Furthermore the Council will be investigating ways in which assault and theft can be reduced, in liaison with the operators and agencies.

In the last year the Licensing Authority has received three applications in this red area. One was for the lengthening of operating hours into the peak hours and was refused. The subsequent appeal was withdrawn before it was heard with all costs recovered from the appellant. Another application was received for a substantial increase in the size of the premises. The applicant agreed to a range of amendments to the application which took the operation of the additional area out of the peak hours for crime and disorder. The third was only partially granted but with the imposition of restrictive conditions.

Any operator seeking a variation to their current licence must be mindful of the problems being experienced in the area and must ensure that the additional measures they offer will result in no impact on the licensing objectives. A responsible operator will always be seeking ways in which they can contribute to the efforts made to reduce the crime statistics, and would not be satisfied with merely maintaining the status quo.

The police report conclusions were:

• Within the Albion Street / Woodhouse Lane Red area, the hot-spot areas have remained the same in both examined periods, specifically the bottom of Woodhouse Lane and top of Albion Street, as shown in Section 7.2. During the period 2015-2016 the peak time is 00:00 – 04:00, compared with 01:00 – 04:00 over the previous 12 months.

The licensing authority hasn't received any new or variation applications in the last year. However the overall 19% increase in crime and the lengthening of the peak hours is worrying.

As with the Call Lane/Lower Briggate area this shows not only how important it is that the number of people using this area during the night time does not increase but that it would be desirable for the number of people to reduce. Therefore any change to the current licences, either new premises or any increase in the operation of the existing premises should not have the effect of increasing visitors to the area.

Furthermore the Council will be investigating ways in which assault and theft can be reduced, in liaison with the operators and agencies.

Cross Belgrave Street / Merrion Street / New Briggate:

The following area is not a designated 'red area' in the existing CIP; although, it has been noted as an emerging area of popularity during the 'Night Time Economy'.

The police report conclusions were:

Within the Merrion Street / New Briggate area the hot-spots have remained the same in both examined periods, as shown in Section 7.3. The peak time has extended from 01:00 - 02:00 to 01:00 - 04:00.

As reported last year, this area in Leeds has been developed in the north of the city and is proving very popular. The lengthening of the hot spot period and the overall 13% increase is in common with the two red areas. When compared to the other areas in the city, in figure 6, Merrion Street lies in 7th on both tables.

This area remains in the amber area this year, as this provides the most flexibility to negotiate with applicants regarding safeguards that can be put in place. However if crime levels increase further this area will be subject to further review next year and may face being placed in a red zone.

City Centre A&E Assault data

A&E data and road traffic incidents data are new additions to the review this year. The licensing authority was keen to see the crime statistics in context to ensure that the peak times for reported incidents was supported by other data specific to the night time environment.

The police report states A&E data was provided for the period 01/09/2014 – 31/08/2016. A notable proportion did not have a location address or did not specify an exact address, for example "on street" or "on bus". Assaults which could be attributed to occurring in the City Centre accounted for 12% of all assaults. Where the time of the assault could be ascertained, overall the peak time was 01:00 - 04:00, with secondary peaks between 23:00 - 01:00 and 04:00 - 05:00. 85% were recorded as being a male patient. Alcohol was the main contributing factor.

The police report conclusions were:

- Overall there are more day time economy road related incidents than during the night time. OPL (over the prescribed limit) and Road Related offences were higher during the Night Time Economy.
- During the NTE the main hot-spots for 2014-2015 for Road Related Incidents were around Woodhouse Lane and the Boar Lane / Briggate / Call Lane area. There was also a concentration of incidents in the vicinity of the Headrow / Westgate area.
- Overall during 2015-2016 the peak time for Road Related incidents is 13:00 18:00, there was a secondary peak between 02:00 03:00. The area reduced around Woodhouse Lane. The hotspot around Boar Lane / Briggate/ Call Lane remained, however the number of incidents in this area reduced compared with the previous 12 months. Boar Lane experienced an increase in Road Traffic Incidents, however incidents halved on Call Lane. This is possibly due to the road closure in effect since October 2015 on Call Lane between 11:00 05:00 on a Friday, Saturday and Sunday night.

Conclusion

With the police report conclusions in mind the Licensing Authority has determined that the red areas be maintained. Merrion Street/Cross Belgrave Street area and the Boar Lane areas will be closely monitored with a view to placing them in a red zone should the crime figures not improve in the next 12 months.

The increase in theft and violent crime in the two red areas is concerning. The council will work with the businesses and partners to establish if further work can be done to reduce these crime figures over the next 12 months.

The Licensing Committee will bear in mind that in the next 12 months there may be significant changes to the way late night levies can be introduced and may also consider the option of an early morning restriction order if these figures do not significantly reduce over the next 12 months.
