**Summary of main issues**

This is an application to vary a premises licence, made by Kanthasmy Mayuran, for Nisshan Convenience Store 411 - 413 Harehills Lane, Harehills, Leeds, LS9 6AP.

Responsible authorities and Ward Members have been notified of this application.

The application has attracted representations from other persons and responsible authorities.

**1 Purpose of this report**

- 1.1 To advise Members of an application made under section 34 of the Licensing Act 2003 ("the Act") to vary a premises licence in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of representations.

## **2 History of premises**

- 2.1 On the 2nd August 2005 an application was received to convert a Justices 'Off' licence. This application received no representations and was granted as applied for.
- 2.2 Various Dps and transfer applications have been received since the original grant of the premises licence.
- 2.3 On the 2nd June 2017 an application was received to extend the sale by retail of alcohol .
- 2.4 A copy of the existing licence is attached at **Appendix A.**

## **3 The application**

- 3.1 The applicant is Kanthasmy Mayuran, .

- 3.2 Briefly the application is to:

Vary the Sale by Retail of Alcohol hours from:

Monday to Saturday 08:00 – 23:00, Sunday 10:00 – 22:30

Sale by Retail of Alcohol            Everyday 24hrs

## **4 The operating schedule**

- 4.1 The applicant proposes to promote the licensing objectives by taking the additional steps identified in the operating schedule. A copy is attached at **Appendix B.**

## **5 Location**

- 5.1 A map which identifies the location of this premises is attached at **Appendix C**

## **6 Representations**

- 6.1 Under the Act representations can be received from responsible authorities or other persons. Representations must be relevant and, in the case of another person, must not be frivolous or vexatious.

### Representations from Responsible Authorities

- 6.2 Representations have been received from Environmental Health in their capacity as a responsible authority. Any representation may be negotiated prior to the hearing. In this instance the operating schedule has been amended to include the measures agreed with Environmental Health. A copy of the representation may be found at **Appendix D.**

### 6.3 Other representations

6.4 The application has attracted representations from members of the public (described as 'other persons' in the legislation).

6.5 Entertainment Licensing is in receipt of one letter of objection, which is opposed to this application on the grounds of public nuisance and anti-social behavior.

6.6 In order to protect personal data, redacted copies of the representations are attached at **Appendix E**. Unredacted copies will be available at the hearing for Members consideration.

## 7 **Licensing hours**

7.1 Members are directed to paragraphs 6.8 to 6.15 for the Statement of Licensing Policy which states the criteria that will be applied to any decision for new applications or variations which include extending hours.

7.2 In brief the Policy states at 6.14 that restrictions may be made to the proposed hours of use where, after receiving relevant representations, the council considers it appropriate for the promotion of the licensing objectives to do so. The council will take into account the existing pattern of licensed premises in an area when considering what is appropriate to promote the objectives. Applications which are significantly out of character for a locality will need to demonstrate that granting the hours sought will not impact on the licensing objectives.

7.3 A list of premises in the local area and their licensed hours and activities is provided at **appendix F**.

## 8 **Equality and diversity implications**

10.1 At the time of writing this report there were no implications for equality and diversity. Any decision taken by the licensing subcommittee will be in accordance with the four licensing objectives as prescribed by the Licensing Act 2003.

## 9 **Options available to Members**

9.1 The licensing subcommittee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:

- Grant the variation as requested.
- Grant the variation whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
- Reject the whole or part of the application.

9.2 Members of the licensing subcommittee are asked to note that they may not modify the conditions or reject the whole or part of the application merely because it considers it desirable to do so. It must actually be appropriate in order to promote the licensing objectives.

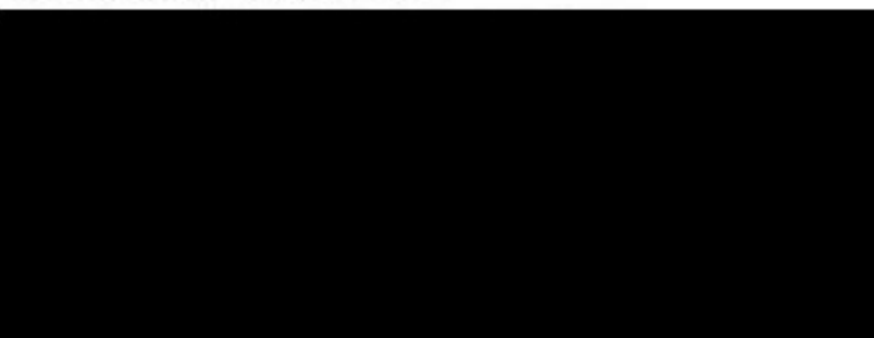

## Annex 1 – Mandatory Conditions

1. No supply of alcohol may be made under this licence
  - a. At a time when there is no designated premises supervisor in respect of the premises licence, or
  - b. At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
3. The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either -

- a. a holographic mark, or
  - b. an ultraviolet feature.
4. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

For the purposes of the condition set out in paragraph 1 of this condition -

- a. "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- b. "permitted price" is the price found by applying the formula  $P = D + (D \times V)$  where -
  - i. P is the permitted price,
  - ii. D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
  - iii. V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- c. "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
  - i. the holder of the premises licence,
  - ii. the designated premises supervisor (if any) in respect of such a licence, or
  - iii. the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- d. "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- e. "value added tax" mean value added tax charged in accordance with the Value Added Tax Act 1994.

Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

- (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

#### **Embedded restrictions**

5. Alcohol shall not be sold or supplied except during permitted hours.

In this condition, permitted hours means:

- a. On weekdays, other than Christmas Day, 8 a.m. to 11 p.m.
- b. On Sundays, other than Christmas Day, 10 a.m. to 10.30 p.m.
- c. On Christmas Day, 12 noon to 3 p.m. and 7 p.m. to 10.30 p.m.

6. The above restrictions do not prohibit:

- a. the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- b. the sale of alcohol to a trader or club for the purposes of the trade or club;

7. Alcohol shall not be sold in an open container or be consumed off the licensed premises.

**Describe any additional steps you intend to take to promote the four licensing objectives as a result of the proposed variation**

**a) General – all four licensing objectives (b, c, d, e) (please read guidance note 11)**

This premises is currently situated on Harehills Lane and has operated in a legal manner retailing alcohol for some time. This premises is one of a number of successful and well ran premises in the locality. The applicant has taken great measures to ensure that the management and the staff are aware of the need to continually risk assess the impact of any activities on the licensing objectives

**b) The prevention of crime and disorder**

A suitable Close-Circuit Television (CCTV) system will be operational at the premises at all times when licensable activities are being carried out and at any other times where members of the public are present on the premises or whilst being served at the hatch

The CCTV system will contain the correct time and date stamp information

The CCTV system will have sufficient storage retention capacity for a minimum of 31 days continuous footage which will be good quality

A designated member/members of staff at the premises will be authorised to access the CCTV footage and be conversant with operating the CCTV system

At the request of an authorised officer of the Licensing Authority or a Responsible Authority (under the Licensing Act 2003) any CCTV footage, as requested, will be downloaded immediately or secured to prevent overwriting

The CCTV footage material will be supplied, on request, to an authorised officer of the Licensing Authority or a Responsible Authority

The Supervisors Register will state the name of the person who is in overall charge of the premises at each time that licensed activities are carried out and this information will be retained for a period of twelve months and produced for inspection on request to an authorised officer

The Incident Report Register will contain consecutively numbered pages, the date time and location of the incident details of the nature of the incident the names and registration numbers of any door staff involved or to whom the incident was reported the names and personal licence numbers (if any) of any other staff involved or to whom the incident was reported the names and numbers of any police officers attending the police incident and/or crime number names and addresses of any witnesses and confirmation of whether CCTV footage of the incident

The Incident Report Register will be produced for inspection immediately on the request of an authorised officer

Between the hours of 23 00 and 06 00 hours the store will be closed to the public and service will take place through a hatch installed at the premises front. This area will be covered by CCTV

All members of staff retailing alcohol will be fully trained in the need to continuously risk assess the licensing objectives. Training will be delivered to a high standard in identifying drunks and conflict management the sale of age related products and the need to challenge when required. Training will be delivered on induction and every 6 months thereafter. The premises will have a concise policy manual that will address areas of concern that have an impact on the licensing objectives

**c) Public safety**

All emergency lighting will be checked weekly  
Entrances, Exits and Passageways are kept clear  
A fire risk assessment will be in place  
A fire prevention policy is in place

**d) The prevention of public nuisance**

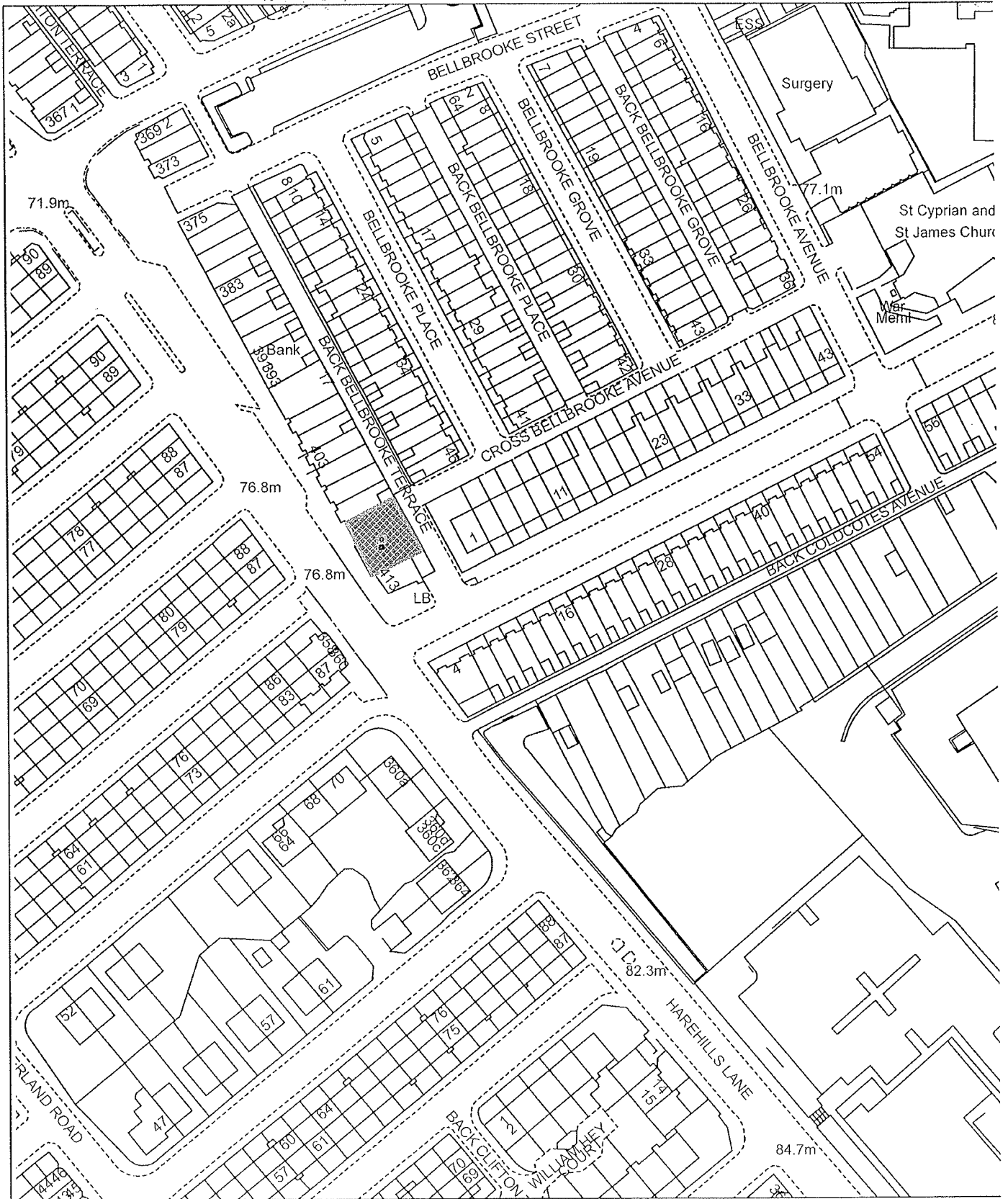
Prominent signs will be displayed requesting customers to have regard for local residents when leaving the premises  
Adequate bins are available for customers to dispose of litter  
A Public Nuisance policy is in place, staff will be trained as to its requirements and will sign a document in compliance to this

**e) The protection of children from harm**

All staff will ask for proof of age from any person appearing to be under the age of 25 who attempts to purchase alcohol at the premises. Only driving Licences, Passports or cards bearing the PASS logo will be accepted. Staff will be trained in challenging customers wishing to buy age related products. A responsible sale of alcohol policy will be in place and staff will sign to signify understanding and compliance  
A dated and sequential refusals register will be kept and maintained on all refusals  
Staff will be trained in the prevention of proxy sales

**Noise**

1. The security shutters on the Harehills Lane elevation of the business shall not be raised or lowered between 11pm and 7am the following day except for use in emergencies and to allow the access and egress of staff.

**Litter**

2. The PLH/DPS or authorised responsible person shall ensure that litter arising from people using the premises is cleared away regularly and that promotional materials such as flyers do not create litter.

3. Clear and legible notices will be displayed at exits and at the point of sale requesting patrons to leave the premises quietly having regard to the needs of local residents, in particular emphasising the need to refrain from shouting, slamming car doors, sounding horns and loud use of vehicle stereos and anti-social behaviour.

Thank you for your correspondence regarding my clients venue

I have read through the four additional conditions and I am happy for to accept them being added in addition to the current conditions I have highlighted the changes in red and explanations why there should be these changes below

- Prevention of public nuisance

#### Noise

- 1 The security shutters on the Harehills Lane elevation of the business shall not be raised or lowered between 11pm and 7am the following day except for use in emergencies and to allow the access and egress of staff

This allows staff changeover if necessary at end/start of duty

#### Litter

- 2 The PLH/DPS or authorised responsible person shall ensure that litter arising from people using the premises is cleared away regularly and that promotional materials such as flyers do not create litter

This ensures that in the absence of the PLH/DPS (when on leave or off duty, etc) then the actions can be taken by the staff member

#### Transport / Pedestrian Movement

- 3 Clear and legible notices will be displayed at exits and at the point of sale requesting patrons to leave the premises quietly having regard to the needs of local residents, in particular emphasising the need to refrain from shouting, slamming car doors, sounding horns and loud use of vehicle stereos and anti-social behaviour Agreed

- 4 The designated premises supervisor or authorised member of staff and any door supervisors will monitor the activity of persons leaving the premises and remind them of their public responsibilities where necessary

The reason for this additional line is that the condition demands that the DPS will have to be on duty at all times that the premises is open Since there can be only one DPSA associated with a premises at any one time I believe that this condition cannot be achieved without delegating this condition to an authorised member of staff

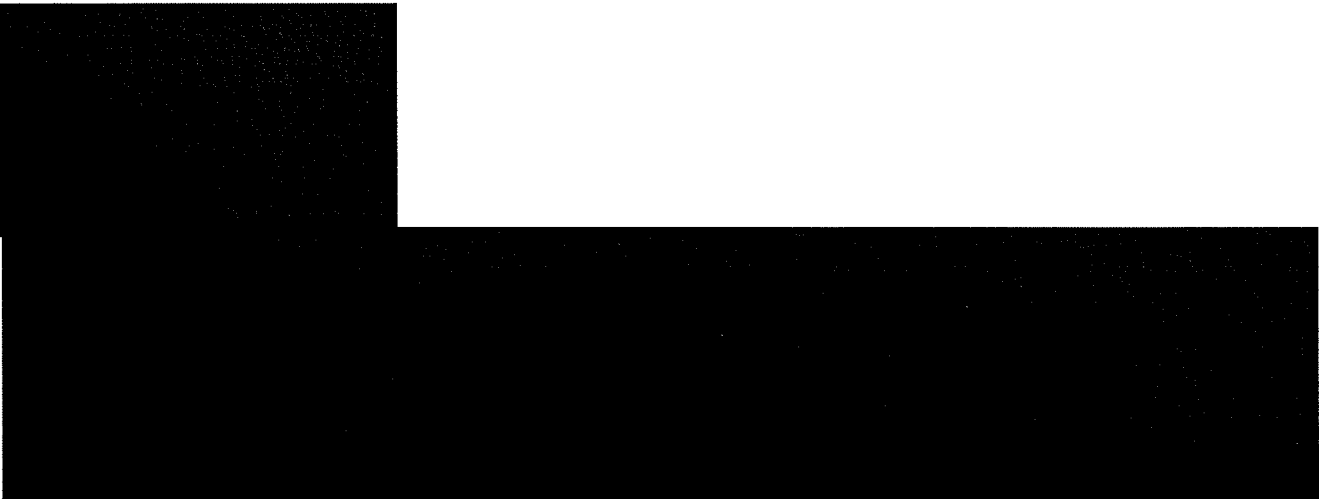

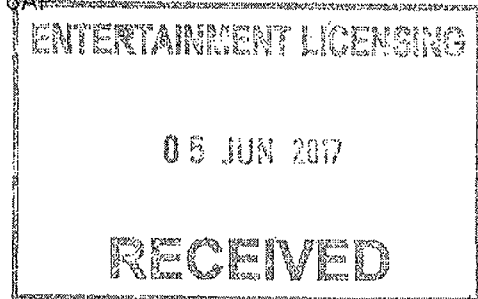

There is already significant public nuisance caused by another shop nearby which has a 24 hour licence (Misha Food and Drink on Foundry Approach).

I did explain in my objection that my concern relates to anti-social behaviour (i.e. a public nuisance). Already the shop on Harehills Lane attracts problems such as drivers on the pavement and I would expect this to worsen if the licencing hours were extended. Ditto the noise problem in the local area.
