Summary of main issues

This is an application for the grant of a premises licence, made by Mr Jean Bruno Kidiadi, for Chez Bisoo Bar & Restaurant 143 Harehills Road, Harehills, Leeds, LS8 5BW.

Responsible authorities and Ward Members have been notified of this application.

The application has attracted representations from responsible authorities.

1 Purpose of this report

- 1.1 To advise Members of an application made under section 17 of the Licensing Act 2003 ("the Act") for a new premises licence in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of representations.

2 History of the premises

2.1 These premises originally submitted a premises licecne application on the 15th September 2017 for the below licensable activities:-

Sale by retail of alcohol

Sunday to Thursday 11:00 - 23:30Friday and Saturday 11:00 - 03:30

Late Night Refreshment

Sunday to Thursday 23:00 – 23:30 Friday and Saturday 23:00 – 03:30

Recorded Music

Sunday to Thursday 10:00 - 23:00Friday and Saturday 10:00 - 03:30

This was amended on the 16th October as detailed in 3.3.

2.2 A Senior Liaison & Enforcement Officer from Entertainment Licensing has concerns that the applicant has stated in Part 3 – The Operating Schedule 'that Please note that similar activities were run on the same premises'.

Whilst there were certainly licensable activities taking place in September 2016, these were without the benefit of a licence and dealt with accordingly by the Entertainment and Licensing Section. Advice was given to the then occupier and the premises were regularly monitored resulting in the complaint being closed in October 2016 when no further offences were witnessed.

2.3 This section is aware of current issues at the above premises which have been brought to the attention of the respective responsible authority.

- The representation submitted by The Planning Department remains as a matter for Members consideration. A copy of the representation may be found at Appendix E.
- 6.6 The representation submitted by West Yorkshire Police remains as a matter for Members consideration. A copy of the representation may be found at Appendix F.

7 Licensing hours

- 7.1 Members are directed to paragraphs 6.8 to 6.15 of the Statement of Licensing Policy which states the criteria that will be applied to any decision for new applications or variations which include extending hours.
- 7.2 In brief the Policy states at 6.14 that restrictions may be made to the proposed hours of use where, after receiving relevant representations, the council considers it appropriate for the promotion of the licensing objectives to do so.
- 7.3 The council will take into account the existing pattern of licensed premises in an area when considering what is appropriate to promote the objectives. Applications which are significantly out of character for a locality will need to demonstrate that granting the hours sought will not adversely impact on the licensing objectives.
- 7.4 A list of premises in the local area and their licensed hours and activities is provided at Appendix G.

8 Equality and diversity implications

8.1 At the time of writing this report there were no implications for equality and diversity. Any decision taken by the licensing subcommittee will be in accordance with the four licensing objectives as prescribed by the Licensing Act 2003.

9 Options available to Members

- 9.1 The licensing subcommittee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
 - Grant the application as requested.
 - Grant the application whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
 - Exclude any licensable activities to which the application relates.
 - Refuse to specify the said person as the designated premises supervisor.
 - Reject the whole or part of the application.
- 9.2 Members of the licensing subcommittee are asked to note that they may not reject the whole or part of the application merely because they consider it desirable to do so. It must be appropriate in order to promote the licensing objectives.







1	Before opening to the public, checks will be undertaken to ensure all access to the premises are clear for emergency vehicles. Regular checks will be undertaken when the premises is open.
2	Written records of all accidents and safety incidents involving members of the public will be kept. These will be made available at the request of an authorised officer.
3	A suitably trained and competent person must ensure regular safety checks of the premises including decorative and functional fixtures, floor surfaces and equipment (including electrical appliances) to which the public may come into contact are undertaken. 4	Empty bottles and glasses will be collected regularly paying particular attention to balcony areas and raised levels.



Good afternoon

Thank you for the further information in support of your application, copy attached This information you have provided has been considered against the licensing objective of the prevention of public nuisance

We would make the following points

- 1 The primary use of the premises on this terrace is commercial at ground floor level with residential accommodation above. There are a number of residential units at first floor level and above which are highly likely be disturbed by your business activities.
- 2 You have mentioned the use of an acoustic engineer and the creation of false walls in terms of noise reduction. From a technical point of view, this would have practical and considerable cost issues to you. Additionally you have not actually provided any firm details of noise reduction proposals which can be considered.
- 3 Customers from your business are likely to use the public pavement outside your premises for smoking, socialising and access and egress. You have little control over the behaviour of these people and the affect this would have over residents.

For the above reasons and the information in our original report, we are unable to withdraw our objection



We refer to your licensing application for the above premises and our site meeting on 26 September 2017 We believe that your application does not give enough information about how you intend to meet an important objective of the licence, which is to prevent public nuisance We therefore confirm that we are submitting a formal objection to your application

We base our objection on the following matters

- The potential for noise disturbance associated with licensable activities passing through the fabric of the building to cause noise and vibration in adjoining residential/business premises
- The potential for noise disturbance associated with licensable activities to break out of the premises or pass through the fabric of the building to cause noise disturbance to nearby residential/business premises
- The potential for noise disturbance from the use of outside areas whilst smoking/drinking in the area/s provided/whilst arriving/leaving, including that from vehicles
- The potential for the alleged sources of nuisance described in the items above to continue into hours where such disturbance may adversely affect sleep and other loss of the use and enjoyment of a property

Description of the applicant venue and the application

The applicant premises are located over four storeys in the centre of a Victorian Terrace Properties either side consist of business use on the ground floor with residential accommodation above (see schematic in Appendix 1). This is the only building in the terrace which has been converted to solely commercial use.

The premises consist of

Noise

On the first and second floors there is living accommodation directly behind the party wall each side of the premises. This includes living rooms and bedrooms. The residents in these units would be subject to noise transmitted through the walls. Residents would also suffer from airborne noise from the venue. The windows in the building are single glazed units and would offer minimal resistance to noise. There are no visible signs of any noise insulation provision within the building.

Noise sources would consist of music including vocals and bass, raised voices and general disturbances from patrons

The residents in the flats in the rest of the terrace would experience noise from music and patrons

The business intends to allow smoking on the pavement outside along with placing tables externally near the door. This would cause a disturbance to nearby residents with their accommodation being only a few metres above.

Odour

The application includes provision for late night refreshment. The current kitchen facilities are basic and there is a potential to extend the cooking facilities to a covered external area. This is highly likely to cause issues with odour nuisance to adjoining properties.

Complaint and other history specific to the applicant premises

There are no noise complaints logged for this site with the current operator being here since August 2017 However the current mode of operation does not involve any licensable activities

Complaint history for the area around the venue

There are no similar venues in the area and therefore no comparable data is available

Conclusions reached

The proposed application, activities and hours of use at this site are totally incompatible with the residential accommodation in this area. Residents would suffer nuisance and sleep disturbance should this application be granted. We do not feel that any noise insulation scheme would be viable or practical at this location.

We recommend that the Sub-Committee refuse the application



Please note I am aware of the subsequent amendments to the application which have resulted in an extended consultation period and an extended deadline for any objections and representations

The details of the Police objections are set out below and this letter replicates the earlier objection dated 16 October 2017 The concerns expressed within this earlier objection still remain and are detailed as follows

West Yorkshire Police are of the opinion that your application contains insufficient information about how you intend to meet the licensing objectives

We therefore confirm that we are submitting a formal representation against your application on the grounds of

- 1 the prevention of crime & disorder
- 2 the prevention of public nuisance, and
- 3 the protection of children from harm

This is a full objection to your application. Your application appears to be for a three floor licensed premises in a busy residential area. The potential maximum occupancy will be sixty people over the

three floors and alcohol and food will be served to customers and space will be available for dancing on the second floor

There is insufficient in the application to show how the licensing objectives will be upheld. There is no risk assessment proforma attached to the application

It has been brought to my attention that this premises have already been operating without the authorisation of a premises licence. In part three of the premises licence application there is reference to the premises previously operating and offering the same facilities to the community. This is not the case

These premises have previously been visited by Leeds City Council and West Yorkshire Police Licensing Departments because of unauthorised licensable activities taking place at the venue. The previous tenant did discuss opening the premises and applying for a premises licence. However at the time of writing I am unaware of an application ever being received, until this application.

Residents have reported being disturbed by the unlawful licensable activities already taking place at the venue until 0300hrs. They also report that the owners are not receptive and existing premises and residents have been told to 'keep their nose out'

If the venue is granted a premises licence it is felt that this location will have a detrimental impact on the community in which they are situated. From what has been reported so far, the venue is already having an impact on its neighbours and it is intimidating at worst and unpleasant at best to be disturbed and told to mind your own business. This venue is not seamlessly integrating with the community and providing a service for the community without impacting on others.

West Yorkshire Police would ask a Licensing Committee to refuse this application in full

Describe the steps you intend to take to promote the four licensing objectives

a) General – all four licensing objectives (b, c, d, e) (please read guidance note 10)

The applicant is aware that the premises are situated within the city centre cumulative impact zone and has sought to address the licensing objectives carefully to take this into account. Mr Hussain has 30 years of experience in the provision of food to the public and has had 15/16 restaurant/shop outlets over that time, 10 of which have had late night refreshment licenses. He is acutely aware of his responsibilities as a premises license holder and the need to ensure that there is no crime and disorder or public nuisance as a result of opening this outlet and to maintain both public safety and the protection of children from harm

He proposes the detailed measures set out below will not impact upon the cumulative effect of opening within the red light area of the City Centre CIP. He is aware that new applications in the red zone area will only be granted in exceptional circumstances

He currently has several restaurants/takeaways in Leeds including Chicos Fast Food at 51d New Briggate, Leeds, Istanbul at 19 Merrion Street, Leeds and Nash's Fish and Chip Restaurant at 51c New Briggate Leeds Mr Hussain has always worked co-operatively with the police and licensing authority and will continue to do so with these premises

Mr Hussain intends to work from the premises. The manager will be his nephew, who has gained 5 years of experience working with Mr Hussain in the food takeaway business. He has knowledge and ability to deal with any customers who may be problematic, having held a hackney carriage license for 14 years and good links with local taxi operators and knowledge of where taxi ranks operators are, close to the premises, to assist in dispersing customers from the premises quickly after purchasing food.

Mr Hussain is fully conversant with the position of the premises in close proximity to pubs and clubs within the area. He has undertaken a risk assessment of the proposed premises in this context against the four licensing objectives

It is noted within the Statement of Licensing Policy that Leeds population is set to rise to around one million and that the increase in city centre residential and mixed use has many benefits including the creation of a vibrant 24 hour city

Thank you for submitting your application for the above premises, received at the address above on 16th August 2017.

The application relates to premises which fall within one of the areas of Leeds currently subject to a policy of cumulative impact, as detailed in the present Statement of Licensing Policy 2014-2018, issued by Leeds City Council as the licensing authority.

The area concerned in this particular case is Area 1 Leeds City Centre.

Therefore, in line with the current statutory guidance issued by the Secretary of State under Section 182 Licensing Act 2003, West Yorkshire Police make representations based on the Cumulative Impact Policy (CIP) of the area concerned and highlighted above, where the licensing objectives and particularly the prevention of crime and disorder and prevention of public nuisance objectives, are being adversely affected.

The proposed premises are located in the current <u>red zone</u> in the cumulative impact area. The Council's policy states:

7.20 "The council will seek to refuse <u>all applications in these red areas</u> on the basis that the impact on the licensing objectives are at such a level that the area cannot support any more premises opening or extending their hours no matter how impressive the concept or application is. <u>The council will only grant</u> applications in the red zone in exceptional cases", and

7.24 "It is the council's policy, on receipt of relevant representations, to

- Refuse new and variation applications in the red area
- To seek additional measures for new and variation applications in the amber area
- · To seek good quality applications for application sin the green area

7.25 "This applies to alcohol led premises such as bars, pubs, and nightclubs, and for premises seeking late night refreshment such as takeaways and late opening restaurants".

The location of these premises is in very close proximity to a multitude of other licensed premises in this area. It is an alcohol related violent crime hotspot for robbery, assault and theft. The peak time for crime is between midnight and 05:00 hrs. The majority of hours of operation applied for by the applicant, 23:00 until 04:00 Mon to Sunday, therefore fall right in to these peak times.

The latest analysis of crime data provided to Leeds City Council upon which the Cumulative Impact Policy is based shows that the Briggate/Call Lane area has experienced a 17% rise in reported crime since the last review of crime statistics a year ago. The peak times for crime in the Night Time Economy have also extended to 05:00hrs from 04:00hrs, and assaults and thefts have risen. The highest concentration of offences in the city remains in this area, and has slightly extended compared with the previous 12 months. The area is not improving – it is deteriorating – and this is the area where the applicant wishes to open a new business.

This is the second application by the same applicant for a premises licence at this address. The first application, objected to by this department, offered scant measures which suggested that the applicant had little or no idea of the issues in this area of the city after midnight. The first application attracted other objections and was withdrawn prior to being heard at a scheduled licensing hearing. The applicant is now represented by a licensing solicitor and is a better quality than the first with a multitude of measures offered – but the issue remains the same: this is an application for late night refreshment in the most problematic area of the city centre which is covered by a cumulative impact policy with the presumption that it shall be refused.

Extra police resources have to be deployed to this area on Friday and Saturday evenings, and over Bank Holiday weekends, in an attempt to help reduce the crime and disorder associated with people frequenting the large amount of licensed premises in the immediate area. These crimes/incidents range from thefts and robberies to public order offences, assaults, serious disorder and also sexual offences. An ambulance is also regularly parked at the junction of Briggate/Boar Lane and Duncan Street to help deal with the amount of injuries sustained due to assaults and accidents caused by over intoxication in the Night Time Economy (NTE). This is in an attempt to help reduce the strain which the NTE puts on the Accident & Emergency Department of the NHS.

The saturation of the area is such that determining which venues may bear some responsibility for the issues is practically impossible, and means that they cannot be dealt with by way of review or enforcement meetings. A strong Cumulative Impact Policy is therefore imperative to prevent already existing venues extending their licensable hours, and to prevent further premises licences being granted in that area which would add to the considerable impact already being felt.

In this new application mention is made of venues which the applicant already operates in the city centre – none of these are in the red zone of the CIP, and there is crime and disorder associated with Chickos in particular.

Much is made of the intended manager, the applicant's nephew, with years of experience and links with taxi opertaors to aid quick dispersal. This lower end of Briggate can be completely blocked by taxis, private hires and private vehicles in the early hours of the morning due to the volume of people and vehicles in the area. We have had complaints from late night bars about the issues with the taxis and vehicles pulling on to the pavement and collisions with pedestrians. If one has not seen this in person it is hard to imagine how congested it is. More people attracted to the area for food, and then needing a taxi to take them home, will only add to this problem. It is impossible to get a quick dispersal from this area at certain times of night and even the emergency services struggle to get through at times.

I will address some of the numbered points made in Section M of the application:

- 1. The fact the premises will not be supplying alcohol or be alcohol led is irrelevant they will be dealing with inebriated customers and all the issues associated with drunkenness, albeit they have not fed them the alcohol. The applicant's business, Chickos on New Briggate, also attracts inebriated customers in the early hours which has led to public order incidents in the past.
- 3. Any CCTV would be expected to retain footage for 31 days.
- 4. 2 door staff have been offered. Door staff are helpful but do not generally prevent issues when people are drunk they help deal with the outbreaks of drunken violence. So this would help deal with issues arising from the unit being open, but would not prevent them in the first place.
- 5. No glassware is a must.
- At 4am it is proposed that a cleaner is going to wash down the footpath outside this may well
 prove impossible given how busy the area will be, and I would have concerns for the cleaner's
 safety.
- 8. Already addressed
- 9. Already addressed
- 10. Signs are inadequate when dealing with people in drink.
- 11. Children should not be anywhere near this part of town after 11pm at night.
- 12. There will be no speedy dispersal of customers due to the congestion with taxis and private hires.

Therefore, in terms of location (RED ZONE), and in terms of applying for a new premises licence to provide late night refreshment from 23:00 until 04:00, West Yorkshire Police consider that this application implicates the current policy of cumulative impact for Leeds City Centre in the red area, and advise that it be refused, unless the presiding Sub-Committee are convinced that the grant of this licence will not negatively impact on the cumulative impact of existing licensed premises in the area.

Thank you for submitting your application for the above premises.

The area in which the subject premises is located in within a cumulative impact area. It is the council's policy, on receipt of relevant representations, to refuse new and variation applications in this area for alcohol led premises such as bars, pubs and nightclubs and for premises seeking late night refreshment such as takeaways and late opening restaurants, unless the applicant can demonstrate that their application would not impact on the cumulative effect of such licensed premises in the area.

Specifically your application falls within the red area of the City Centre CIP. As stated at 7.20 of the Statement of Licensing Policy 2014 to 2018 the council will seek to refuse all applications in these red areas on the basis that the impact on the licensing objectives are at such a level that the area cannot support any more premises opening or extending their operation no matter how impressive the concept or application is.

I refer you to 7.67 to 7.70 of the Policy which describes how, when considering the presumption against grant in a CIP area, the council will need to be satisfied that the grant of this variation will not impact on the cumulative impact of existing licensed premises in the area. It will be for you to advise the council how your application would allow Members to make an exception to the policy.

I also refer you to 7.69 of the Policy which describes examples of factors the licensing authority will not consider as meeting the standard of rebuttal include:

- That the premises will be well managed and run as all licensed premises should meet this standard.
- That the premises will be constructed to a high standard.
- That the applicant operates similar premises elsewhere, such as in another licensing authority area, without complaint.

I note that the application is for late night refreshment to 4am, 7 days a week.

You have provided a number of measures in Section M of the application that you believe address the issues operating a late night establishment in this area may experience. These are:

- · Food led premises
- · DBS checks for staff
- CCTV
- 2 door supervisors
- · No bottles or glasses to be used
- A full time cleaner for the premises who will clean the outside of the premises at the end
 of the business day
- Litter bins within the premises
- Provision of a telephone to ring a taxi if required, along with details of local firms
- Signs at exits
- No access to children
- Speedy dispersal of customers
- · Low plant and machinery noise

Late night refreshment applications are considered within scope of the CIP as they add to the cumulative impact of licensed premises in the area. Instead of dispersing away from the area, late night takeaways hold people in areas where there is already an accumulation of people. This area already suffers from an accumulation of people, most of whom are in drink, and who already have a significantly negative impact on the licensing objectives. Providing a takeaway in this location would not reduce the cumulative impact of licensed premises in the area but increase it.

Bearing in mind the severity of the problems being experienced in the area with this area suffering from the highest levels of violent crime and disorder incidences in the city centre, with an increase in the last 12 months of over 17% in this area, the Licensing Authority is of the opinion that despite your application offering a number of measures it still does not contain sufficient information about how your proposed business would not add to the impact already being experienced in the area.

The licensing authority requires good quality applications for any part of the city centre, as per the Statement of Licensing Policy (paragraphs 7.20 to 7.22), and to assist prospective applicants the licensing authority provides a cumulative impact assessment and a risk assessment proforma to guide them in proposing measures that mitigate against the issues being experienced in the area. Although this application includes some measures it does not adequately address the issues of how an area which is already suffering from the number of people using it, between 11pm and 5am, would not be impacted by a new premises whose customer base are those very people. The answer to reducing waiting times at McDonalds, which is slightly away from the red zone area, is not to provide another late night refreshment premises in the red zone area.

The applicant takes great store in his links to the local taxi trade and uses this connection to seek to reassure the Licensing authority of a speedy dispersal from his premises. This area of the city is extremely busy throughout the night with private hire and hackney carriage vehicles using all three lanes of Lower Briggate. This traffic has increased since the road closure on Call Lane, put in place to reduce the risk of harm and death from vehicles colliding with people who are in drink.

Even if there are strong links, and the Licensing Authority has no way of confirming this, it seems that the availability of taxis to disperse people away from the area will be impacted by the number of vehicles using this area now. Not only will this slow down dispersal from 5 Briggate, but the additional traffic may increase the traffic issue in this area.

Therefore the licensing authority submits a formal representation against your application on the grounds of the prevention of crime and disorder and will strongly recommend to the licensing sub-committee that this application is refused.



Cumulative Impact Assessment







Area 1 relates to the city centre. West Yorkshire Police has shared information and statistics that show that the nature of the city centre is such that the cumulative impact of licensed premises leads to problems that aren't experienced in other parts of the city and this can be attributed to the density of licensed premises in specific areas. The number and close proximity of venues on a street can result in difficulties in identifying individual premises as causing problems and so action planning and reviewing individual licences is not possible.

The closure or opening of businesses can have a dramatic effect on reported crime and incidents in an area. While problems at individual premises are dealt with using action planning and the review process, there are areas in Leeds city centre which become saturated as new businesses open or existing businesses change their style of operation.

In addition the council recognises that a previous problem area can be improved by the introduction of new styles of business types, such as food led premises and seeks to encourage this.

The dynamic nature of the city centre has created difficulties in setting a policy that will be relevant for five years until the next formal review of the Licensing Policy. Therefore the council has adopted an approach of designating areas within the city centre CIP as 'red' or 'amber' based upon an analysis of crime and disorder in the night time economy and will review these areas on an annual basis.

Areas that are considered highly saturated and that are experiencing particularly high levels of crime, disorder and/or nuisance will be designated as red areas. The policy states that the council will seek to refuse all applications in these **red areas** on the basis that the impact on the licensing objectives is at such a level that the area cannot support any more premises opening or extending their operation and that the council will only grant applications in the red zone in exceptional cases. Exceptional does not mean that an application is innovative or novel, but that it allows Members to make an exception to their policy. Those exceptional cases would be where the premises can demonstrate that they will not impact on the issues already being experienced in the area, i.e. by containing their operation within the hours of the daytime and early evening economy.

Any variation that will effectively increase the occupancy of premises will be viewed in a similar light to a new application as it may increase the available capacity in the same way a new premises in that area would, which in the red area would be unacceptable. Similarly new businesses seeking to introduce a new concept, and so attract different people into the area, may be acceptable in the amber area but in the red area the problems are exacerbated by the sheer number of people on the street during the peak hours and introducing a new or extended business, even with a different concept, would add to the impact rather than reduce it.

Management controls such as door staff will not be adequately effective in preventing an increase in the number of people within the red zone.

The **amber area** is an area which is of concern, based upon an analysis of issues within the night time economy that are relevant to the licensing objectives, and the council will expect applicants to offer additional measures tailored to the problems in that area. Applicants are strongly advised to consult with West Yorkshire Police and the licensing authority during their application process. By working together, the responsible authorities and businesses can establish working practices that reduce crime and disorder and so benefit the long term aims of the city to be a vibrant, thriving economy.

All other areas within the city centre CIP will be designated **green areas** where good quality applications will be generally be more acceptable even though the area is a CIP area.

It is the council's policy, on receipt of relevant representations, to

- refuse new and variation applications in the red area
- to seek additional measures for new and variation applications in the amber area
- to seek good quality applications for application in the green area

This applies to alcohol led premises such as bars, pubs and nightclubs, and for premises seeking late night refreshment such as takeaways and late opening restaurants.

Extra scrutiny is given to applications which appear to adopt a number of different styles during their trading. For example businesses that purport to be food led but seek late opening hours may be judged to be predominantly alcohol led due to their late night activities. It is for the applicant to demonstrate how their business will not impact on the licensing objectives.

Changes in the last year

There are two distinct areas in the city where extra police resources are deployed on a regular basis. These areas are the Call Lane area and the Albion Street/ Woodhouse Lane area. Premises in those areas deploy street marshals at their own expense as it has been recognised that incidents on the street require extra attention and that early intervention can prevent an escalation in the severity of incidents on the street.

As police resources are reducing each year, priorities have been realigned. There has been a small reduction in the number of arrests for drunk and disorderly but an increase in assault. The increase in assaults could be due to early intervention methods being cut back, such as the street marshalling scheme and intervention at an early level (i.e. arresting people for being drunk and disorderly), and so the low level offences are escalating to the more serious assault charge.

The issues with disorder in the street on Call Lane has led to a road closure between 11pm and 5am on the Friday, Saturday and Sunday night which took effect in October 2015. The sheer numbers of people, often intoxicated, in the street during these hours highlights the need for the overall capacity of the red area to decrease, not increase.

The Council continues to receive applications within the areas designated as red. There has been a trend for existing operators to apply for minor and full variations to bring into use areas which were unlicensed previously. In all cases the premises licence holder has undertaken to keep their capacity the same. However this trend for increasing the licensed area is concerning as the ability to control capacity is difficult. Any application seeking an increase in floor space, even without an increase in stated capacity, can expect close scrutiny.

Police Crime Reporting

West Yorkshire Police has produced a crime report "2016-10 Night Time Economy – City v4" dated October 2016 which has been referred to when reviewing the red and amber zones for 2017. This report is referred to as the Police report in this document. It uses reported crime figures from 01/09/2014 - 31/08/2016.

In 2014 Her Majesty's Inspectorate of Constabulary made recommendations to change crime recording practices. This resulted in an increase in the number of recorded crimes in West Yorkshire in 2015. Analysis of the changes in crime levels, along with a number of other measures, concluded that a proportion of these recent increases were related to administrative change rather than an increase in criminality. Specifically this change in recording practise has impacted on the level of 'violence against the person', in particular 'violence without injury' as many lower level offences were not previously being recorded.

The police report only compares statistics from the last two years, as the statistics are not comparable going further back than that due to the changes in the way in which crime is recorded.

The following data tables and key findings (signified by bullet points) have been extracted from the police report.

The tables clearly show that there has been in increase in crime across the city centre. The police report conclusions state:

- An analysis of the examined offences shows overall offending in the City Centre has increased by 13% compared with the previous examined period.
- During 01/09/2015 31/08/2016 Assaults and Public order offences have seen the highest increases in terms of volume compared with the previous year. Public Order and Robbery offences have experienced the greatest percentage change. The majority of the examined offences experienced an increase with the exception of Drunk and Disorderly and Murder / Manslaughter offences.
- Assaults and Thefts have the highest number of offences with a licensed premises flag and experienced the greatest increases during the period 01/09/2015 – 31/08/2016 compared with the previous 12 months.
- Assaults continue to be the highest alcohol related crime, followed by Drunk and Disorderly
 offences. Only Drunk and Disorderly and Theft Non Specific offences had a reduction.

- Assaults and Thefts are the top offence categories for both the day time economy and night time economy. For both time periods, the highest increases were in Assaults and Public Order offences.
- In both the examined periods there are more reports of 'off street' offences than 'on street'. The
 number of assaults occurring 'on street' or 'off street' are fairly similar in both years. There are
 slightly more assaults which occur 'on street'.

Street Level Data

The tables below relate to Leeds City Centre night time economy offending only (18:00 to 05:59) and show the top ten streets and the top ten streets of increasing concern for the night time economy offending. The table shows the percentage of the street compared with the city centre total as shown in Figure 5.

These clearly show that the Briggate and Call Lane areas are responsible for 35% of crime reported in the city in the last year. 15% of crime was reported in the other red area of Albion Street/Woodhouse Lane.


The police report conclusions were:

Call Lane, Briggate, Albion Street and Woodhouse Lane are the top streets for offending in the
night time economy for both examined periods. These streets are located within the two city
centre CIP red areas, supporting the view that both red areas should be maintained.

Red Area Comparisons

The stated crime figures and time analysis is taken from offences occurring within the red outlining square, between 18:00 – 05:59. Assaults, theft from person, theft non-specific, robbery and sexual offences have been included in this analysis.

The police report conclusions were:

- The Call Lane red area remains the predominant hot-spot area. Geo-spatial analysis shows the
 main risk area within the city centre is the area of Call Lane and Briggate. The highest
 concentration of offences remains in this area and has slightly extended compared with the
 previous 12 months, but still falling within the existing designated area. The peak time for
 offending in the Call Lane area is now 00:00 05:00.
- Within the Call Lane area, all the examined offences namely assaults, robberies, sexual offences and thefts have increased during 2015-2016 with assaults and theft from persons experiencing the largest gains.

Not only have all crimes increased in this area by 17%, the peak times have lengthened from midnight to 4am to midnight to 5am. The risk days have changed from Friday, Saturday and Sunday to Thursday, Friday and Saturday. Most worrying are the increases in assault and theft from person.

This shows not only how important it is that the number of people using this area during the night time does not increase but that it would be desirable for the number of people using this area during peak hours to reduce. Therefore any change to the current licences, either new premises or any increase in the operation of the existing premises should not have the effect of increasing visitors to the area.

Furthermore the Council will be investigating ways in which assault and theft can be reduced, in liaison with the operators and agencies.

In the last year the Licensing Authority has received three applications in this red area. One was for the lengthening of operating hours into the peak hours and was refused. The subsequent appeal was withdrawn before it was heard with all costs recovered from the appellant. Another application was received for a substantial increase in the size of the premises. The applicant agreed to a range of amendments to the application which took the operation of the additional area out of the peak hours for crime and disorder. The third was only partially granted but with the imposition of restrictive conditions.

Any operator seeking a variation to their current licence must be mindful of the problems being experienced in the area and must ensure that the additional measures they offer will result in no impact on the licensing objectives. A responsible operator will always be seeking ways in which they can contribute to the efforts made to reduce the crime statistics, and would not be satisfied with merely maintaining the status quo.

The police report conclusions were:

 Within the Albion Street / Woodhouse Lane Red area, the hot-spot areas have remained the same in both examined periods, specifically the bottom of Woodhouse Lane and top of Albion Street, as shown in Section 7.2. During the period 2015-2016 the peak time is 00:00 – 04:00, compared with 01:00 – 04:00 over the previous 12 months.

The licensing authority hasn't received any new or variation applications in the last year. However the overall 19% increase in crime and the lengthening of the peak hours is worrying.

As with the Call Lane/Lower Briggate area this shows not only how important it is that the number of people using this area during the night time does not increase but that it would be desirable for the number of people to reduce. Therefore any change to the current licences, either new premises or any increase in the operation of the existing premises should not have the effect of increasing visitors to the area.

Furthermore the Council will be investigating ways in which assault and theft can be reduced, in liaison with the operators and agencies.

Cross Belgrave Street / Merrion Street / New Briggate:

The following area is not a designated 'red area' in the existing CIP; although, it has been noted as an emerging area of popularity during the 'Night Time Economy'.

The police report conclusions were:

 Within the Merrion Street / New Briggate area the hot-spots have remained the same in both examined periods, as shown in Section 7.3. The peak time has extended from 01:00 – 02:00 to 01:00 – 04:00.

As reported last year, this area in Leeds has been developed in the north of the city and is proving very popular. The lengthening of the hot spot period and the overall 13% increase is in common with the two red areas. When compared to the other areas in the city, in figure 6, Merrion Street lies in 7th on both tables.

This area remains in the amber area this year, as this provides the most flexibility to negotiate with applicants regarding safeguards that can be put in place. However if crime levels increase further this area will be subject to further review next year and may face being placed in a red zone.

City Centre A&E Assault data

A&E data and road traffic incidents data are new additions to the review this year. The licensing authority was keen to see the crime statistics in context to ensure that the peak times for reported incidents was supported by other data specific to the night time environment.

The police report states A&E data was provided for the period 01/09/2014 - 31/08/2016. A notable proportion did not have a location address or did not specify an exact address, for example "on street" or "on bus". Assaults which could be attributed to occurring in the City Centre accounted for 12% of all assaults. Where the time of the assault could be ascertained, overall the peak time was 01:00 - 04:00, with secondary peaks between 23:00 - 01:00 and 04:00 - 05:00. 85% were recorded as being a male patient. Alcohol was the main contributing factor.

The police report conclusions were:

- Overall there are more day time economy road related incidents than during the night time. OPL (over the prescribed limit) and Road Related offences were higher during the Night Time Economy.
- During the NTE the main hot-spots for 2014-2015 for Road Related Incidents were around Woodhouse Lane and the Boar Lane / Briggate / Call Lane area. There was also a concentration of incidents in the vicinity of the Headrow / Westgate area.
- Overall during 2015-2016 the peak time for Road Related incidents is 13:00 18:00, there was a secondary peak between 02:00 03:00. The area reduced around Woodhouse Lane. The hotspot around Boar Lane / Briggate/ Call Lane remained, however the number of incidents in this area reduced compared with the previous 12 months. Boar Lane experienced an increase in Road Traffic Incidents, however incidents halved on Call Lane. This is possibly due to the road closure in effect since October 2015 on Call Lane between 11:00 05:00 on a Friday, Saturday and Sunday night.

Conclusion

With the police report conclusions in mind the Licensing Authority has determined that the red areas be maintained. Merrion Street/Cross Belgrave Street area and the Boar Lane areas will be closely monitored with a view to placing them in a red zone should the crime figures not improve in the next 12 months.

The increase in theft and violent crime in the two red areas is concerning. The council will work with the businesses and partners to establish if further work can be done to reduce these crime figures over the next 12 months.

The Licensing Committee will bear in mind that in the next 12 months there may be significant changes to the way late night levies can be introduced and may also consider the option of an early morning restriction order if these figures do not significantly reduce over the next 12 months.

Having taken all these matters into account the Licensing Sub Committee have agreed to

The reason for this decision is as follows:

The applicant attended the hearing and was represented by Mr Leo Charalambides, of Counsel. The application had attracted representations from responsible authorities as the premises are located within an area covered by a cumulative impact policy - specifically the Red Zone of the cumulative impact area for Leeds City Centre.

PC Cath Arkle of West Yorkshire Police, Ms Susan Holden of Entertainment Licensing and Mr Trevor Porter of the Council's Environmental Protection Team attending the hearing to comment upon their representations.

The application was for late night refreshment every day from 23:00hrs until 04:00hrs.

At the outset of the hearing there was an application made by PC Arkle to submit supplementary information from West Yorkshire Police. This was a document entitled "Leeds City Centre, Night Time Economy Related Crime 2017". It was clarified that this document had already been provided to the applicant's solicitor, and there being no objections to the inclusion of the information it was accepted.

In his opening remarks to the Licensing Sub Committee Mr Leo Charalambides challenged the status of the Council's Statement of Licensing Policy and queried how the Council had reached the conclusion of red, amber and green zones as referred to the Cumulative Impact Assessment, City Centre - December 2016, which was attached to the report at Appendix D. He questioned the lawfulness of the current assessment, map and zoning under the Licensing Act 2003. He also referred to alleged inconsistences in paragraphs 7.19 and 7.26 of the Council's Statement of Licensing Policy, to the collation of evidence and how the Cumulative Impact Assessments are conducted.

In response PC Arkle noted that the Police statistics related to what happens in the City Centre and due to the nature of the offences happening on the street, it is not possible to connect crimes to specific licensed premises. Ms Holden referred to paragraph 7.20 of the Statement of Licensing Policy, which refers to the dynamic nature of the City Centre area creating difficulties in setting a policy for the city centre that will be relevant for five years until the next formal review of the Policy. She referred to the updated information which is collated as part of the annual review.

Following an adjournment to consider the comments of Mr Charalambides and the responsible authorities the Licensing Sub Committee decided to adjourn the hearing until Tuesday 5 December 2017 at 2.00pm. The Licensing Sub Committee also directed that:

- No later than 25 October 2017 the Applicant to set out in writing the full basis of the challenge to the Council's Cumulative Impact Policy and for this to be served on all Responsible Authorities
- 2. No later than 8 November 2017 the Responsible Authorities to respond in writing to the Applicant's letter.

It was clarified that the Licensing Sub Committee could only consider any responses under paragraph 2 above from the Police, Entertainment Licensing and Environmental Protection Team in relation to this application at the resumed hearing.

Right of Appeal

There is a right of appeal to the Magistrates Court should you be dissatisfied with the decision made by the sub committee. You must make this appeal within 21 days of receiving this notice.

Submissions by the Applicant In respect of the Leeds City Council Statement of Licensing Policy

At the hearing of the application on the 10th October, 2017 the licensing sub-committee
having heard submissions in respect of the Leeds City Council Statement of Licensing
Policy determined to adjourn the hearing of the application to the afternoon of the 5th
December, 2017. The licensing sub-committee further directed that:

[1] Within 14 days of the hearing — by the Thursday 25th October, 2017¹ — the applicant to provide detailed submissions as to the challenge to the SLP and the CIP; these submissions to be served on all the responsible authorities; and

[2]14 days thereafter the responsible authorities to comment on the submissions.

The Local Statement of Licensing Policy

- Section 5(1) of the Licensing Act 2003 requires that each licensing authority must in respect of each five year period (a) determine its policy with respect to the exercise of its licensing functions and (b) publish a statement of that policy before the beginning of that period.²
- Further, s 5(4) provides that a licensing authority must keep its policy (in respect of that period) under review and make such revisions to it, at such times, as it considers appropriate.
- Section 5(3) provides that before determining its policy, the licensing authority <u>must</u> consult with:
 - The chief officer of police for the area;
 - The fire and rescue authority for the area;
 - Each local authority's Director of Public Health in England (Local Health Board in Wales);
 - Persons/bodies representative of local premises licence holders;
 - Persons/bodies representative of local club premises certificate holders;
 - Persons/bodies representative of local personal licence holders; and

- · Persons/bodies representative of businesses and residents in its area.
- 5. 'Subject to the statutory requirements, it is for each local authority to determine the extent of the consultation it should undertake, and whether any particular person or body is representative of the groups described in the 2003 Act.' (See s 182 Guidance, para 14.6). The Leeds City Council has consulted with a 'wide range of people and organisations' who are listed in paragraph 1.2 of the current 2014 edition of its Statement of Licensing Policy.
- 6. By virtue of s 5(5) the consultation requirements of s 5(3) apply in relation to <u>any</u> <u>revision</u> of an authority's statement of licensing policy as it applies to the original determination of that policy. The Editors of *Paterson's Licensing Act 2017* provide the following pointed commentary: 'Ie any changes to policy may only be made following consultation with each of the bodies which the local authority is at liberty to identify itself as being representative of the classes of persons specified.' (*Paterson's Licensing Act 2017*, 1.3504, fn 5).
- 7. The concept and application of cumulative impact is not [*] found in the Licensing Act 2003 but within the s 182 Guidance issued by the Secretary of State. A cumulative impact policy must be based upon evidence and consultation in compliance with the minimum statutory requirements of s 5(3) (see s 182 Guidance, para 14.28 and 14.29).3
 - [*] No Police and Crime Act 2017, Prt 7, s 141.
- 8. The Secretary of State further advises that: 'Once adopted, special policies should be reviewed regularly to assess whether they are needed any longer or if those which are contained in the statement of licensing policy should be amended' (s 182 Guidance, para 14.32). It follows that reviews and amendments are subject to the statutory consultation requirements in s 5(5):
 - 's 5(4): During each five year period, a licensing authority must keep its policy in respect of that period under review and make such revisions to it, at such times, as it considers appropriate.
 - s 5(5) Subsection (3) [Consultation requirement] applies in relation to any revision of an authority's policy as it applies in relation to the original determination of that policy.'

Leeds City Council Statement of Licensing Policy

15th January 2014 - 15th January 2019 Edition

9. The current edition of the Leeds City Council Statement of Licensing Policy ("Leeds SLP") was approved on the 15th January 2014. An amendment was approved in September 2016 to include a cumulative impact policy for Armley and to make small typographical changes. It is proposed that a new policy will be in place by 15th January, 2019.4

Leeds City Council Cumulative Impact Policy (General)

- 10. Section 7 of the SLP sets of the Leeds City Council Cumulative Impact Policy ("CIP") the general outline of which is set out at paragraphs 7.1 7.15. Paragraph 7.9 lists the six areas in which the CIP applies; these six areas are seemingly the subject of one CIP. These six areas include 'the city centre (Area 1)'. There is no definition nor accompanying map to show the extent and scope of Area 1 city centre.
- 11. Paragraph 7.4 sets out the effect of the policy which 'creates a rebuttable presumptions that applications within the designated cumulative impact area for new premises licences that are likely to add to the existing cumulative impact will normally be refused if relevant representations are received. It is for the applicant to demonstrate that their application will nor add to the cumulative impact of such licensed premises in the area.'
- 12. Paragraph 7.15 provides that 'the council will keep the cumulative impact areas under an annual review'. Further that applicants 'should contact Entertainment Licensing to ensure they are in possession of the latest information before making their application.'
- 13. Despite the policy commitment to an annual review of the cumulative impact areas there has been no annual review in compliance with section 5 of the 2003 Ac; save for the inclusion of the Armley CIP in 2016 (see Leeds SLP paras 1.1 and 7.13) and the 'amendments to the wording of the City Centre CIP to remove ambiguity' (see Leeds SLP 7.13). It is unclear whether Leeds City Council has one CIP effecting six areas or six CIPs in six separate areas; ambiguities abound. There seems to be a review of guidance documents which are not part of the Statutory Policy; indeed in the case of so-called Local Licensing Guidance (see below) the City Council accept that such guidance documents are not and cannot be part of the Statutory Statement of Licensing Policy.
- 14. The Leeds SLP (at para 7.15) seeks to incorporate 'the latest information' but does not define nor explain what is comprised in the 'latest information'.

- 15. Paragraphs 6.32 6.34 provide for 'Local Licensing Guidance'; Leeds City Council recognise that 'it cannot insist on applicants using the local licensing guidance when completing their operating schedules' (see Leeds SLP, para 6.34). The Leeds City Council makes reference to three documents called 'special guidance' and links to three documents: (i) Local Licensing Guidance, Inner West Leeds (LS 21); (ii) Local Licensing Guidance, Inner East (Gipton and Harehills) and (iii) Local Licensing Guidance, South Leeds (LS 10 and LS 11). The City Council accept that such guidance documents are not and cannot be part of the Statutory Statement of Licensing Policy.
- 16. This local guidance is not part of the statement of licensing policy and has not been consulted upon and reviewed in accordance with s 5 of the Act. The use of such external guidance documents undermines the clarity and certainty of the local statement of licensing policy.
- 17. The website also provides 'some guidance on the city centre cumulative impact policy'. This links to a document titled: 'Cumulative Impact Assessment, City Centre December 2016'. This too is an external guidance document that has not been consulted upon and reviewed in accordance with s 5 of the Act; it too undermines the clarity and certainty of the local statement of licensing policy. Such seemingly ongoing CIP assessment seeks to avoid and circumvent the clear policy aim to annual review the cumulative impact areas and to avoid and circumvent the clear statutory requirements for consultation in the event of such reviews.

Leeds City Council Cumulative Impact Policy (Area 1 - City Centre)

- 18. Paragraphs 7.16-7.26 of the Leeds SLP are concerned with the City Centre area of the CIP. Paragraph 7.16 states that: 'Area 1 relates to the city centre.' There is no map and no description setting out the extent, scope and boundaries of Area 1 (City Centre) of the CIP.
- 19. This lack of map and description is in stark contrast to areas 2-5 each of which (as the opening paragraph) provides a map and description setting out the extent, scope and boundary of each area (see Leeds SLP: area 2, para 7.27; area 3, para 7.34; area 4, para 7.41; and area 5, para 7.46). Area 6 Armley is said to relate to 'the main shopping areas of Armley, known as Armley Town Street and Branch Road. A map with a lined boundary (unreferenced within the text) is provided. There is no link between the text and the map. As Leeds City Council have recognised ambiguities need to be remedied by way of 'directed consultations' and evidently undermine the clarity, certainty and reliability of the local SLP.
- 20. At para 7.24 of the Leeds SLP the City Council provides: 'The current map and evidence is available on the council's website from Entertainment Licensing.' Given that the consulted and approved SLP does not itself contain neither a map nor a proper

description there can be no 'current map' as no such map (nor description) has been consulted upon or subsequently approved.

- 21. The website also provides 'some guidance on the city centre cumulative impact policy'. This links to a document titled: 'Cumulative Impact Assessment, City Centre December 2016'. This too is an external guidance document that has not been consulted upon and reviewed in accordance with s 5 of the Act; it is not clear whether this paragraph relates to local licensing guidance (Leeds SLP 6.32 6.34), the annual review (Leeds SLP, para 7.15), or the latest information (Leeds SLP, para 7.15). In any event it is entirely outside the statutory SLP.
- 22. At the initial hearing, on the 10th October, 2017, the Licensing Officer stated that it was for an applicant to check on the website for the map and details of the CIP. However, the documents are not part of the policy as originally consulted upon and adopted in 2014 nor do they form part of the directed consultations in early 2016 (Leeds SLP, para 7.13). There is no express incorporation of any external guidance, documents etc in the adopted SLP.
- 23. If there are omissions, ambiguities or other amendments that need to be incorporated into a SLP the proper course is to follow the statutory requirements set out in s 5 of the 2003 Act and not to adopt additional guidance which sit outside the officially adopted policy.
- 24. At the initial hearing, on the 10th October, 2017, the legal advisor to the subcommittee advised that the guidance documents were regularly reviewed in conjunction with the police. That the additional guidance documents were 'within and below' the SLP and that these documents were 'constantly under review'.
- 25. Neither the Licensing Officer nor the Legal Advisor were able to point to any portion of the officially adopted SLP where provision had been made for these additional documents and procedures (for procedures, see below).
- 26. The impression given by officers of the Council was that additional guidance and procedures were a private practice of review, amendment and designation between the Council and the West Yorkshire Police.

CIP presumption

27. The effect of the CIP is set out at para 7.4 of the Leeds SLP, however, within the vaguely designated Area 1 City Centre 'the council will adopt an approach of designating areas within the city centre CIP as 'red' or 'amber' upon an analysis of night time economy related issues that are relevant to the licensing objectives' (Leeds SLP, para 7.20). Later at para 7.23 a 'green area' designation is also introduced.

- 28. The Leeds SLP does not explain how the approach to designating areas within the city centre is to be undertaken nor the extent and scope of the analysis. Howsoever this designation is carried out the practical effect seems to be that areas within the vaguely defined city centre will be subject to differing and changing considerations; it seems to be the case that the designations are reviewed, amended, designated and agreed in private between the licensing authority and representatives of the West Yorkshire Police.
- 29. The Cumulative Impact Assessment, City Centre December 2016 document is based entirely on police data, evidence and submissions (even the A&E data is filtered through the police report). It is unclear to what extent the police report has been properly 'scrutinised' (cf. s 182 Guidance, para 9.12); insofar as the December 2016 guidance is concerned the evidence and conclusions of the police are accepted in their entirety.
- 30. These private determinations of policy and policy designations have far reaching consequences:
- 30.1 The general effect of the CIP as set out at para 7.4 is that the CIP creates a rebuttable presumption that applications will normally be refused unless the applicant can demonstrate that the application will not add to the cumulative impact of such premises in the area (Leeds SLP, para 7.4, see also paras 7.67 7.70 Rebutting the presumption against grant in a CIP area) seems to be set aside in favour of different tests.
- 30.2 In red areas the council adopts a policy that it will 'seek to refuse all applications in the red areas' (Leeds SLP, para 7.21, repeated at para 7.25). The effect of this policy is that on a seemingly annual basis the City Council will have privately(pre-) determined with the West Yorkshire Police that any designated red areas 'cannot support any more premises opening or existing premises extending their operation no matter how impressive the concept or application' (Leeds SLP, para 7.21 see also paras 7.67 7.70 Rebutting the presumption against grant in a CIP area). The City Council moreover will actively set its face against any applications 'and seek to refuse' all these applications in the red area. The statement that 'the council will only grant applications in the red zone in exceptional cases' (Leeds SLP, para 7.21) is a pithy attempt to poorly conceal what in practical effect is a blanket ban on new premises and variations in the designated red areas.
- 30.3 Overnight without notification or consultation a private cabal of council representatives and the West Yorkshire Police can designate an area within the city centre so as to effectively ban all new applications or variations.
- 30.4 In an amber designated area the council expects 'to offer additional measures tailored to the problems in the area' (Leeds SLP, para 7.22, repeated at para 7.25). While in a

- green designated area 'good quality applications will be generally more acceptable' (Leeds SLP, para 7.23, repeated at 7.25).
- 30.5 It is unclear to what extent the red, amber and green designations relate to the general position in respect of the CIP provided at para 7.4 of the SLP nor whether the policies at paras 7.67 7.70 (Rebutting the presumption against grant in a CIP area) (in particular para 7.69) apply.

Conclusion

- 31. The aim of the Leeds SLP is set out at para 1.13:
 - 'Applicants for premises licences should be aware of the expectations of the licensing authority and the responsible authorities as to the steps that are appropriate for the promotion of the licensing objectives, and to demonstrate knowledge of their local area when describing steps they propose to take to promote the licensing objectives. This policy seeks to provide advice to applicants about the approach they should take to making applications and the view the council is likely to take on certain key issues where representations are made.'
- 32. In many respects the Leeds City Council has failed to meet this aim.
- 33. There is a lack of clarity and certainty as to the exact definition and boundary of the CIP area 1 – City Centre. There is a substantial and significant issue as to the lawfulness of the area 1 CIP area.
- 34. There has been a failure to provide an annual review of the CIP in accordance with the local policy and the statutory requirements, yet further raising a substantial and significant issue as to the lawfulness of the CIP and of area 1 City Centre.
- 35. There is a lack of clarity and certainty as to the test applied in CIP area 1, being subject to private review, amendment and designation without consultation or scrutiny, yet further raising a substantial and significant issue as to the lawfulness and fairness of the CIP and of area 1 City Centre.
- Leeds City Council have sought to avoid and circumvent the clear requirements of s 5
 of the 2003 Act.
- 37. Leeds City Council have adopted a blanket ban in all but name and are actively engaged in seeking to oppose applications, having (pre-) determined that the City Centre 'cannot support' any more premises this is contrary to the scheme of the 2003 Act
- Leeds City Council are applying a SLP that is tainted by illegality, impropriety and irrationality and is in urgent need of review.

Options for the Licensing Subcommittee

39. It is submitted that, in the present circumstances, the proper course of action is for the licensing sub-committee to set aside the entirety of section 7 of the SLP (CIP) setting out its reasons for doing so. Further the matters set out herein ought to be brought to the urgent attention of the full licensing committee.
