#### **DANCERS WELFARE POLICY**

- Dancers and performers shall be provided with secure and private changing facilities.
- Dancers and performers shall be provided with private toilet/hand washing facilities.
- Dancers and performers can deposit any valuables with the management by way of a sealed/signed envelope, to be kept in a safe upon their arrival at the club and returned at the end of their shift.
- Each new dancer and/performer will be given a full and detailed induction upon their commencement of employment at the club. This will include all club rules, conduct, code of conduct, unit familiarity, fire evacuation procedures and health and safety. This will be documented by way of the company dancer/performers contract.
- Any dancer or performer who expresses a grievance with a fellow dancer or performer or a member of management or staff from the company will have the matter dealt with by way of the company's grievance policy.
- At the conclusion of a shift all performers will be provided with a company nominated taxi or escorted to their own transport by a member of security staff or management.
- All entrances to private areas to which members of the public are not permitted access shall have clear signage stating that access is restricted and/or a coded digital lock.

#### CONTRACT FOR SERVICES

**THIS CONTRACT FOR SERVICES** is made on the day of 2

BETWEEN: (1) Purple Door ("The Club") and

(2) ("Dancer")

#### DANCER

By signing this contract you are confirming that whilst you are providing dancing services to the Club you are doing so as a self employed Dancer.

#### You are obliged to:

- Act in a professional manner and in accordance with the club's code of conduct at all times.
- Make all reasonable attempts to work to the Club's opening times.
- Observe Health and Safety regulations regarding working hours and site security.
- Be responsible for the cost of repairs for damage to property of the Club or any third party.
- Pay your own Tax and National Insurance.
- Pay a floor fee, as agreed with the club, for each session services are provided.

#### You have the right to:

- Leave the site without permission (although you should notify the Club for Health and Safety reasons).
- End this contract without giving notice.
- Take legal advice before signing this contract, and to have a copy of it.

#### You do not have the right to:

- Holiday pay or sick pay.
- Take part in the Club's employee grievance procedure.
- Hold yourself out as being an employee of the Club.

By signing this contract you are agreeing to be bound by its terms and you are agreeing that these terms will govern the working relationship between you and the Club.

You are also agreeing that the terms of this contract represent the whole contract between you and the Club with the exception of any verbal negotiation about price or location of the services.

#### Club

The Club intends that in this working relationship you are an independent sub contractor.

#### The Club is obliged to:

• Provide all of the equipment used on their clubs either by employees or subcontractors as the Club takes its Health and Safety responsibility seriously.

#### The Club is not obliged to:

- Offer you any work. They may offer you the opportunity to provide your services but they are not obliged to.
- Pay any substitute or help hired by you to undertake the work.

#### The Club has the right to:

- End this contract without giving notice.
- Take legal advice before signing this contract.

#### The Club does not have the right to:

- Control the methods you use when you provide your services to the Club providing they apply with the terms and conditions of our licences and code of conduct
- First call on your services they cannot expect you to drop whatever you are doing to come and provide your services to them.

By signing this contract the Club is agreeing to be bound by its terms and you are agreeing that these terms will govern the working relationship between the Club and you.

The Club is also agreeing that the terms of this contract represent the whole contract between you and the Club with the exception of any verbal negotiation about price or location of the services.

#### General

This Contract is governed by the laws of (England, Wales, Scotland or Northern Ireland) as appropriate and is subject to the non-exclusive jurisdiction of the (English, Welsh, Scottish, Northern Irish) Courts.

Breach of any clause or clauses in this contract will not void or annul this Contract for Services as a whole in any circumstances.

I will provide Purple Door with my accountant's details.

I have adequate and appropriate insurance to include a valid public liability certificate, a copy of which shall be available to the company upon request. And hereby indemnify the company in respect to any claims.

#### Management Rules

#### Effective immediately

#### **Breaks**

Cigarette breaks will now be given once an hour, you need to go to the back on designated area. You are to wear the coats provided. Only 2 girls can smoke at anytime. Once an hour is loosely based this is if customer numbers and staff availability allows it. Under no circumstance may you take yourself without permit ion.

#### Mobile phones

Mobile phones may not be used on the floor they must remain in your bag or in the office; use during the night is for emergencies only.

#### Partner's friend's visits

You may not receive visit from friends during the night if either friends or partners are picking you up they may only arrive 30 minutes before closing and must not distract you from work.

#### Early finishes

You finish work when the club closes do not ask to go home unless under a valid reason through the week we close at 4 am at weekends we close at 5 am you may get changed when the last customer has left during that time you remain on the floor.

#### Pole dances

It is included in the job description that you are required to dance on the pole from time to time it is understood you may be inexperienced or nervous you will be given a period of grace to overcome this but eventually you will have to take part.

#### **Arrivals**

Whatever time we open you are required to be on the floor ready to work for said time therefore please arrive at least 15 minutes prior to allow time to get changed, hair makeup etc, for example if we open at 10 pm you should be in the building for at least 9.45pm and back in the bar area for 10pm or earlier, should there be consistent lateness then fines will be imposed.

#### Dress codes

#### There is dress code

We like you to bee in long dresses until midnight after that you can change to something shorter but not just underwear but please be sensible about it, don't reveal more than you have to.

Allow a customer to touch you with their hands, mouth or tongue Penetrate any part of your body with anything

#### **Code of Conduct - Dancer**

- 1. **THE CLUB** will be open 30 minutes before the doors open. Dancers will be expected to be at the club at least 15 minutes prior to the start time. Dancers must be on the floor at the time agreed for the evening's performance. Dancers are requested that they sign-in on arrival and sign-out on leaving. To avoid a late cancellation fine please text 07547434443 no later than 5pm to tell them if you cannot attend your shift.
- 2. **ANY QUERIES** as to appropriate clothing, hair, make-up and jewellery should be referred to the Club Manager.
- 3. **DANCERS are** asked to arrive and leave the club quietly. These are terms and conditions of our licence.
- 4. DANCERS MAY NOT give out their telephone number or any contact information to any customer, accept any telephone number or contact information from any customer or otherwise make any arrangements whatsoever to meet a customer off premises. A dancer may provide a customer with the days and shifts they are working at the club.
- 5. **DANCERS SHALL NOT** be intoxicated though drink or drugs on the premises at any time. Intoxicated dancers will have their contract for services terminated immediately and will be removed from the premises.
- 6. **DANCERS SHOULD REFRAIN** from chewing gum and smoking is NOT permitted inside the club

#### 7. DANCE:

- i. Stage Performances during any public stage performance dancers will be topless.
- ii. Booth Performances nude booth performances will be for a maximum of 4 customers and are on the basis of a number of dances. When a booth is chained off no dances may be undertaken in that booth. Dancers are not allowed to unchain and open booths.
- iii. Sit Downs these will also take place in booths but are on the basis of half an hours dancing and may involve more that one dancer.

- 8. IF A CUSTOMER ATTEMPTS to touch or speak to a dancer inappropriately during a booth performance, the dancer may cease the dance, and explain the club rules to the customer. If necessary the dancer should ask for assistance from security.
- 9. **SELLING OF ANY** form of sexual favours is prohibited and shall result in the immediate termination of the dancer's contract for services with FORBIDDEN CLUB with immediate effect.
- 10. ACCEPTING A CUSTOMER'S offer of payment in return for sexual favours, whether or not the dancer has any intention of carrying them out, will result in the immediate termination of the dancers contract for services with FORBIDDEN CLUB.
- 11. **LEWD AND LASCIVIOUS BEHAVIOR** is not permitted with in any of the clubs and such conduct will result in the immediate termination of the dancers contract for services with. Purple Door
- 12. ALL CLUBS have a zero tolerance policy regarding the illegal use and selling of drugs. Any dancer who is witnessed or is known to be under the influence of, or found to sell, or be in possession of an illegal drug will have their contract for services with Purple Door terminated immediately. The dancer will also be escorted from the premises and/or reported to the appropriate authorities.
- 13. **DANCERS** are asked not to have spouses or boyfriends visit any of the clubs on the night that the dancer is performing.
- 14. **DANCERS** are required to sign a disclaimer that they have no previous convictions for sex or drug offences.
- 15. **ALL DANCERS** will pay the appropriate floor fee. If the dancer arrives after 10pm, the floor fee is £30.
- 16. Purple Door employs extensive use of recorded CCTV, which is reviewed on a regular basis.
- 17. Purple Door **WILL REQUIRE** proof that you have the intention of paying your own tax and national insurance. A letter from your accountants will meet this requirement.

#### CUSTOMER CODE OF CONDUCT

At The Purple Door we want you to have the best experience possible. Due to our licensing conditions we have a few rules that we ask you adhere to whilst enjoying your visit to our club.

- 1) Any person must be seated before a dancer can commence a dance, and must remain seated during the dance.
- 2) There must be no touching of the dancers at anytime during the dance.
- 3) No propositioning the dancers.
- 4) Customers must not dance at any time.
- 5) The customer must remain fully clothed during a dance.

## ANY BREACH OF THESE RULES WILL RESULT IN THE CUSTOMERS EXCLUSION FROM THE CLUB.

We hope that you have a pleasant time here with us and continue to return so if you require anything please do not hesitate in contacting a member of staff.
