Yes. The main equalities issue is the question of who benefits from economic growth? This has been a topic for discussion at the Leeds Sustainable Economy and Culture Board. The report sets out the position that Leeds City Council is seeking to develop an approach to economic growth that is sustainable and inclusive, addressing problems of worklessness, deprivation and low pay.
