2. Please provide a brief description of what you are screening

This screening has been carried out for the contract for the supply of frozen foods. This contract will run from 06 August 2014 to 05 August 2017.

Catering Leeds provides a school meals service within schools to pupils in Leeds. The school meals are prepared daily on site. . Frozen foods are is an essential component of a balanced diet. In the past many of our pupils are eligible for free school meals where it is a legal requirement to provide a meal meeting the government's nutritional guidelines.

From September 2014 the government is introducing the Universal Free School Meal (UFSM) for all school children at Key Stage 1.

The tender will follow the procurement process which includes consideration of equality. Specifically this considered the group of pupils who would be receiving meals, how they would receive them and meeting any specific needs. The meals are supplied to young people, some with special dietary needs as well as some disability, religious and cultural requirements.

There is a requirement for some halal, and this is included within other contracts as well. Any successful supplier will have demonstrated through the tendering process their ability to provide halal items. With frozen foods the possibility of cross contamination is greatly reduced.

There is currently no demand for Kosher meat within the schools covered by this contract. If this demand arose we would be able to look at provision and we will be monitoring demand throughout the contract period.

There is a requirement for some limitations for children with special dietary needs. However, this is more restricting access to certain products, rather than asking for specialist produce.

All menus are checked by the services lead officer for the appropriate nutritional values and ensure a well balanced diet is provided at all times.

The provision of a full range of meals should have a positive impact on provision within schools. The procurement process will determine that any supplier is capable of providing items required for diets both restricted due to health and restricted due to religion. This will include confidence in both authenticity and traceability of supply.

Regular review meetings will be held as part of the contract management process
