- 1.1. Leeds Community Equipment Service (LCES) provides the right equipment quickly to enable people to live independent inclusive lives.
- 1.2. Leeds Community Equipment Service is an integrated service between Adult Social Care (ASC) and Leeds Community Healthcare (LCH) delivering all aspects of equipment for health and local authority customers of all ages in Leeds.
- 1.3. LCES oversees all aspects of relevant staff training, information and advice to actual and potential users of equipment, service development and the storage, delivery, installation, collection and cleaning of community equipment.
- 1.4. Equipment is delivered and installed in people's homes at the request of a

- range of people who assess patients' needs, such as occupational therapists, district nurses, physiotherapists and others. The equipment is also delivered to hospitals and other stores to be taken to service users' homes
- 1.5. The intention is to have an overarching Section 75 agreement between the commissioning partners (the Leeds NHS CCG's and LCC) and relate this to a potentially broad range of jointly commissioned services
