There is a proposal to set aside £160k from the Housing Revenue Account to address elected member concerns relating to non-urgent works required to trees within housing areas. The funding will be used to establish a team of staff to address non-urgent tree works mainly in tenant gardens.				
This will address issues affecting health, wellbeing and quality of life for the residents where the works would not meet the normal priority assessment process under the tree risk management approach.

We have established that there are almost 3500 outstanding requests for non-urgent works held by the Forestry section of Parks and Countryside. Currently these would not be addressed creating a cause for concern to residents who may well contact elected members who in turn would make representation on behalf of constituents. No equality data relating to enquiries is currently captured as part of corporate reporting procedures.

The Tree Risk policy assigns actions based on the risk of the tree's failure (partial or whole) to decide on the required actions and timescales. Equality factors would have no influence on current response.

The proposal is to undertake works to address access to light where this is a health and wellbeing concern and to improve TV and satellite reception where no engineered solution is suitable.

Key findings

The criterion to select works set out above provides a clear basis for selecting tasks to be completed. These will address health and wellbeing and quality of life concerns for relevant residents. The funds available will not allow the service to remove entirely the existing backlog of requests however in many cases these would not be acceptable for tree cultivation reasons under any circumstances.

The service will seek to encourage more active citizen engagement by encouraging tenants to take more responsibility for tree management as appropriate.
