In order to make best use of resources and to fit with the changes to both the youth offer and the youth offending service the service will be re-commissioned and merged with PAYP. The services will work with a younger client group this is due to the change of focus of the youth service and the Youth Offending team. The service will be city wide so there and will be able to focus on areas that maybe considered high crime.

The service is a targeted service to children at risk of antisocial behaviour or offending. It impacts positively on cohesion and integration. The referral process prioritises the following groups of young people:

- Risk of entering care or being accommodated by voluntary agreement with parents

- Not in education, employment or training
- At risk of becoming NEET through permanent exclusion or regular truanting.
- At risk of offending or antisocial behaviour
- Significant police involvement with other family members/ or involved with a negative peer group.
