Summary of main issues

- 1. These proposals aim to address the problems and concerns raised by the Killingbeck & Seacroft Councillors and the elderly residents of Nos. 61 to 67 Farm Road about the inability for the residents, their visitors and their medical help to be able to park in close proximity of their properties.
- 2. The purpose of this report is to seek approval to carry out a small element of kerbing/footway works and the introduction of Resident Permit Parking on Farm Road as shown on the attached drawing no. TME/20/1/93/1; and the advertisement of the draft Traffic Regulation Order and, if no valid objections are received, to make, seal and implement the Order as advertised.

Recommendations

- 3. The Chief Officer (Highways and Transportation) is requested to:
 - i) note the contents of this report;
 - ii) approve the proposals to carry out a small element of kerbing/footway works and the introduction of Resident Permit Parking on Farm Road, Crossgates, as shown on the attached drawing number. TME/20/1/93/1, at a total cost of £10,000 funded by the elected members through injection into the Traffic Management Revenue budget; and

iii) instruct the City Solicitor to advertise the draft Traffic Regulation Order to introduce residents only parking on a section of Farm Road, as shown on drawing number TME/20/1/93/1 and, if no valid objections are received, to make, seal and implement the Orders as advertised.

1 Purpose of this report

1.1 The purpose of this report is to seek approval to carry out a small element of kerbing/footway works and the introduction of Resident Permit Parking on Farm Road as shown on the attached drawing no. TME/20/1/93/1; and the advertisement of the draft Traffic Regulation Order and, if no valid objections are received, to make, seal and implement the Order as advertised, all being funded from the Traffic Management Revenue budget.

2.0 Background information

- 2.1 Farm Road is a narrow road running from the A6120 Station Road into the Poole estate, serving Crossgates library, a large residential area and Crossgates Children's Centre, but is subject to wide footways, with the footways along the frontages of the properties in question being approx. 5m wide.
- 2.2 Over the past 12 months complaints and concerns have been raised by the Killingbeck & Seacroft Councillors and the elderly residents of Nos. 61 to 67 Farm Road about the inability for the residents, their visitors and their medical help to be able to park in close proximity of their properties.
- 2.3 Due to the close proximity of Farm Road, to the central shopping area of Crossgates, parking is restricted in the whole area with a mixture of limited waiting, permit parking and on this particular length of Farm Road, a No Waiting At Any Time restriction along the frontages of the residential properties.

3 Main issues

3.1 Design Proposals and Full Scheme Description.

- 3.1.1 These proposals aim to address the complaints and concerns that have been raised by the Killingbeck & Seacroft Councillors and the local elderly residents and their families about the lack of on street parking adjacent to Nos. 61 to 67 Farm Road.
- 3.1.2 In order to provide an element of parking for the elderly residents of Nos 61 to 67 Farm Road, it is proposed to introduce a dropped kerb along the full frontage of these properties and Resident Permit parking to enable the residents, their visitors and their medical help to be able to park in close proximity of their properties.

- 3.1.3 The total estimated cost of the required highway works is £10,000 comprising £500 works costs and £3,500 staff fees and advertisement costs, funded by the elected members through injection into the Traffic Management Revenue budget.
- 3.2 **Programme** Subject to approval being granted, it is proposed to design the scheme in the 2013/14 financial year and advertise the draft Traffic Regulation Order and implement the actual works in the 2014/15 financial year.

4 Corporate Considerations

4.1 Consultation and Engagement

- 4.1.1 Ward Members and the Local MP were consulted on the proposals by email on 8 January 2014. The Ward Members were in full support of the proposals and eager to see the proposals implemented in order to address the concerns of the Farm Road residents. The Ward Members were also instrumental in arranging funding for this scheme to take place.
- 4.1.2 West Yorkshire Police, WYMAS, West Yorkshire Fire Service and Metro were consulted on the proposals by email on 8 January 2014. West Yorkshire Police have no objections to the proposals. No other adverse comments were received from the emergency services.
- 4.1.2 The local residents of Farm Road were consulted by letter in 6 February 2014. As some of the residents are the original complainants they are in favour of the proposals and the prospect of being able to park along the frontage of their properties.

4.2 Equality and Diversity / Cohesion and Integration

4.2.1 An Equality, Diversity, Cohesion and Integration Screening (Appendix 1) was carried out in February 2014 which found the following positive and negative impacts;

Positive Impacts

 Providing on Resident Permit parking along the frontages of Nos. 61 to 67 Farm Road so that the elderly residents, some with disabilities, their visitors and their medical help are able to park within the vicinity.

Negative Impacts

- Objections could be raised, however in order to negate any negative impact that the proposals may raise, any objectors will be made fully aware of the legitimate need of the elderly residents, their friends, family and medical help to be able to park on Farm Road.
- 4.2.2 Whilst the proposals will provide on street parking specifically for the elderly residents of Nos. 61 to 67 Farm Road, should any negative impact be raised via objections, the objectors will be made fully aware of the legitimate need of the elderly residents, their friends, family and medical help.

4.3 Council policies and City Priorities

4.3.1 Local Transport Plan (LTP): The proposals contained in this report are in accordance with Local Transport Plan 3 - Strategic Approaches:

Connectivity: P18. Improve safety and security

- 4.3.2 Disabled/Mobility: The proposals will provide a positive aid to the elderly residents especially disabled and will assist the ability for these residents to be able to travel to local amenities via help from their friends and family.
- 4.3.3 Ethnic minorities and women: This report has no implications for ethnic minorities or women.

4.4 Resources and value for money

4.4.1 Full scheme estimate

4.4.2 Costs for the scheme are as follows: Works £5,000 Legal fees £3,000 Staff fees £2,000

The funding for this scheme can be met by the elected members through injection into the Traffic Management Revenue budget 2014/15.

4.5 Legal Implications, Access to Information and Call In

4.5.1 The scheme is in the Annual Programme and subject to approval is programmed to be completed in the 2014/2015 financial year.

4.6 Risk Management

4.6.1 There are no risks over and above those expected when working on the public highway.

5.1 These proposals aim to address the complaints and concerns that have been raised by the Killingbeck & Seacroft Councillors and the elderly residents of Nos. 61 to 67 Farm Road about the inability for the residents, their visitors and their medical help to be able to park in close proximity of their properties.
