- 3.1 As part of the 2013/14 budgetary process Schools Forum agreed to retain a budget of £1,000,000 to support schools in financial difficulty.
- 3.2 Schools Forum previously agreed that all applications, should be considered by a panel of the School's Forum and that recommendations from that panel would be submitted to the Chief Officer (Strategy, Commissioning and Performance), who has delegated responsibility on behalf of the Director of Children's Services of Leeds City Council, for a formal decision to be made.
- 3.3 The panel consider the applications, all of which were to fund costs of commuted pensions arising from schools undertaking a Managed Staff Reduction process. The panel recommended that £441,356 be allocated to various schools as tabled in the report to Schools Forum on 26 June 2014.
