


DELEGATED DECISION NOTIFICATION

SUBJECT ⁱⁱ :	Approval for a contract variation under Contracts Procedure Rules (CPRs) 21.6 and 21.7 to vary the contract awarded to Carers Leeds from 1 st April 2014. The value of the contract is to be varied by an increase of £149,750 per annum from 1 st October 2014 in order to incorporate the service provided by Alzheimers Leeds to carers of people with dementia.
DECISION DETAILS ⁱⁱⁱ :	<p>The Deputy Director, Adult Social Care, approved the contract variation of CPRs 21.6 and 21.7 to vary the contract awarded to the consortium of organisations led by Carers Leeds. The variation is within the scope of the original contract and does not materially affect or change the scope of the original contract or the contract term. The value of the contract consortium led by Carers Leeds is to increase by £149,750 per annum from 1st October 2014 in order to incorporate the service provided by Alzheimers Leeds to carers of people with dementia.</p> <p>The Carers Commissioning Officer will ensure that the necessary action is taken to vary the Carers Leeds contract so that Alzheimers becomes a sub-contractor to Carers Leeds and enters into a contract to deliver dementia carers support services to Carers Leeds. When the two organisations have completed their negotiations and entered into a subcontracting relationship Leeds City Council will vary the main contract with Carers Leeds with effect from 1st October 2014.</p>

^v If the decision is exempt from call-in a reason must be provided in the 'Notice / Call-In' box and in the report. The call-in period expires at 5pm on the 5th working day after publication. Scrutiny Support will notify decision makers of matters called-in no later than 12 noon on the 6th working day.

^{vi} If the decision would have been a Key decision but for an exception set out in Article 13.2.1, please refer to the connected Key decision in the decision details (either by the title or the reference number).

^{vii} All Key decisions should appear on the List of Forthcoming Key Decisions for 28 clear days before the decision can be taken. If 28 clear days' notice has not been provided, a reason must be provided here.

^{viii} No Member having a disclosable pecuniary interest or officer having an interest in any matter (whether pecuniary or otherwise required to be declared) should take a decision in relation to that matter. Other interests of a non-disqualifying nature should be recorded here. Any dispensation in place in relation to the matter should also be recorded here.

^{ix} This may include other elected Members, officers, stakeholders and the local community.

^x Please include proposed timescales for commencement and / or completion of implementation as appropriate.

^{xi} Please insert a complete telephone number whether land line or mobile, rather than an extension number so that you can be contacted from outside the Council.

^{xii} The signatory must be duly authorised by the Lead Director to make a decision in accordance with the relevant sub-delegation scheme. It is not acceptable for the signature to be 'pp' for the authorised signatory. For Key decisions only, the date of the authorised signature signifies that, at the time, the officer was content that the decision should be taken. However, should representations be received following public availability of reports the signatory will consider the effect which such representations should have on the final decision.
