## LEEDS CITY COUNCIL (TRAFFIC REGULATION) (NO. 6) ORDER 2006

### GRANGEFIELD ROAD STANNINGLEY LEEDS

Leeds City Council (hereinafter referred to as "the Council") in exercise of the powers contained in Sections 1 and 2 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act") and of all other powers so enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and with those persons and organisations specified in the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 hereby makes the following Order:-

#### **DEFINITIONS**

1. For the purposes of this Order "motor vehicle" has the same meaning as in Section 136 of the 1984

# POINT CLOSURE (WITH EXEMPTIONS)

- 2. Save as provided in Article 2 of this Order no person shall cause or permit any motor vehicle proceeding in the road specified in Column 1 of the Schedule to this Order to pass the point specified in relation to that road in Column 2 of the said Schedule
- 3. Nothing in Article 2 of this Order shall apply if the motor vehicle is a motor vehicle being used for the purpose of gaining access to or egress from land or buildings on or adjacent to the length of road specified in Column 1 of the said Schedule


### **GENERAL**

- 4. The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the 1984
- 5. For the avoidance of doubt any reference in this Order to a length of road shall be deemed to be a reference to more than one length of road where the context requires it
- 6. This Order is made on the day of June 2006 and shall come into force on the 2<sup>th</sup> day of June 2006 and may be cited as the "Leeds City Council (Traffic Regulation) (No.6) Order 2006".
