#### Summary of main issues

1 This report seeks approval to incur expenditure and undertake the detail design and implementation of a zebra crossing at the location of Queensway near to its junction with Wellington Street, Morley.

#### Recommendations

- 2 The Chief Officer (Highways and Transportation) is requested to:
  - i) note the contents of this report;
  - ii) approve the detailed design and implementation of a scheme to introduce a zebra crossing at the location of Queensway near its junction with Wellington Street, as shown on the attached drawing number TMW/26.3/1974.02
  - iii) give authority to incur expenditure of £22,000 comprising £15,000 works costs and, £7,000 staff costs funded from the LTP Transport Policy Capital Programme;

iv) give authority to display a notice on site under the provisions of Section 23 of the Road Traffic Regulation Act 1984 in order to inform the public of the proposed zebra crossing; and

#### 1 Purpose of this report

1.1 The purpose of this report is to seek approval for the detailed design and implementation of a scheme to introduce a zebra crossing facility at the location of Queensway, Morley.

### 2 Background information

- 2.1 The Council received a request for a formal crossing facility at the location of Queensway/ Wellington Street, where currently, there is a build-out with informal crossing points.
- 2.2 There is an high number of pedestrians crossing at this location throughout the day. A contributory factor is the presence of the leisure centre, a park, a supermarket and other local amenities within the vicinity. Vehicular movement are high due to access to off street parking facilities and the pedestrianised high street.
- 2.3 Following a pedestrian crossing survey, the results were included in the Pedestrian Crossing Review 2014. The associated report approved on 18 March 2014 recommended introducing a zebra crossing at this location.
- 2.4 It was envisage that a humped zebra crossing would meet the criteria for this particular location, however following a recent speed survey which was carried out on the 07 August 2014. The survey revealed an average speed of 23.4mph. Thus dismissing the idea for a humped zebra crossing facility.

### 3 Main issues

## 3.1 **Design Proposals and Full Scheme Description.**

- 3.1.1 It is proposed to introduce a zebra crossing at the same location as the existing informal crossing point.
- 3.1.2 Some minor footway improvements works will be required to the surrounding area along with some improvement works to the existing drainage system to incorporate the new crossing.
- 3.1.3 The existing build-out will be the position of the proposed zebra crossing. There are existing parking facilities between the build-out and the new zig zag markings, it is proposed that this area will be hatched to prevent parking in that area and so increase visibility for pedestrian.
- 3.1.4 It is envisaged that the works will be carried out within the 2014/2015 financial.
- 3.1.5 The proposals are shown on drawing number TMW/26.3/1974-02.
- 3.1.6 The objective of this proposal is to make it safer for pedestrians to cross Queensway on their way to and from local amenities.

## 4 Corporate Considerations

### 4.1 **Consultation and Engagement**

- 4.1.1 Ward Members: Morley South Ward Members were consulted by email on the 26 March 2014. Replies have been received by all of them who are all fully supportive the proposal.
- 4.1.2 Emergency Services and Metro (WYPTE): The Emergency Services and Metro were consulted by email on the 26 March 2014. The Police had no objections. The other emergency services and metro had no objections.

## 4.2 Equality and Diversity / Cohesion and Integration

An Equality, Diversity, Cohesion and Integration Screening (Appendix 1) has been carried out on the proposals and has determined that an impact assessment is not required for the approvals requested. The Pedestrian Crossing Review was also referred to as part of the equality process.

The screening process identified the following positive impacts:

- The crossing will provide a safe crossing point enabling all pedestrians to safely cross a busy road which will be of particular benefit for people with mobility issue; the elderly; carers supporting wheelchairs or pushchairs and parents with young children.
- This crossing facilitates the safe movement of pedestrians going to the local amenities including the leisure centre and the shopping precinct
- The crossing will include tactile paving and dropped kerbs which will alert people who are visually impaired, that they are approaching a road crossing point.

## 4.3 Council policies and City Priorities

- 4.3.1 Environment Policy: The proposals contained in this report are in accordance with Aims 6 and 7 of the Policy in that the proposals will aid to "reduce the impact of traffic in the city by changes to the road system" and "develop a safe, healthy local environment which provides the best quality of life for Leeds residents.
- 4.3.2 The proposal contributes to the policies in the West Yorkshire Local Transport Plan 2011-26 (Chapter 4, Strategy p67), as follows: Proposal 18. Improve safety and security, seeking to minimise transport casualties.

## 4.4 Resources and value for money

4.4.1 The cost of design and implementation will be £22,000, consisting of £15,000 works costs and £7,000 staff design fees, funded from the LTP Transport Policy Capital Programme.

These measures also benefit carers supporting wheelchairs and pushchairs; people who are visually impaired, and disabled people.

Negative: The introduction of humped zebra crossing along a route used by buses could have an adverse effect on the ride comfort of passengers.
