Summary of main issues

- 1 Local residents made a request, via a Ward Member, for consideration to be given for a crossing facility on Town Street, Farsley, near the Cooperative Society building.
- 2 A pedestrian and vehicle volume survey was undertaken to ascertain the need for a crossing and the results were put forward for consideration during the pedestrian crossing review. The site was subsequently approved for the implementation of a zebra crossing.
- 3 This report seeks approval to incur expenditure and undertake the detailed design and implementation of a zebra crossing facility on Town Street, Farsley. The total cost of this scheme is estimated to be £30,000; made up of £22,000 works costs and £8000 staff costs and will be funded from the LTP Transport Policy Capital Programme.

Recommendations

- 4 The Chief Officer (Highways and Transportation) is requested to:
 - i) approve, subject to public consultation, the detailed design and implementation of a scheme to introduce a humped zebra crossing facility on

Town Street, Farsley, as shown on the attached drawing number TMW/8/1967/10 at an estimated cost of £30,000;

- ii) give authority to display a Notice on site under the provision of Section 23 for the Road Traffic Regulation Act 1984 to inform the public of the proposed zebra crossing; and
- iii) give authority to incur expenditure of £ 22,000 works costs and £ 8,000 staff design fee costs to be funded from the LTP Transport Policy Capital Programme.

1 Purpose of this report

- 1.1 The purpose of this report is to seek approval for the detailed design and implementation of a scheme to introduce a zebra crossing facility on Town Street , Farsley; to advertise the proposed crossing on site in the form of a Section 23 Notice.

2 Background information

- 2.1 Farsley Town Street is located within the Calverley/Farsley Ward and is a single carriageway road currently subject to a speed limit of 30mph at the point where a crossing is proposed to be located.
- 2.2 Local residents made a request to Ward Members, for consideration to be given for a crossing facility on Town Street, near to the Cooperative Society close to the junction of Croft Street and Well Street.
- 2.3 A pedestrian and vehicle volume survey was undertaken to ascertain the need for a crossing and the results were put forward for consideration during the pedestrian crossing review. The site was subsequently approved and a design brief was received for the implementation of a zebra crossing.
- 2.4 Within the latest five year period, there have been no recorded injury accidents in close proximity to the proposed crossing site.

3 Main issues

3.1 Design Proposals and Full Scheme Description.

- 3.1.1 The location of the proposed zebra crossing has been given consideration with regards to the pedestrian desire lane, visibility and parking requirements.
- 3.1.2 Ward Members expressed concern about the possible loss of on street parking in the area as a result of the crossing installation. A site meeting has taken place with Members to ascertain the optimum location and suitable site has been identified that has no adverse effects on parking during daytime.
- 3.1.3 The eastern side of Town Street has a single yellow line “working day” restriction, No Waiting Mon-Sat “8am to 6pm”, so the introduction of zig zag markings will preclude parking during the evening. However, evening parking does not appear to

be a problem on Town Street; there are parking bays on the western side which are unaffected by the proposals.

3.1.4 The proposals are shown on drawing number TMW/8/1967/10.

3.1.5 The objective of this proposal is to improve the local environment by providing a safe crossing point.

3.2 Programme

3.2.1 It is anticipated that the proposal will be implemented in the financial year 2014/2015.

4 Corporate Considerations

4.1 Consultation and Engagement

4.1.1 Ward Members: Ward Members were consulted on the 19 March 2014 and they fully support the scheme.

4.1.2 Emergency Services and Metro (WYPTE): The Emergency Services and Metro were consulted on the 19 March 2014. No objections have been received .

4.2 Equality and Diversity / Cohesion and Integration

4.2.1 A screening document has been prepared and an independent impact assessment is not required for the approvals requested.

4.2.2 The crossing will be provided with tactile paving to assist those with sight issues by identifying a safe place to cross. These measures also benefit carers supporting wheelchairs and pushchairs; people who are visually impaired and disabled.

4.2.3 The scheme provides a new formal crossing facility that gives precedent to pedestrians over vehicular traffic. This benefits all pedestrians but particularly those with mobility issues, the visually impaired, carers supporting wheelchairs and pushchairs who can now cross with confidence for their safety.

4.3 Council policies and City Priorities

4.3.1 The proposal contributes to the policies in the West Yorkshire Local Transport Plan 2011-26 as follows:

Proposal 18 – Improve safety and security, seeking to minimise transport casualties.

Proposal 22 - Define, develop and manage networks and facilities to encourage cycling and walking.

4.3.1 Safety Audit: Full Safety Audits will be carried out on this proposal and any recommendations received will be given full consideration and responded to.

4.4 Resources and value for money

4.4.1 The cost of the scheme implementation is £30,000 and will be made up of £22,000 works costs and £8,000 staff design fee costs to be funded from the LTP Transport Policy Capital Programme.

- **Key findings**

Positive Impacts of the Scheme

- Tactile paving will also be provided at the crossing points and these assist those with sight issues by identifying a safe place to cross. These measures also benefit carers supporting wheelchairs and pushchairs; people who are visually impaired and disabled.
- The scheme provides a new formal crossing facility that gives precedent to pedestrians over vehicular traffic. This benefits all pedestrians but particularly those with mobility issues, the visually impaired, carers supporting wheelchairs and pushchairs who can now cross with confidence for their safety.
- The crossing will be built out on one side which reduces the crossing width at a pedestrian desire line across a road. This improves safety by reducing the amount of time taken to cross the road and reducing the amount of time a pedestrian is exposed to traffic. This benefits people with mobility issues, young and older people, carers supporting wheelchairs and pushchairs.

The scheme is in line with the findings of the Pedestrian Crossing Review EDCI Assessment
