#### Summary of main issues

- 1. The Citroen Berlingo 5 by Automotive Group has been tested against Leeds City Council's Standard Conditions attached to a Wheelchair Accessible Hackney carriage Vehicle Proprietors Licence. **Appendix A.**
- 2. The purpose of this report is to consider the application for a variance to section 4.8.8 of the Standard Conditions attached to a Wheelchair Accessible Hackney Carriage Vehicle Proprietors Licence.
- 3. The vehicle was re-inspected by the Taxi & Private Hire Licensing Section on 11 September 2014 and failed to meet condition 4.8.8 (step height dimensions).
- 4. A similar variation was previously the subject of an application from Cab Direct/Allied Vehicles . This variation was approved in July 2007.
- 5. The vehicle meets all other criteria for licensing as a Wheelchair Accessible Hackney Carriage Vehicle Proprietors Licence.

#### Recommendations

 It is recommended that the application be approved for the Citroen Berlingo 5 by Automotive Group to be included on the approved list for Hackney carriage Wheelchair Accessible Vehicles.

# 1 Purpose of this report

1.1 To consider a request by Automotive Group for the inclusion of their Citroen Berlingo 5 on the approved list of Wheelchair Accessible Hackney Carriage Vehicles to be licensed by this Authority. **Appendix B.** 

# 2 Background information

- 2.1 The vehicle was inspected by the Taxi & Private Hire Licensing section on 24 June and failed to meet the conditions required. (**Appendix A** – Conditions attached to Wheelchair Accessible Hackney Carriage Vehicle Proprietor Licence.)
- 2.2 The members of the Access Committee for Leeds<sup>1</sup> were consulted on the application.
- 2.3 The inspection carried out by Taxi & Private Hire Licensing Section highlighted various reasons for rejection and included comments from the Access Committee for Leeds in a letter dated 28 July 2014 to Automotive Group. **Appendix C**.

# 3 Main issues

- 3.1 A re-inspection was carried out by the Taxi & Private Hire Licensing Section on 11 September 2014 and the vehicle failed to meet condition 4.8.8. of the Conditions attached to a Wheelchair Accessible Hackney Carriage Vehicle Proprietor Licence. The vehicle meets all other criteria for licensing as a Wheelchair Accessible Hackney Carriage Vehicle.
- 3.2 Condition 4.8.8 states:
  - "4.8.8 Distance between 1<sup>st</sup> step and vehicle floor 310mm required range 120 200mm (step height dimension).
- 3.3 This was previously the subject of an application from Cab Direct/Allied Vehicle to allow a variance to the condition 4.8.8 which was approved on 30 July 2007.
- 3.4 For this vehicle to be approved as a Wheelchair Accessible Hackney Carriage Vehicle, a variation under delegated powers would need to be grated as the vehicle model does not fully comply with the Conditions Attached to Wheelchair Accessible Hackney carriage Vehicle proprietors Licence.

5.1 The vehicle model and type does not fully meet the conditions required to be licensed as a Wheelchair Accessible Hackney Carriage Vehicle. As a variance to Condition 4.8.8 has already been approved in respect of a previous application by Cab Direct/Allied Vehicles in July 2007 there is no reason why a variance cannot be approved in respect of the Citroen Berlingo 5 vehicle by Automotive Group.
