1 Purpose of this report

- 1.1 The purpose of this report is to update the Committee on recent and proposed changes in its membership.

2 Background

- 2.1 In March 2011, the Joint Health Overview and Scrutiny Committee (Yorkshire and the Humber) – the JHOSC – was specifically established to consider the Safe and Sustainable Review of Children’s Congenital Heart Surgery Services in England and respond to proposed services changes and reconfiguration options.
- 2.2 The establishment of the JHOSC received unanimous support from the 15 top-tier local authorities across Yorkshire and the Humber and its membership has reflected this position since that time. However, due to the extended period that the JHOSC has been functioning and the features of member appointments/ nominations, specific membership has changed over time.
