Summary of main issues

- A request was received from Abbey Grange Academy for consideration to be given for a crossing facility on Butcher Hill primarily to assist pupils crossing between the school and the playing fields.
- A meeting was held between the school and council officers to discuss this request and issues they have experienced. Following this meeting and site observations it was agreed that a zebra crossing would be appropriate in this location and the site was subsequently approved in the pedestrian crossing review.
- This report seeks approval to incur expenditure and undertake the detailed design and implementation of a humped zebra crossing facility on Butcher Hill, Kirkstall. The total cost of this scheme is estimated to be £25,000; made up of £18,000 works costs and £7,000 staff fee costs. A £10,000 S106 contribution from the school will be made and £15,000 will be funded from the LTP Transport Policy Capital Programme.

Recommendations

- 4 The Chief Officer (Highways and Transportation) is requested to:
 - i) approve, subject to public consultation, the detailed design and implementation of a scheme to introduce a humped zebra crossing facility on

- Butcher Hill, Kirkstall, as shown on the attached drawing number TMW/22/1963/1 at an estimated cost of £25,000;
- ii) give authority to publish a Section 23 Notice under the Road Traffic Regulation Act 1984, to inform members of the public of the proposed crossing;
- iii) request the City Solicitor to advertise a Notice for the humped zebra crossing traffic calming measure on Butcher Hill, Kirkstall as shown on drawing TMW/22/1963/1 and if no valid objections are received to implement the proposals as advertised;
- iv) give authority to incur expenditure of £18,000 works costs and £ 7,000 staff design fee costs, which will be part funded from a Section 106 receipt £10,000 and also from the LTP Transport Policy Capital Programme £15,000.

1 Purpose of this report

1.1 The purpose of this report is to seek approval for the detailed design and implementation of a scheme to introduce a humped zebra crossing facility on Butcher Hill, Kirkstall; to obtain authority to advertise a 90c Notice and to obtain authority to advertise the proposed crossing on site in the form of a Section 23 Notice.

2 Background information

- 2.1 Butcher Hill is located within the Kirkstall Ward and is a single carriageway road currently subject to a speed limit of 30mph at the point where a zebra crossing is proposed to be located.
- 2.2 A request was received from Abbey Grange Academy for consideration to be given for a crossing facility on Butcher Hill primarily to assist pupils crossing between the school and the playing fields. A crossing point will also improve accessibility to the existing bus stop.
- 2.3 A meeting was held between the school and council officers to discuss this request and issues they have experienced. Following this meeting and site observations it was agreed that a zebra crossing would be appropriate in this location.
- 2.4 A pedestrian and vehicle volume survery was undertaken to ascertain the need for a crossing and the results were put forward for considertation during the pedestrian crossing review. The site was subsequently approved and a design brief was received for the implementation of a zebra crossing, subject to funding being identified.
- 2.5 The Section 106 contribution from the school is related to the development of a new 6th form block and will be payable at the start of the development.
- 2.6 Within the latest five year period, there have been no injury collisions within 100 metres of the proposed crossing site.

2.7 As part of the current programme of 20mph schemes, the section of Butcher Hill outside of the school is proposed to have a 20mph speed limit introduced in the financial year 2014 / 2015. Traffic calming features are proposed to be introduced on Butcher Hill and therefore consideration is being given to introduce a humped zebra at this location, subject to consultation, to compliment the 20mph scheme.

3 Main issues

- 3.1 Design Proposals and Full Scheme Description.
- 3.1.1 It is proposed to introduce a humped zebra crossing, subject to consultation, on Butcher Hill, between the school and playing grounds.
- 3.1.2 As part of the works, a short section of footway link will be provided from the zebra crossing to the playing fields entrance.
- 3.1.3 The proposals are shown on drawing number TMW/22/1963/1
- 3.1.4 The objective of this proposal is to improve the local environment by providing a safe crossing point.

3.2 **Programme**

3.2.1 It is anticipated that the proposal will be implemented in the financial year 2014/2015, subject to the Section 106 funding becoming available.

4 Corporate Considerations

4.1 Consultation and Engagement

4.1.1 Ward Members: Ward Members were consulted on the 20 March 2014. Ward members have expressed support for the scheme.

4.1.2 Emergency Services

and Metro (WYPTE): The Emergency Services and Metro were consulted on the 20 March 2014. No objections have been received.

4.2 Equality and Diversity / Cohesion and Integration

- 4.2.1 A screening document has been prepared and an independent impact assessment is not required for the approvals requested.
- 4.2.2 Tactile paving will be provided at the crossing points and these assist those with sight issues by identifying a safe place to cross. These measures also benefit carers supporting wheelchairs and pushchairs; people who are visually impaired and disabled.
- 4.2.3 The scheme provides a new formal crossing facility that gives precedent to pedestrians over vehicular traffic. This benefits all pedestrians but particularly those with mobility issues, the visually impaired, carers supporting wheelchairs and pushchairs who can now cross with confidence for their safety.

4.3 Council policies and City Priorities

4.3.1 The proposal contributes to the policies in the West Yorkshire Local Transport Plan 2011-26 as follows:

Proposal 18 – Improve safety and security, seeking to minimise transport casualties.

Proposal 22 - Define, develop and manage networks and facilities to encourage cycling and walking.

4.3.1 Safety Audit: Full Safety Audits will be carried out on this proposal and any recommendations received will be given full consideration and responded to.

4.4 Resources and value for money

4.4.1 The cost of the scheme implementation is £25,000 and will be made up of £18,000 works costs and £7,000 staff design fee costs to be part funded from a Section 106 contribution (£10,000) and also from the LTP Transport Policy Capital Programme (£15,000).

 - approve, subject to public consultation, the detailed design and implementation of a scheme to introduce a humped zebra crossing facility on Butcher Hill, Kirkstall, as shown on drawing number TMW/22/1963/1 at an estimated cost of £25,000;
 - ii) give authority to publish a Section 23 Notice under the Road Traffic Regulation Act 1984, to inform members of the public of the proposed crossing;
 - iii) give authority to advertise a Notice for the road hump that conforms with the Highways Act 1980 (90c Notice); and
 - v) give authority to incur expenditure of £18,000 works costs and £7,000 staff design fee costs, to be part funded from a Section 106 receipt £10,000 and also from the LTP Transport Policy Capital Programme £15,000.

The screening focuses on a report to the Highways and Transportation Board requesting authority to construct a humped zebra crossing.				

Butcher Hill is located within the Kirkstall Ward and is a single carriageway road currently subject to a speed limit of 30mph at the point where a zebra crossing is

proposed to be located.

Main issues

- It is proposed to implement a zebra crossing on Butcher Hill with tactile paving and associated lining in order to improve pedestrian movements. A short footway link will also be provided between the zebra crossing and playing fields access.
- As part of a current programme of 20mph scheme, the section of Butcher Hull outside of the school will be reduced to 20mph.
- Associated lining with the Zebra crossing will be implemented to ensure the correct behaviour of motorists will be adopted.
