Please provide a brief description of what you are screening This report sets out the key issues effecting the sustainably of 258 Lidgett Lane, LS17 6QE, a large Victorian semi-detached property, which vests with Environments and Housing, which has been split in to 4 x bedsits and 1 x 1 bedroomed flat. 258 Lidgett Lane has problems with subsidence, which has caused significant structural issues, which would be costly to address. This report sets out and evaluates a range of options for this property and puts forward a recommended preferred option, which is to dispose of this property on the

open market.
