**Summary of main issues**

This is an application for the grant of a premises licence, made by Garforth Cricket & Social Club, for Garforth Cricket And Social Club, Church Lane, Garforth, Leeds, LS25 1HB

Responsible authorities and Ward Members have been notified of this application.

The application has attracted representations from members of the public.

## **1.0 Purpose of this Report**

- 1.1 To advise Members of an application made under section 17 of the Licensing Act 2003 ("the Act") for a premises licence in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of representations.

## **2.0 History of Premises**

This is the first application under the Licensing Act 2003 for a Premise Licence. The premise currently benefits from a Club Premise Certificate which was granted in 2005. Due to declining membership which is affecting the viability of the Club, a premise licence has been applied for. This would allow the public to attend functions and not be restricted to members of the club and bona fide guests.

- 2.1 The Club Premise Certificate allows the premise to carry out the following activities:

Supply of Alcohol, Live Music, Recorded Music, Performance of Dance and Entertainment of a Similar Description:

Monday – Saturday:	11:00 – 23:00
Sunday:	12:00 – 22:30

#### **4.0 Other matters relevant to the application**

7.1 Carolyn Victoria Pallister intends to be the Designated Premises Supervisor.

#### **8.0 Licensing Hours**

8.1 Members are directed to paragraphs 6.8 to 6.15 for the Statement of Licensing Policy which states the criteria that will be applied to any decision for new applications or variations which include extending hours.

8.2 In brief the Policy states at 6.14 that restrictions may be made to the proposed hours of use where, after receiving relevant representations, the council considers it appropriate for the promotion of the licensing objectives to do so. The council will take into account the existing pattern of licensed premises in an area when considering what is appropriate to promote the objectives. Applications which are significantly out of character for a locality will need to demonstrate that granting the hours sought will not impact on the licensing objectives, given the potential for neighbouring premises to seek the same additional hours to prevent rivals gaining a commercial advantage.

8.3 A list of premises in the local area and their licensed hours and activities is provided at **Appendix C**

#### **9.0 Location**

9.1 A map which identifies the location of this premise is attached at **Appendix D**

#### **10.0 Representations**

10.1 Under the Act representations can be received from responsible authorities or other persons. Representations must be relevant and, in the case of another person, must not be frivolous or vexatious.

##### **10.2 Representations from Responsible Authorities**

10.2.1 A representation has been received from Leeds City Council Health & Safety in their capacity as a responsible authority.

- 10.3 Any representations submitted may be agreed prior to a hearing. In this instance the operating schedule has been amended to include measures agreed with Health & Safety. A copy of which may be found at **Appendix E**
- 11.0** There are no outstanding representations from Responsible Authorities.

- 11.2.1 The application has attracted representations from other persons.
- 11.3 The Licensing Section is in receipt of 32 individual letters of objection all of which are opposed to the application on the grounds of public nuisance.

- 12.0 Options Available to Members**
- 12.1 The licensing sub-committee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
- Grant the application as requested.
  - Grant the application whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
  - Exclude any licensable activities to which the application relates.
  - Refuse to specify the said person as the designated premises supervisor.
  - Reject the whole or part of the application.
- 12.2 Members of the licensing sub committee are asked to note that they may not modify the conditions or reject the whole or part of the application merely because it considers it desirable to do so. It must actually be appropriate in order to promote the licensing objectives.
