2. Please provide a brief description of what you are screening

The screening is required to inform a Delegated Decision Report (DDP) to the Interim Director of Adult Social Care for approval on December 11^h 2014. The report seeks to use CPRs 21.1 and 21.2 to extend the contract for BID utilising the second of two twelve month contract extension starting April 1st 2015 until 31st March 2016.

DALES (Deaf Across Leeds Enablement Service) is delivered by BID Services in partnership with Sign-Health who provide a range of services focussing on the health of deaf people. DALES aims to support adults aged 18+ who are affected by a hearing impairment. The service provides a range of services i.e. a specialist social work team; assistive technology for adults and young people under the age of eighteen; access to mental health and wellbeing support; as well as enabling service users to access recreation and leisure facilities.

This is the second of two 12 month extensions and there has been no identified adverse equality issues identified through contract monitoring and no immediate equality concerns.

The approval of the extension will enable commissioners to undertake an Equality Impact Assessment, a Market Sounding Exercise and/or additional procurement exercise with the intention to award a single contract to provide services for people with Hearing impairment commencing April 1st 2016.
