- User research demonstrates that the re-located OSC is in a location closer to the homes of the majority of users of the service
- Two members of staff will be re-located from Rawdon to Yeadon, however the distance between Micklefield House and Yeadon Library is less than one mile.
- The co-location of the library and one Stop Centre will be of benefit to users of both services by increasing ease of access to council services, including on-line access.
