	Men's Sector Community Services	£198,136.00	The service provides 45 units of accommodation for vulnerable men in housing need. Accommodation is provided in self-contained units with visiting support. The service provides a route into independent living.
	Oakdale House and Women's Sector	£342.267.00	The service supports a total of 65 vulnerable women in housing need through hostel and dispersed community based accommodation.
Leeds Housing Concern	Seacole	£175,213	The service is for homeless young people in immediate housing need and provides them with emergency accommodation, and helps them to obtain suitable longer term accommodation. It provides nine units of emergency accommodation to young people who are homeless and is accessible 24 hours a day. The staff identify appropriate move-on accommodation options for young people within the emergency accommodation units and aim to achieve a planned move on within seven days. The service provides three units of self-contained accommodation as longer term supported accommodation for up to six months duration.
	DIP/IOM Housing service	£93,099.84	The service provides housing related support to 55 people who are subject to the Drug Intervention Programme (DIP) to enable them to achieve independent living, comply with any drug treatment orders and achieve long term recovery. The service provides support to people who have been identified as eligible for DIP following arrest or release from custody. The IOM Anchor service offers short-term support to 30 offenders who are currently detained in regional prisons, including Leeds Prison, due for release who are identified as at risk of re-offending on release due to homelessness or unsuitable move-on accommodation. The service supports these people leading up to release and oversee a planned move into suitable accommodation.

	Carr Beck hostel	£77,632.37	The purpose of the service is to provide accommodation based longer term open-ended packages of housing related support to 6 women with alcohol problems, in a safe, secure environment that will enable women to develop and sustain independent living and which accommodates challenging lifestyles. The service works with women aged 16 years and over. The service provides specialist provision to break the 'revolving door' syndrome of street drinking, rough sleeping, petty offending, temporary private and hostel accommodation, general and psychiatric hospital treatment, detox and prison which is often the experience of long term drinkers.
Leeds Housing Concern	Carr Beck Group Homes	£30,566.14	The purpose of the service is to provide floating support to 6 women living in the community with alcohol problems, to enable them to develop and sustain independent living.
	Sinclair	£111,639.40	This service supports people with drug and/or alcohol problems to live independently through the provision of floating and accommodation based housing related support. The Sinclair service provides accommodation based housing related support for up to 28 people with drug addiction problems. This consists of a self- contained one bedroom furnished tenancy with visiting support for up to two years, during which time the service user is expected to engage with drug treatment. The majority of people secure independent accommodation and are able to successfully move on from the service after 18 to 24 months.

GIPSIL	Care Leavers service	£281,165.55 (includes £80k from Children's Services)	The service provides housing related support to young people to enable them to make the successful transition from a care setting to independent living. The service brings housing expertise into the Pathway Planning service and enables early planning of care leavers housing and housing support and provides opportunities to explore the full range of housing options open to a young person. The service works closely with a young person's Personal Adviser to plan and ensure a clear and effective housing pathway into independent living through a coordinated support planning process.
	Leeds Emergency Accommodation Provision -LEAP	£72,644.82	Leeds Federated provides accommodation based support for homeless adults and Families in self –contained dispersed and furnished accommodation through the LEAP service in 6 month Assured Shorthold Tenancies, with a focus on achieving a move into longer term independent housing. The service was varied in July to reduce the number of units commissioned from 65 to 50 saving a total of £4k on the annual contract value.
Leeds Federated Housing Association	PhysAbility	£78,750	The aim of this service is to offer flexible housing support to 30 people who are aged over 16 and who have a physical impairment. The aim is to help people retain, or gain independence while remaining as safe as possible and avoid unnecessary admission to hospital or residential care. The service also assists in improving safety and security and works together with clients to reduce fear of crime. Support can be provided to people in all tenure types.
	Choices	£39,655.16	The aim of the Choices service is to enable 59 older people to live independently in their own homes for as long as they wish, in a secure and safe environment. LFHA offer a range of person centred support tailored to meet individual needs. The service is flexible and offers a range of support levels to meet the needs of the customer as they change over time. Support needs are regularly reviewed and can be increased or decreased, dependent on the needs of the customer. This service is available to people living in a variety of tenures including private, council, RSL and owner occupiers.

Age UK	Mental Health Hospital Aftercare service	£51,591.23	The service provides support to 28 people with mental health needs aged 60 and over living in Leeds. The aim of the service is to provide support to people who are in hospital or have recently been discharged from hospital or are at risk of admission because of their mental health needs. This is a short term intervention service providing support to up to 3 months and works with Care & Repair where clients require minor adaptations in order to return home.
Making Space	Waterhouse Court	£37, 542.86	This service comprises of 12 self-contained flats on one site providing permanent accommodation to older people with support needs. Making Space are the managing agents of the service and the building is owned by Anchor housing association. The service users are assured tenants of Anchor. The aim of the service is to provide housing related support to tenants in order to maintain independent living, and to reduce the incidences of admissions to care homes, hospital or psychiatric units.
Creative Support	Independent Living Service for Older People	£290,784	This service provides floating support to 110 adults aged 60 years and over who are experiencing moderate to severe mental health problems. Support is provided to clients living in a range of tenure types. The service works with clients to address the day to day difficulties they experience due to their mental health issues and other factors associated with ageing. Support Workers assist clients with getting out and about to reduce social isolation, coping with any concerns, accessing other specialist support services, dealing with money management and benefits, and managing at home.
KeyRing	Living Support Networks	£57,200 from 01/04/2015.	The KeyRing support model is based on people living in their own homes but sharing their skills with each other and with their communities. Clients who receive the service are known as 'members'. Network members live in properties which are located within a small neighbourhood area, within walking distance of each other. They are supported for up to one hour per week by a community volunteer trained and supervised by KeyRing. Most clients have a mild learning disability and/or mental health problems.
