### 2. Please provide a brief description of what you are screening

Approval is being sought to approve Contracts Procedure Rule 22.1 in order to terminate existing contracts and enable the establishment of new interim contracts with coterminous end dates. Approval is also being sought to waive Contracts' Procedure Rule 9.1 and 9.2 in order to establish interim contracts with coterminous end dates of 31<sup>st</sup> March 2017 for a number of current Housing Related Support providers. This will ensure continuity of provision during the course of the service review and outcome implementation. The maximum value of the contracts will not exceed £4,851,406.60 per annum.

Approval of these interim contracts will ensure continuity of existing services, and therefore there will be no changes to the support provided to people who are in receipt of the service. A detailed Impact Assessment will be undertaken as part of

the review to help identify where there are gaps in services and issues for particular equality groups, and be used to inform the design and future re-commissioning of these services.
