# 1 Purpose of this report

1.1 This report presents the recommendations of General Purposes Committee to establish a Town Council for Guiseley.

#### 2 Background information

- 2.1 Following receipt of a valid petition, General Purposes Committee, at its meeting on 23rd October 2014, agreed to undertake a Community Governance Review to invite representations on the proposal to establish a Town Council for Guiseley.
- 2.2 On the 12th February 2015, General Purposes Committee received recommendations from the Electoral Working Group (EWG) following that group's consideration of the representations that had been received.

#### 3 Main issues

- 3.1 The report considered by General Purposes Committee is attached at Annex 1 to this report.
- 3.2 An amendment to the recommendations made to General Purposes Committee by the Electoral Working Group was moved by the Chair. The amendment is detailed in the map at Annex 2 to this report and comprised of an alternative boundary for the Town Council which omitted polling districts GRA and GRB, from which in relation to the review, a significant number of representations against the proposal to create a Guiseley Town Council had been received.

- 3.3 Having considered the proposed amendment the Committee agreed to recommend that full Council consider and agree that a Guiseley Town Council Council be created at the earliest opportunity based on polling districts GRD, GRI, GRC, GRK and GRJ.
- 3.4 The proposed electoral arrangements for suggested wards, ward names and number of Councillors will also need to be amended as follows: -
