**Repair of listed structures at Tower Works Holbeck, namely the Giotto Tower, Verona Tower and Little Tower.** In March 2103 Executive Board agreed that the Council accepted the freehold transfer of ownership from the Homes and Communities Agency (HCA) of buildings known as the Engine House, Giotto Tower, Verona Tower and Little Chimney at Tower Works, Globe Road, Holbeck.

The transfer was accompanied by a “dowry” payment from the HCA for repair and maintenance of the Engine House and the three towers. Of this the sum of £180,000 is earmarked for the repair of the three towers. The overall intention is to make the Tower Works site more attractive to commercial developers by removing any liability and responsibility for the upkeep of the listed historic structures which form part of the site
