It is a very long footpath that forms part of a long distance recreational route. Part of the footpath have fallen into the river and other sections are close to being lost making the paths unsafe for public use. The proposed diversion will provide a safe route for all path users. There were no objections to the diversion of the footpath as it will provided a useable route on a legal line. There is little overall change to the length of the footpaths.
• Actions The diversion will enable to the footpaths to be used by all walkers and maintained for the future. Currently parts of the path are un-useable as they are in the river and other parts are unsafe to use. If no action is taken it may become impossible to use more of the footpath and the landowners who currently allow deviations to the legal line could start challenging use prevent access to a long section of footpath which is part of a promoted recreational route.
