## 2. Please provide a brief description of what you are screening

For some time, the Council's arrangements for handling out of hours contact have been dispersed over a number of areas and locations. Whilst a previous project was undertaken to bring together a number of out of hour's services, the project was not as successful as anticipated in improving the joining up of service delivery. The current arrangements therefore are inefficient, not joined up and lack the support from the infrastructure that is currently available to those working in the Council's Corporate Contact Centre at West Gate.

The project seeks to undertake the physical relocation of 4 FTE officers from the Environments and Housing Directorate, Middleton CCTV Control Facility, to the West Gate Customer Contact centre in Leeds City Centre in order to integrate the Out of Hours service, within the wider Corporate Customer Contact Centre.
