

## Scrutiny Board (Environment and Housing ~~and Regeneration~~)

The Scrutiny Board (Environment and Housing ~~and Regeneration~~) is authorised to discharge the following overview and scrutiny functions<sup>1</sup>:

1. to review or scrutinise decisions made or other action taken in connection with any council or executive function or any matter which affects the authority's area or the inhabitants of that area;<sup>2</sup>
2. to receive and consider requests for Scrutiny from any source;
3. to review or scrutinise the performance of such Trust / Partnership Boards as fall within its remit
- ~~2. to carry out such other reviews or policy development tasks as it may be requested to do by either the Executive Board or the Council;~~
- ~~3.4. \_\_\_\_\_ to act as the appropriate Scrutiny Board in relation to the Executive's initial proposals for a relevant plan or strategy<sup>3</sup> within the Budget and Policy Framework which falls within its remit;<sup>4</sup>~~
- ~~4.5. \_\_\_\_\_ to review or scrutinise executive decisions that have been Called In;~~
- ~~5. to review outcomes, targets and priorities within the Council Business Plan and the Best city to live priorities within the City Priority Plan;~~
- ~~6. to receive requests for scrutiny and councillor calls for action and undertake any subsequent work; and~~
6. to exercise the functions of a crime and disorder committee<sup>5</sup>, including the following:
  - a. to review or scrutinise the exercise of crime and disorder functions<sup>6</sup> by responsible authorities;<sup>7</sup>
  - b. to review or scrutinise any local crime or disorder matter raised by a Member;<sup>8</sup> and
