There is a proposal to seek funding to design, build and operate a compressed natural gas (CNG) filling station. The development and financial model for this proposal is based on a unique and innovative model that will allow for the installation of a CNG filling station that will facilitate the transition to a cleaner fuel for the council's fleet of Refuse Collection vehicles. This will have a positive impact upon the Council reducing its contribution to harmful emissions and will support the Low Emission Strategy and Air Quality Action Plan.

The delivery of a CNG filling station will also provide for operational fuel savings for the council and will have a potentially positive economic as well as environmental impact, creating jobs and opportunity for transfer to CNG fuel for private sector businesses.
