#### Summary of main issues

- 1 The Best Council Plan 2013-17 outlines how Leeds City will achieve its ambition to become the Best City in the UK and Leeds City Council the best local authority. According to the Best Council Plan, the success of the Best Council objective: ensuring high quality public services will be partly measured through reduced numbers of people Killed or Seriously Injured on the city's roads. By improving the local road environment this will actively encourage children in to more active modes of travel on journeys to school, contributing to the Leeds Education Challenge, which is part of the objective to build a child friendly city, delivery of the Better Lives programme and contribution to "Public Health which is embedded and effectively delivering health protection and health improvement
- 2 Leeds City Council, being mindful of the above, is responsible for designing and implementing highway works associated with the school expansion/ development programme for North East Leeds Specialist Inclusive Learning Centre (SILC) in accordance with a number of planning conditions
- 3 The purpose of this report is to request authority to advertise a draft Traffic Regulation Order to introduce 'No Waiting At Any Time' restrictions in the vicinity of the North East Leeds SILC along Crowther Place, Melville Place, Moseley Place, Craven Road and Lucas Court.

### Recommendations

- 4 The Chief Officer (Highways and Transportation) is requested to:
  - Approve the design and implementation of 'No Waiting At Any Time' restriction on Crowther Place. Melville Place, Moseley Place, Craven Road and Lucas Court, Woodhouse, at an estimated cost of £4,500, all to be funded from the Children's Services Capital Programme. Details are shown on drawing TM-19-2318-12-CONSULT-01.
  - ii) Request the City Solicitor to:
    - a) Advertise a draft Traffic Regulation Order to introduce 'No Waiting At Any Time' restrictions along Crowther Place, Melville Place, Moseley Place, Craven Road and Lucas Court, Woodhouse and if no valid objections are received, to request that the City Solicitor make, seal and implement the order as advertised. Details are shown on drawing TM-19-2318-12-CONSULT-01.

### 1 Purpose of this report

1.1 To seek approval to advertise a draft Traffic Regulation Order to introduce 'No Waiting At Any Time' restrictions on Crowther Place, Melville Place, Moseley Place, Craven Road and Lucas Court as shown on drawing TM-19-2318-12-CONSULT-01 and if no valid objections are received, to request that the City Solicitor make, seal and implement the order as advertised.

#### 2 Background information

- 2.1 The planning application seeks permission for the extension of the existing North East SILC on the site of the former Blenheim Centre to accommodate an additional 150 pupils.
- 2.2 The site lies within a predominantly residential area and all pupils are expected to be transported to the site by vehicle, with all the drop offs and pickups taking place on the site of the SILC.
- 2.3 The extension to the existing SILC is proposed to accommodate the demand for additional pupils. Although the site is adequately served by public bus services and is accessible on foot, these would be used mainly by staff at the school. Pupils attending the centre will be transported into the site by a vehicle.
- 2.4 The proposed highway improvements 'No Waiting At Any Time' restriction will be implemented to protect the access points to the site off Craven Road, Crowther Place junction with Moseley place and as well as the junction of Crowther Place/ Melville Place. Lucas Court will also have 'No Waiting At Any Time' restrictions on one side (east side) of the carriageway.

2.5 A proposed off street parking level to provide 100 spaces is proposed, for use by members of SILC staff and visitors. As such, it is considered that all staff and visitor parking should be contained off the public highway.

### 3 Main issues

- 3.1 The location of the North East (SILC) is predominately in a residential area and the expected parking demand to the SILC along Crowther Place, Melville Place, Moseley Place, Craven Road and Lucas Court has to be manage through the introduction of formal waiting restrictions as shown on drawing no: TM-19-2318-12-CONSULT-01.
- 3.2 To improve road safety in the area, it is proposed that on both sides of Crowther Road and its junctions of Melville Place and Moseley Place be introduce with 'No Waiting At Any Time' restrictions and the eastern side of Lucas Court and a small section of Craven Road, to be introduce with 'No Waiting At Any Time' restrictions to ensure the free flow of vehicles and to remove obstructive parking from the SILC frontage.

### 3.3 **Design Proposals and Full Scheme Description.**

- 3.3.1 To formalise parking within the area, it is also proposed to introduce 'No Waiting At Any Time' restrictions on Crowther Place, Melville Place, Moseley Place, Craven Road and Lucas Court. This will remove any on-street car parking associated with staff or visitor to the North East Leeds SILC.
- 3.4.2 The full extents of the 'No Waiting At Any Time' restrictions are as shown on drawings TM-19-2318-12-CONSULT-01.

#### 3.5 Programme

3.5.1 It is anticipated that the proposal will be implemented within the 2015/ 2016 financial year.

#### 4.0 Corporate Considerations

#### 4.1 Consultation and Engagement

- 4.1.1 Ward Members: Ward Members were consulted as part of the initial planning application, and were consulted by Highways by email dated 22 May 2015 and no replies have been received to date.
- 4.1.2 Emergency Services and WYCA were consulted by email dated 22 May 2015. A reply has been received from the Police, Fire and combined authority who are all in favour of the proposals.
- 4.1.3 The general public will be consulted via notices on street lighting columns during the public advertisement phase, along with an advert in the Evening Post newspaper.

# 4.2 Equality and Diversity / Cohesion and Integration

- 4.2.1 A full Equality, Diversity / Cohesion and Integration impact assessment has been carried out for the 'No waiting at any time' restrictions.
- 4.2.2 Positive Impact:
  - Improved sightlines at junctions where restrictions are introduced.
  - Improved awareness of existing crossing points for motorist.
  - Improved footpath access for all pedestrians, which will include carers supporting pushchairs, wheelchair users and disabled people particularly the blind and visually impaired.
- 4.2.3 Negative Impact:
  - The removal of the unrestricted carriageway section will move the indiscriminate parking to other location where there are no restrictions applied.

## 4.3 Council Policies and City Priorities

- 4.3.1 The Best City ambition is to improve life for the people of Leeds and make our city a better place. Measures to improve road safety make a specific contribution to the Best City for Communities and Child Friendly Leeds ambitions. Reducing the number of casualties involving loss of life or severe injury (Killed or Seriously Injured KSIs) is one of the measures for the delivery of the objectives for the Best Council Plan.
- 4.3.2 The proposals contained in this report are in accordance with Plan Objective: Delivering Accessibility. The proposals also follow core strategy approaches A1 and A2 in that the scheme will improve physical accessibility and improve the highway for pedestrians.

## 4.4 Resources and Value for Money

4.4.1 The estimated total cost to implement this scheme is £4,500, which comprises of £2,000 works costs, £1,500 staff fees, and legal fees £1,000, all to be funded from the Children's Services Capital Programme.

## 4.5 Legal Implications, Access to Information and Call In

4.5.1 The scheme is in the Annual Programme and subject to resolving any objections received it is anticipated to be completed within the 2015/2016 financial year.

## 4.6 Risk Management

4.6.1 Objections to the permanent Traffic Regulation Order may be raised during the formal consultation and could result in a delay in implementing the orders.

## 5 Conclusions

5.1 The proposed 'No Waiting At Any Time' restrictions will improve overall road safety along Crowther Place, Craven Road and Lucas Court. It will also keep the entrances to the North East Leeds SILC free of on-street parking and allow for taxis and other vehicles to drop–off and pick-up pupils attending the centre to park without being obstructed by any vehicles.

# 6 Recommendations

- 6.1 The Chief Officer (Highways and Transportation) is requested to:
  - i) Approve the design and implementation of 'No Waiting At Any Time' restriction on Crowther Place, Melville Place, Moseley Place, Craven Road and Lucas Court, Woodhouse, at an estimated cost of £4,500, all to be funded from the Children's Services Capital Programme. Details are shown on drawing TM-19-2318-12-CONSULT-01.
  - ii) Request the City Solicitor to:
    - a) Advertise a draft Traffic Regulation Order to introduce 'No Waiting At Any Time' restrictions along Crowther Place, Melville Place, Moseley Place, Craven Road and Lucas Court, Woodhouse and if no valid objections are received, to request that the City Solicitor make, seal and implement the order as advertised. Details are shown on drawing TM-19-2318-12-CONSULT-01.
