Summary of main issues

- 1 The City Council is responsible for designing and implementing highway works associated with the new development of Lane End Primary School on Beeston Road, built on the former site of South Leeds Sports Centre, in accordance with a number of planning conditions.
- 2 The purpose of this report is to request authority to construct a number of buildouts to form speed reduction measures and informal crossing points, introduce pedestrian guardrail and advertise a Traffic Regulation Order to introduce waiting and stopping restrictions in the vicinity of the School.
- 3 This report presents these highway proposals to the Chief Officer and seeks consent to proceed with implementation of the measures proposed and discharge the conditions for external highway works required by the planning consent.

Recommendations

- 3 The Chief Officer (Highways and Transportation) is requested to:
 - i) note and approve the contents of this report; and

- approve the introduction of a draft Traffic Regulation Order (TRO) to restrict stopping by implementing 'School Keep Clear' markings between the hours of 8am–6pm Monday to Friday as shown on drawing number EP-994610-01-01; and
- iii) Approve the introduction of a draft waiting restrictions TRO to introduce no waiting at any time and time limited waiting between the hours of 7.45am 9.15am and 2.45pm 3.45pm Monday to Friday inclusive as shown on drawing No. EP-994610-01-01; and
- iv) Approve the revocation of an item of the Beeston & Holbeck Ward TRO to remove restrictions on an existing school keep clear marking on Beeston Road outside Beeston Primary School as the school entrance has moved and the markings are no longer relevant.
- v) Instruct the City Solicitor to advertise the draft Traffic Regulation Order restrictions as shown on drawing No. EP-994610-01-01 and if no valid objections are received, to request that the City Solicitor make, seal and implement the Order as advertised; and
- vi) Approve the construction of a number of build-outs to form speed reduction measures and informal crossing points, and introduce pedestrian guardrail.

1 Purpose of this report

- 1.1 The purpose of this report is to seek approval to introduce 'School Keep Clear' markings between the hours of 8am 6pm Monday to Friday as shown on drawing No. EP-994610-01-01; and
- 1.2 To seek approval to introduce no waiting at any time restrictions as shown on drawing No. EP-994610-01-01; and
- 1.3 To seek approval to introduce limited waiting restrictions between the hours of 7.45am 9.15am and 2.45pm 3.45pm Monday to Friday inclusive, as shown on drawing No. EP-994610-01-01; and
- 1.4 To seek approval to revoke an item of the Beeston & Holbeck Ward TRO for the school keep clear marking on Beeston Road outside Beeston Primary School as the school entrance has moved and the markings are no longer relevant.
- 1.5 To seek approval to advertise the draft Traffic Regulation Order and if no valid objections are received, to request that the City Solicitor make, seal and implement the Order as advertised; and
- 1.6 To seek approval for the construction of a number of build-outs to form speed reduction measures and informal crossing points, and introduce pedestrian guardrail.

2 Background information

- 2.1 Full Planning Permission was granted on 5 June 2014 to build Lane End Primary School. The proposed school will have a maximum capacity of 420 pupils with a 26 place nursery by 2020 over 7 years. The first pupil intake is accommodated temporarily for one year at Cockburn High School. In the 2015/16 academic year, these pupils will then relocate to Lane End Primary School together with the new reception intake.
- 2.2 The proposed school is located on the former site of the recently demolished South Leeds Sports Centre, on Beeston Road by the borders of Beeston & Holbeck and City & Hunslet wards.
- 2.3 A Transport Assessment and Travel Plan have been developed for the new school by this Service in support of the planning application for the new school.
- 2.4 The proposed changes to the highway and waiting restrictions were included within the pre-planning consultations and received no objections. These proposals have subsequently formed part of the Planning Consent for the new school.

3 Main issues

3.1 Design Proposals and Full Scheme Description.

- 3.1.1 It is proposed to include a number of build-outs to form speed reduction measures and informal crossing points, and introduce pedestrian guardrail. The full design proposals are shown on Drawing No. EP-994610-01-01.
- 3.1.2 It is proposed to restrict stopping by implementing 'School Keep Clear' markings between the hours of 8am 6pm Monday to Friday on Beeston Road.
- 3.1.3 It is proposed to restrict waiting by implementing 'no waiting at any time' restrictions on Beeston Road, Hunslet Hall Road and Lane End Place.
- 3.1.4 It is proposed to introduce limited waiting restrictions between the hours of 7.45am 9.15am and 2.45pm 3.45pm Monday to Friday on Beeston Road and Lane End Place.
- 3.1.5 It is proposed to remove and revoke a School Keep Clear marking on Beeston Road outside Beeston Primary School.

4 Programme

4.1 Subject to approval being granted, it is planned to advertise the draft Traffic Regulation Order and implement the works in the 2015/16 financial year.

- 4.2 Ward Members: Ward Members were consulted as part of the initial planning application, and were consulted by Highways by email dated 1st July 2015. No responses have been received as yet.
- 4.3 Emergency Services and WYCA were consulted by email dated 1st July 2015. No responses have been received as yet.

5 Corporate Considerations

5.1 Consultation and Engagement

- 5.1.1 Ward Members: Ward Members were consulted as part of the initial planning application, and were consulted by Highways by email dated 1st July 2015. No responses have been received as yet.
- 5.1.2 Emergency Services and WYCA were consulted by email dated 1st July 2015. No responses have been received as yet.
- 5.1.3 The school has been contacted with regards to the proposals and contributed towards the times applied to the school keep clear markings and restricted waiting times.

5.2 Equality and Diversity / Cohesion and Integration

An Equality, Diversity/Cohesion and Integration Screening Assessment have been undertaken for the proposed external highway works and is attached as Appendix 1

- 5.2.1 Positive Impact: The proposed external highway works would:
 - Improve a safer environment on the roads around the school to all pedestrians, especially those with mobility issues, disabled people, parents supporting pushchairs and young and old people
 - Traffic speeds will be further reduced through a build out for a safer crossing point and parking restrictions will reduce congestion. This recognises that a significant number of parents and children will walk or cycle to school from the local catchment areas.
 - Greater independence and choice for children travelling to school.
 - Make it more pleasant to walk or cycle, therefore encouraging walking and cycling and a healthier lifestyle.
 - Improve quality of life for the local community.
- 5.2.2 Negative Impact: The proposed external highway works may:

- Impact local businesses and their trade; and
- Impact local residents parking and their visitor's parking.

5.3 Council policies and City Priorities

- 5.3.1 Local Transport Plan: The proposals support the plan through maintaining road safety for pedestrians and motorists and reducing congestion caused by inappropriate parking.
- 5.3.2 Environmental Policy: The improved facilities for pedestrians and improved traffic safety should encourage walking and cycling to the new school.

5.4 Resources and value for money

- 5.4.1 Full Scheme Estimate: The total cost of the scheme is estimated to be £41,000 to be funded by Children Services. This includes £35,000 of works costs, £4,000 of staff fees and £2,000 legal costs.
- 5.4.2 Capital Funding and Cash Flow: The scheme is being funded by Children's Services and there will be no funding requirements from the Highways and Transportation budgets.
- 5.4.3 Staffing: The design and supervision of the works can be carried out within existing staff resources.

5.5 Legal Implications, Access to Information and Call In

5.5.1 The recommendations in this report are not subject to call in.

5.6 Risk Management

5.6.1 Objections to the Permanent Traffic Regulation Orders may be raised during the formal consultation and could result in a delay in implementing the orders. This would result in further consultations and possible modifications to the Traffic Regulation Order.

6 Conclusions

- 6.1 The proposed highway improvements in this report are planned for the roads and footways near to the proposed Lane End Primary School and are conditioned in the planning permission for the development.
- 6.2 These proposals include parking restrictions, build outs to form speed reduction measures and informal crossing points, pedestrian guardrail. These will benefit the area, improving safety, mitigating the potential impact of the school and encouraging walking and cycling to and from school.

- i) note and approve the contents of this report;
- ii) approve the introduction of a draft Traffic Regulation Order (TRO) to restrict stopping by implementing 'School Keep Clear' markings between the hours of 8am – 6pm Monday to Friday as shown on drawing number EP-994610-01-01; and
- iii) approve the introduction of a draft waiting restriction TRO to introduce no waiting at any time and time limited waiting between the hours of 7.45am 9.15am and 2.45pm 3.45pm Monday to Friday inclusive as shown on drawing No. EP-994610-01-01;
- iv) Approve the revocation of an item of the Beeston & Holbeck Ward TRO to remove restrictions on an existing school keep clear marking on Beeston Road outside Beeston Primary School as the school entrance has moved and the markings are no longer relevant;
- v) Instruct the City Solicitor to advertise the draft Traffic Regulation Order restrictions as shown on drawing No. EP-994610-01-01 and if no valid objections are received, to request that the City Solicitor make, seal and implement the Order as advertised; and
