The proposed contract contains provision for free treatment of rats in people's homes. Although this is offered to all households there is a disproportionate prevalence of rat infestation in low income households. Therefore offering a free service helps deliver better health outcomes to these groups. In addition, if the service was not offered on a free basis it is likely that low income households will be less inclined to seek out private paid for treatment due to the cost. This would cause health risks for both their households and those of their neighbours. As with many health issues the very young, the elderly and people with other health conditions are the most vulnerable.

Therefore offering a free service helps deliver better health outcomes to low income communities. No negative implications have been identified.

As free treatment is offered to all households it is unlikely that there will be any resentment of this approach. The service has been offered on this basis for many years and no negative impact has been identified.
