## 2. Please provide a brief description of what you are screening

Contracts are currently in place with Foundation and Home Group who are commissioned by the Council to provide housing related support to offenders and those with an offending background. These contracts apply to four separate services and are due to expire on 30<sup>th</sup> September 2015. A six month contract extension is available to apply to ensure continuity of services and allow current on-going review work to be concluded.

Consultation has been carried out with both service providers about the decision to extend the contracts and Foundation have offered some efficiency savings. Further discussion will take place from the date of the extension with Foundation about remodelling the services to offer greater flexibility of support to clients to make the service more accessible and improve outcomes and support provision to vulnerable

groups and/or those from recognised equality characteristic groups. .

Contract extensions will take effect from 1<sup>st</sup> October 2015. Existing provision will not be reduced.

On-going review work will continue during the six month contract extension period to identify and improve pathways into housing support for offenders and to promote equality and diversity outcomes.
