1.0 INTRODUCTION & CONFIRMATION OF THE PREVIOUS PANEL RESOLUTION

- 1.1 This update report is presented to North & East Plans Panel in accordance with the Panel resolution from the previous meeting held on 1st October 2015.
- 1.2 As with previous meetings, Members considered information relating to progress onsite in terms of reaching practical completion of the external shell and also received further legal advice about possible options going forward. Having considered these matters, the Panel resolved the following:
 - a) To note the report and the information provided as part of the verbal update


- b) That in light of the previous resolution and the further works undertaken in implementing planning permission 14/00575/FU that Officers continue to monitor building works on the site and that:
 - a list of works to bring about the practical completion of the external shell of the dwelling be agreed with the developer
 - that such works be completed within three weeks from the 1st October 2015
 - that Panel Members and Ward Members be updated on progress every two days
 - that a further report be presented to Panel at its meeting on 29th October 2015
- 1.3 A full copy of the minutes and Panel resolution in respect of this item are included earlier within the main papers.

2.0 UPDATE SINCE THE OCTOBER MEETING

- 2.1 Since the previous meeting, officers have provided the applicant with a list of what are considered to be the main outstanding works which need to be completed in order to achieve practical completion. The list has been put into a simple table and then used as the main measure against which progress at the site can be monitored.
- 2.2 In terms of keeping both Panel and Ward Members informed, the table has been updated by officers on average twice a week. These updates will continue between now and the Panel meeting itself.
- 2.3 In the light of these continuing updates and the intention for Members to carry out another site visit on the morning of the Panel meeting, this report does not set out the current position as it is continuously evolving. A further update will nevertheless be provided by officers during the meeting.
