## 2. Please provide a brief description of what you are screening

This screening relates to the request to enter into the second of two 12 month extensions available for the current contract between Leeds City Council and a consortium made up of Leeds Women's Aid, Behind Closed Doors and HALT for the provision of services to support people who have experienced domestic violence or abuse. A request has also been made to waive CPRs 9.1 and 9.2 to allow an additional 4 months extension.

A 10% increase in funding has been requested in order to address the ongoing high demand for the service and the significant impact this is having on the service's capacity.

This contract extension is being requested in order to ensure continuity of service whilst a review and subsequent procurement of domestic violence and abuse

services is undertaken. A full EDCI Impact Assessment will be undertaken as part of the review. The 16 month extension will involve no change for clients, staff, the provider or the Council.

Due regard has been given to equality through all stages of this contract, from the sector review through to the procurement of the service. Ongoing contract management arrangements ensure that this continues to be monitored.
